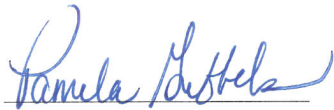

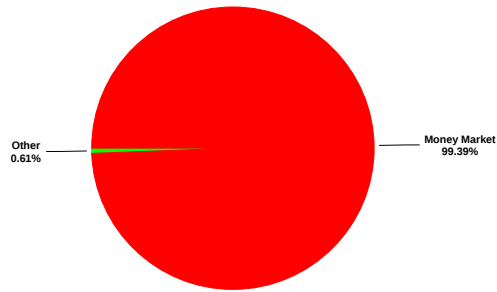

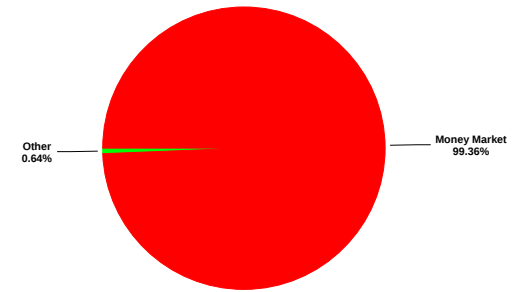

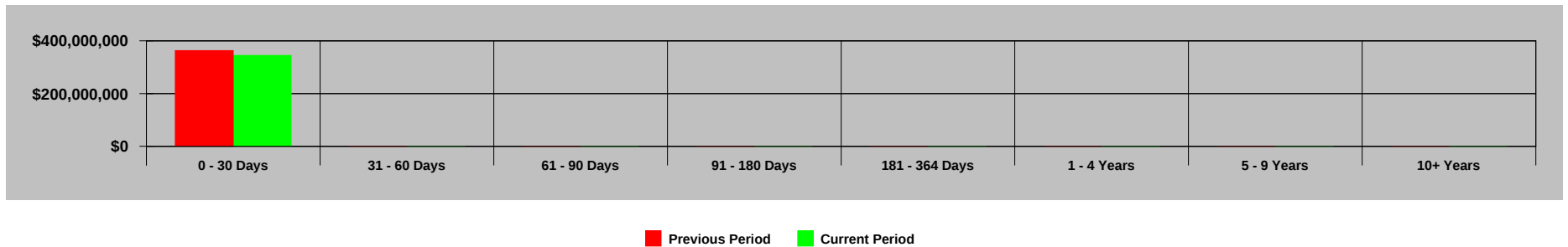
Portfolio Composition - 02/28/10



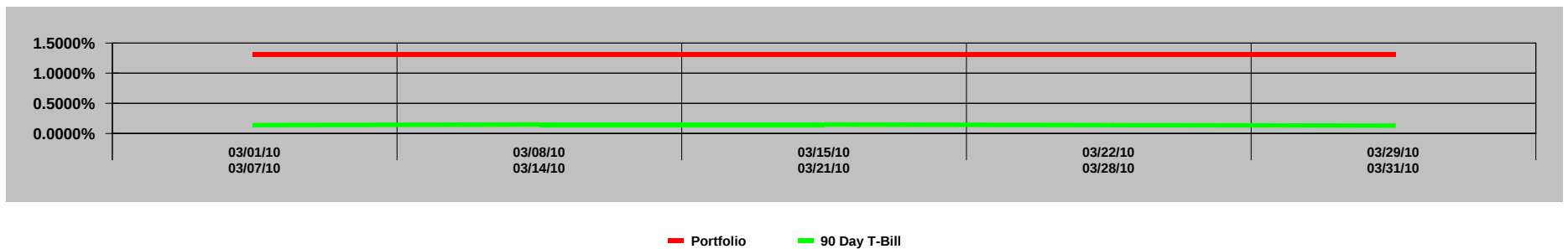
Portfolio Composition - 03/31/10

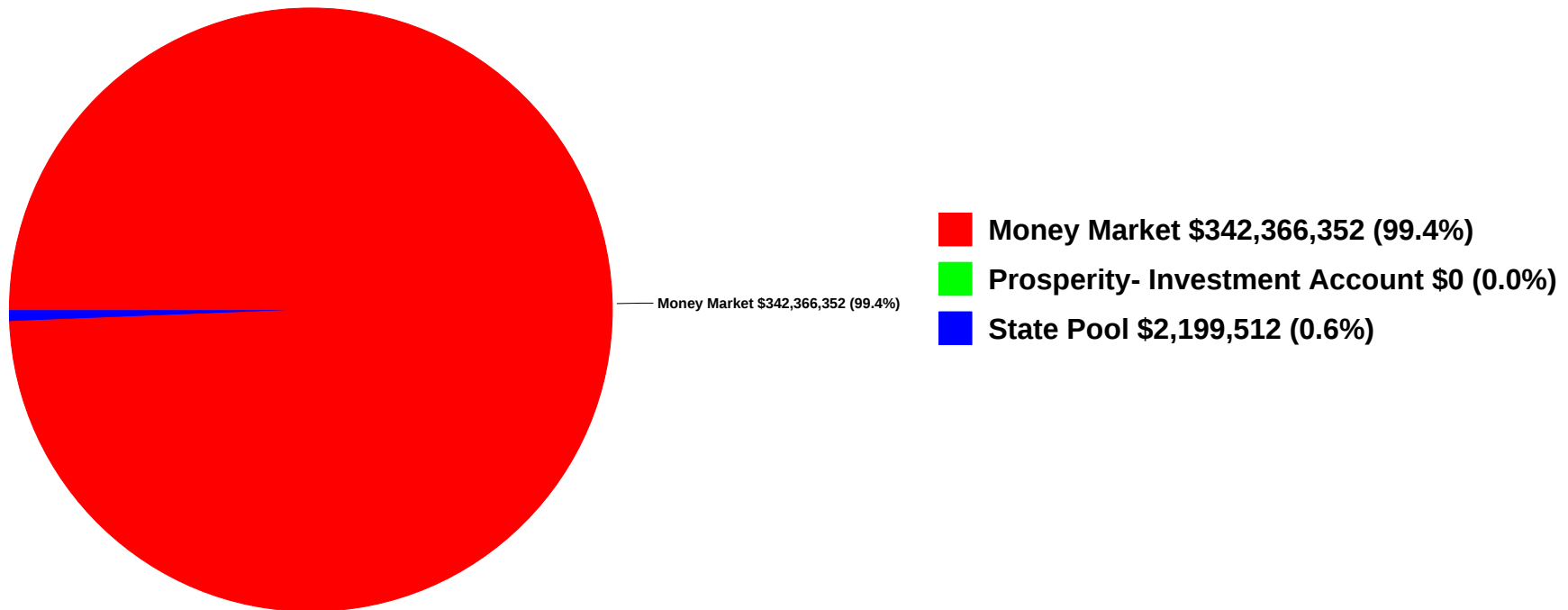

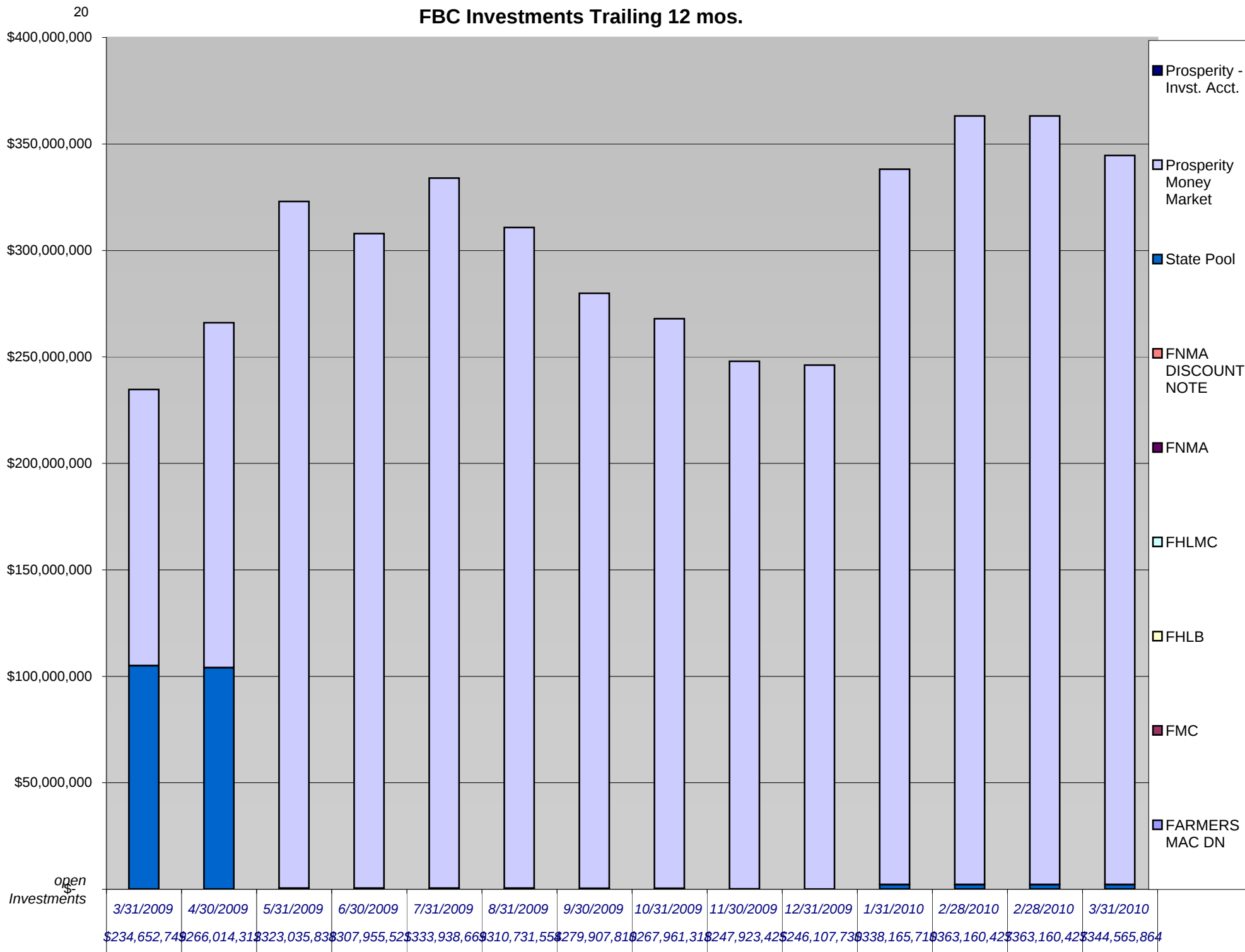

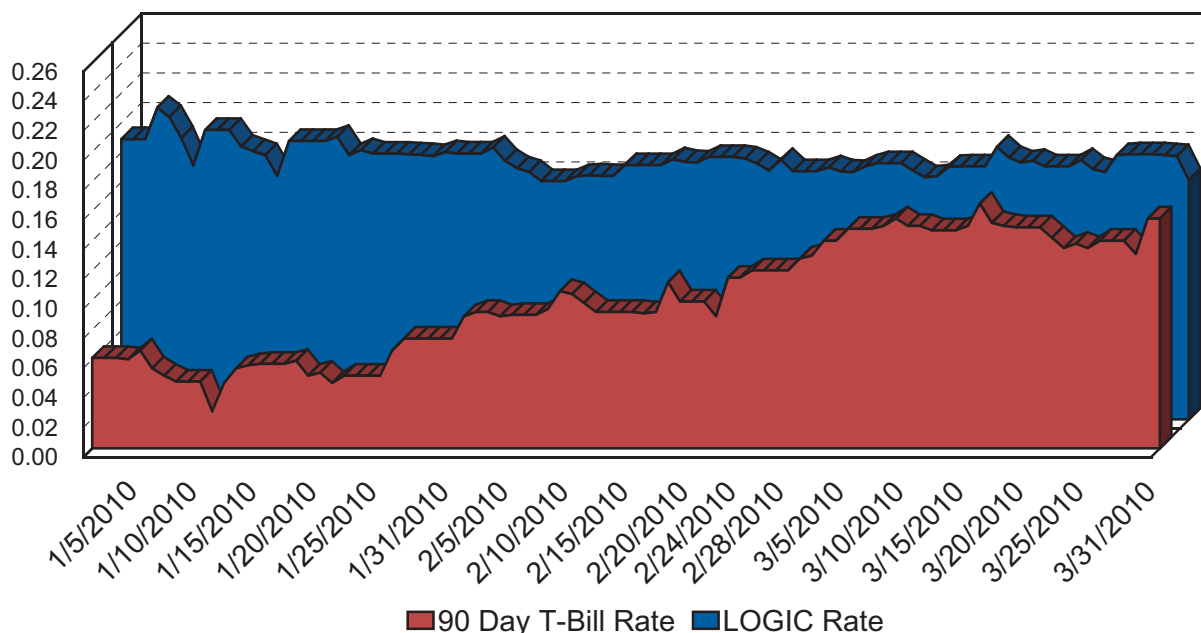
