Dear Dr. Condrey:

Enclosed is Supplemental Agreement No. 5 for LJA Engineering and Surveying, Inc. (LJA) to do additional field surveying. During ABHR's negotiations with adjacent property owners, it was difficult to determine the exact location of the proposed right of way line, property lines, and pavement edges. Therefore, it is proposed to stake the proposed right of way line, property lines, and pavement edges for Parcels 33-1 & 33-2 (Senior); 34 (Hayes); 35 (Logan); and 41 & 43 (Senior).

LJA has requested \$3,400.00 to complete this work as shown in the attached supplemental agreement. This increases the total contract amount to \$1,276,650.23.

SUPPLEMENTAL AGREEMENT NO. 5 TO AGREEMENT OF FEBRUARY 20, 2008 FOR

ENGINEERING SERVICES for Fort Bend Parkway Toll Road Segment B (Phase 1)

The agreement is hereby modified as follows:

The Scope of Services are amended to include the additional service as described in Attachment A-1, which are made part of this Supplemental Agreement.

The first sentence of Paragraph 2.a is replaced with the following:

"Compensation for performance of the Services defined in Attachment A-1 will be as follows: The Additional Services compensation shall be increased by \$3,400.00, for the additional work shown in Attachment A-1, for Right of Way and Pavement Staking (Parcels 33-1, 33-2, 34, 35, 41, and 43). The maximum amount payable under this agreement shall not exceed \$1,276,650.23 for all work except by separate agreement in accordance with the provisions of this agreement."

ATTACHMENT A-1 SUPPLEMENTAL AGREEMENT NO. 5 Fort Bend Parkway Toll Road, Segment B, Phase 1

RIGHT OF WAY AND PAVEMENT STAKING (Parcels 33-1, 33-2, 34, 35, 41 and 43)

GENERAL DESCRIPTION

The work under this supplemental agreement includes field surveying to stake the proposed right of way line and pavement edge along Parcels 33-1, 33-2, 34, 35, 41 & 43.

FIELD SURVEYS

- 1) Recover or re-set the previously set corners along the south line of the proposed ROW line for taking parcels 33-1, 33-2, 34, 35, 41 & 43.
- 2) Recover the north corners of the Parent tract of Parcels 33-1, 33-2, 34, 35, 41 & 43. These are also the north corners of the taking parcels.
- 3) Stake a line of laths along the proposed ROW marked "S. Line Prop. ROW" often enough to see between (Approx. 75')
- 4) Stake a line of laths along the Property Lines within the proposed ROW.
- 5) Stake a line of laths along the proposed Paving marked "S. Line Prop. Paving" often enough to see between (Approx. 75')
