Mr. Coronado is requesting waiver of penalty and interest on the above referenced account for the 2009 tax year because he states that he did not receive his tax statement.

Tax Office records indicate:

- Original Deed Volume 836 Page 584 for 4.756 acres and Deed Volume 836 Page 580 for 1 acre were recorded on May 14, 1979 with the owners listed as Luis Rey Coronado and wife, Clara S. Coronado, with no mailing address shown. These two pieces of property were combined into one account in 1983 by the Fort Bend Central Appraisal District under the current account number.
- Due to a Tax Office error 2009 tax statement was sent to Vanderbilt Mortgage Company.
- March 2010—2009 Reminder Tax Statement was mailed to taxpayer: Coronado Luis Rey, 4406 Meadowbend Dr, Richmond, TX 77469-8461 (Statement was not returned by Post Office.)
- March 22, 2010—Tax Clerk received letter from taxpayer stating mortgage is paid and that all statements should be sent to him.
- Needville ISD and Wharton County Junior College have authorized Fort Bend County Tax Office to handle the processing of the waiver of penalty and interest, and allow the Fort Bend County Commissioners Court to make the determination based on 33.011 of the State Property Tax Code.
