Here is Katie's response from the CUC. I remember Katie discussing this with me before we had Amendment No. 3 approved by the CUC Oversight Board.

Amendment #3 is actually the revision for FY10 only. If you execute Tyler's agreements and go live in FY10, we will need Amendment 3 executed so we have the authority to bill you for the Tyler invoices we received. Amendment #3 also includes the Hot Checks maintenance that was omitted from your original FY10 amendment, which Tyler has already billed us for (there is a payment advisory request for you in with my bookkeeper as we speak).
