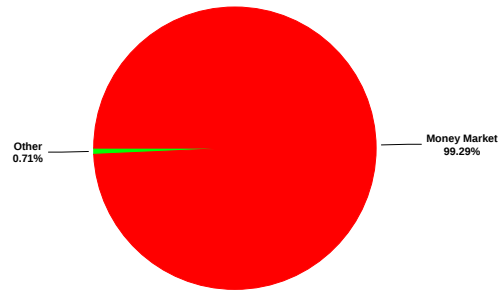

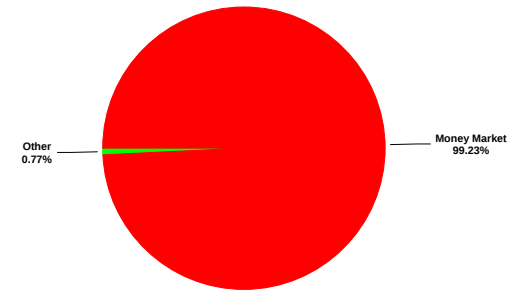

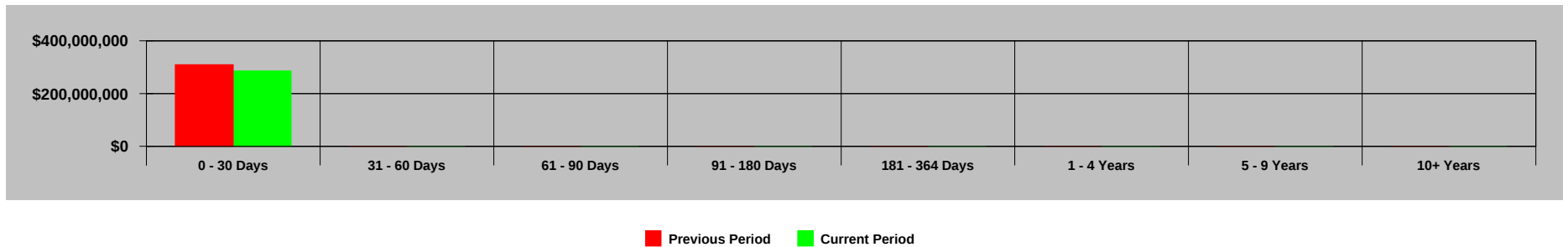
Portfolio Composition - 05/31/10



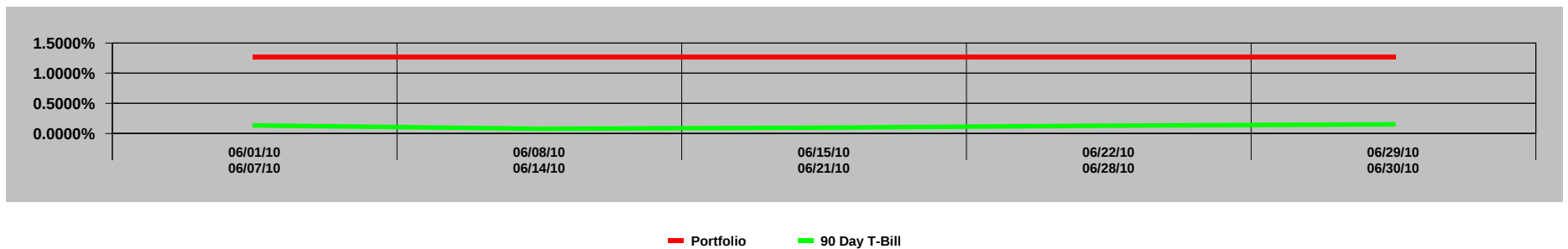
Portfolio Composition - 06/30/10

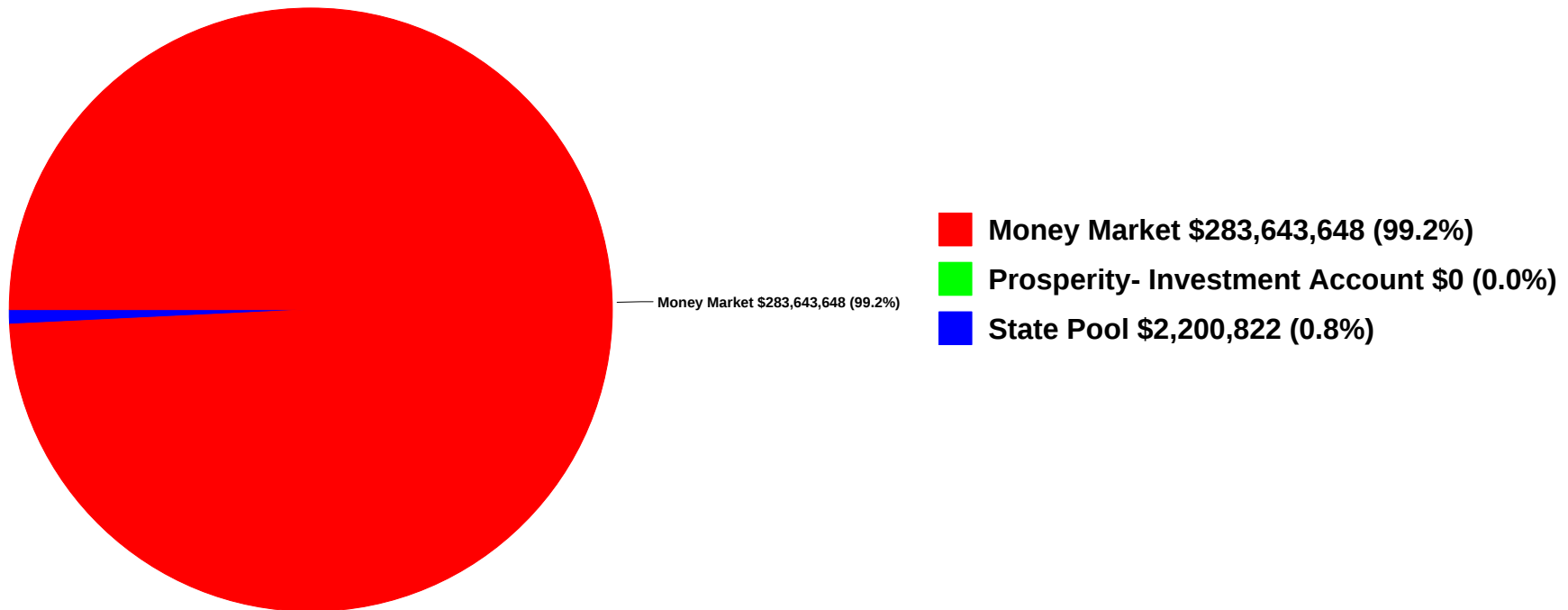

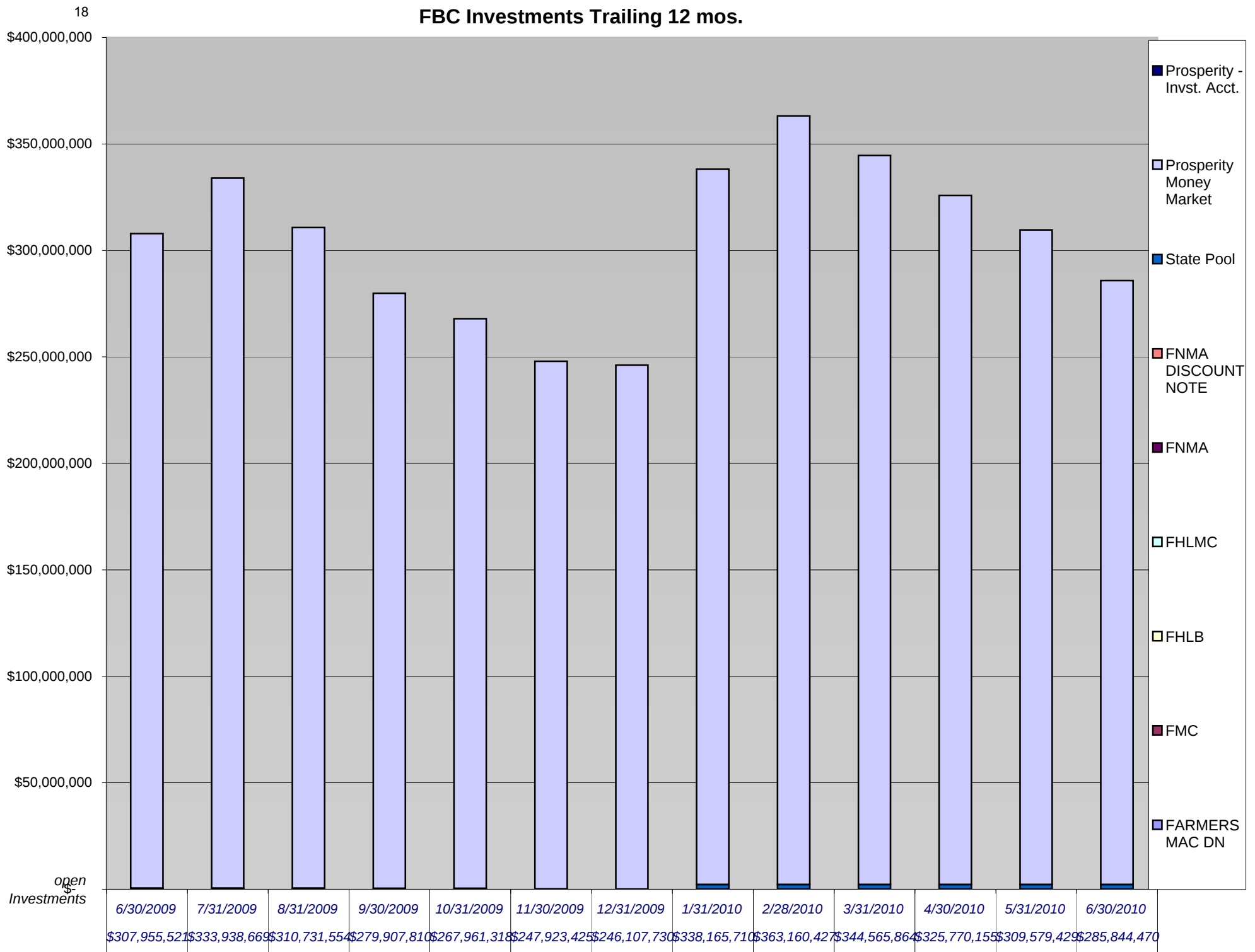

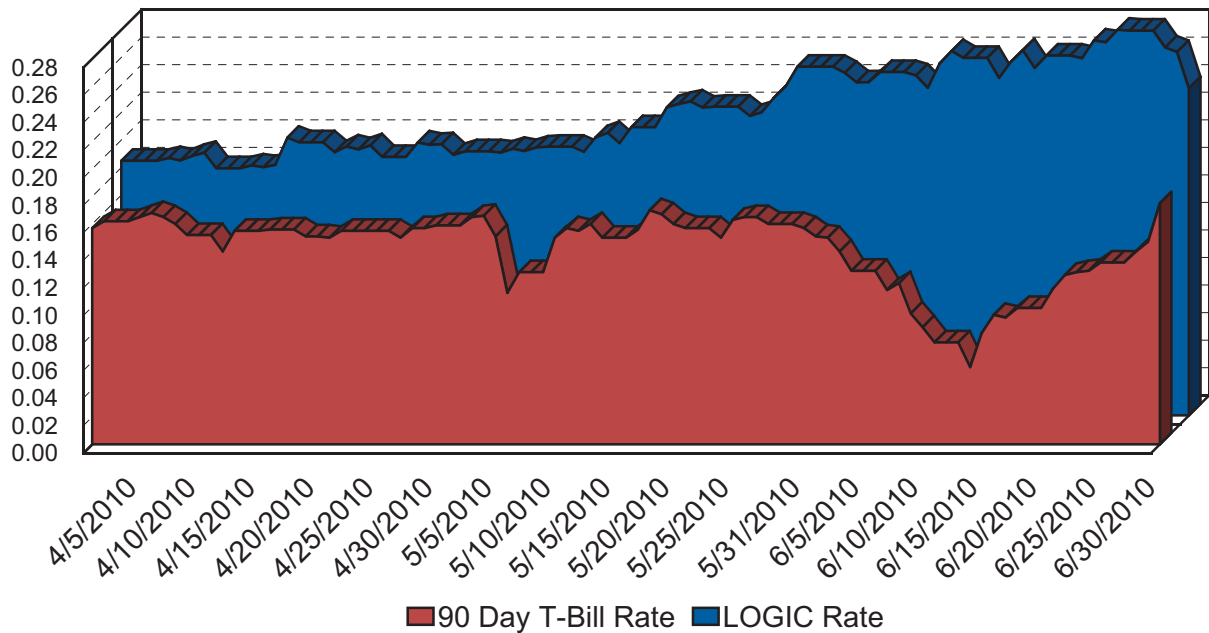
