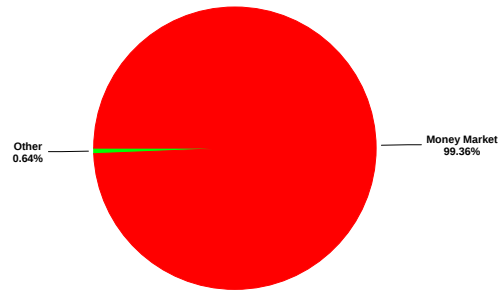

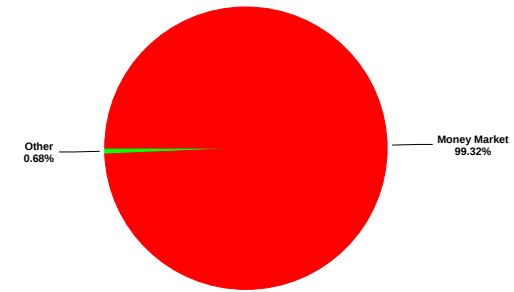

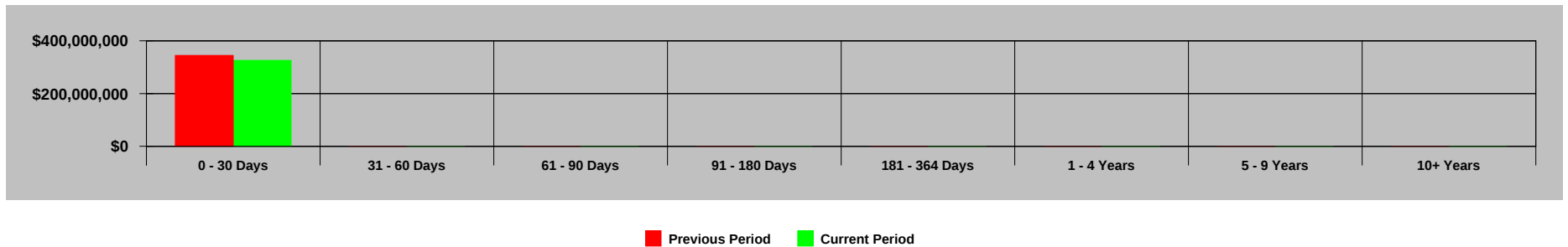
Portfolio Composition - 03/31/10



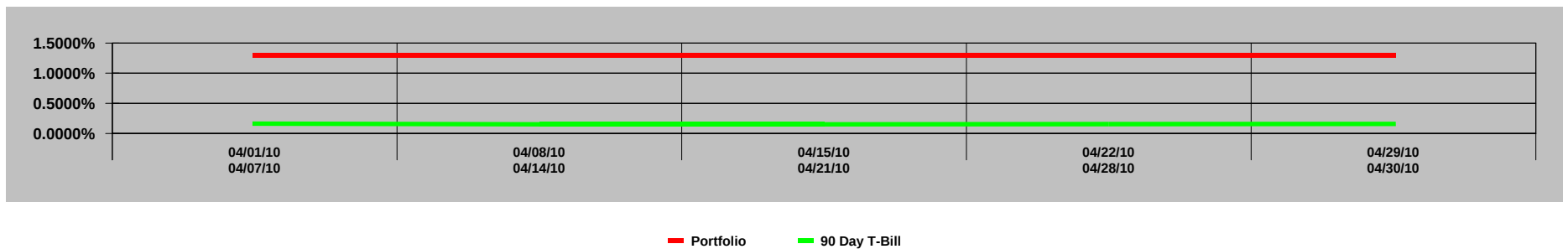
Portfolio Composition - 04/30/10

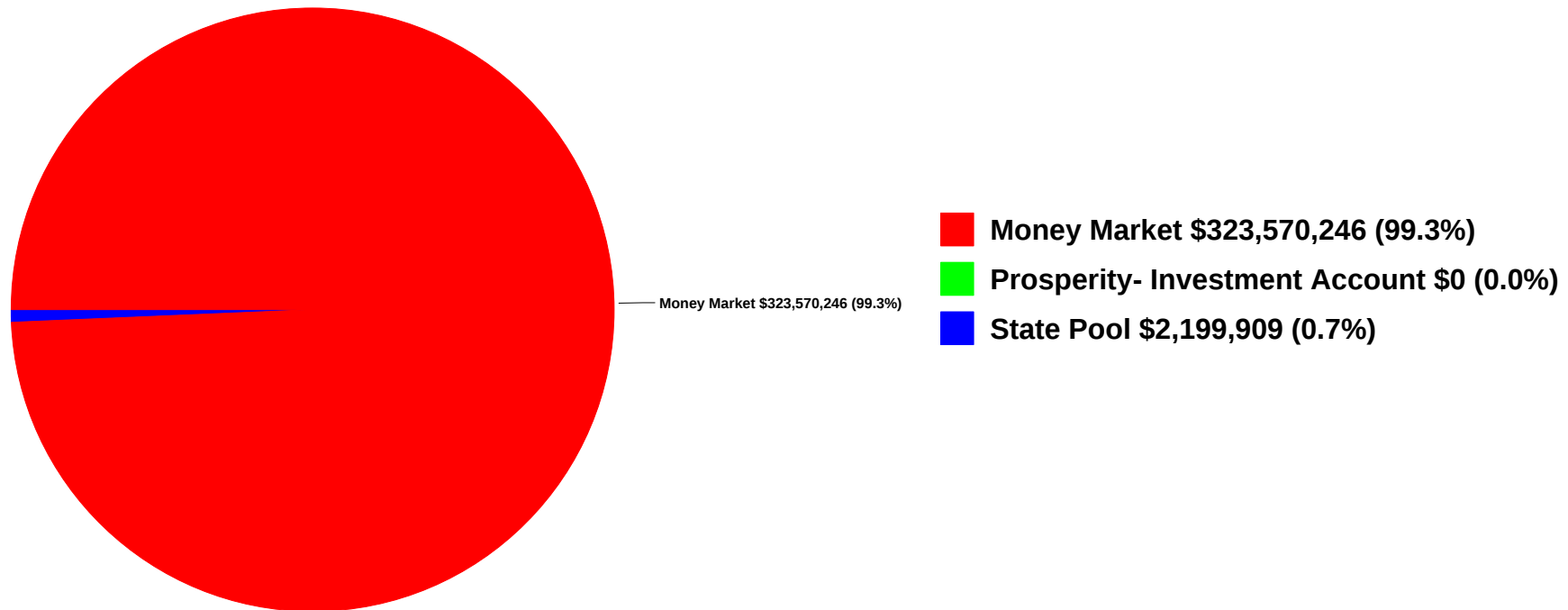

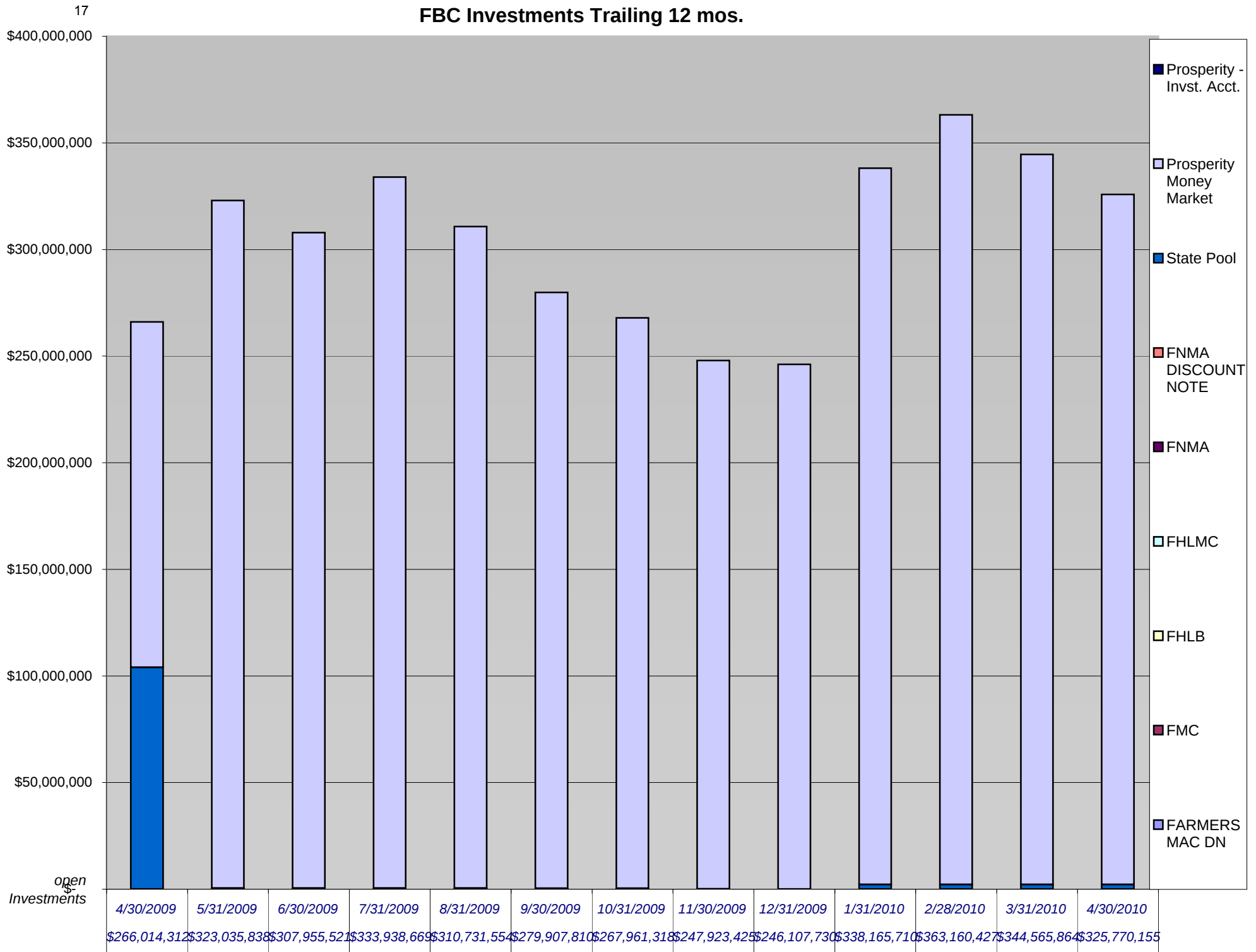

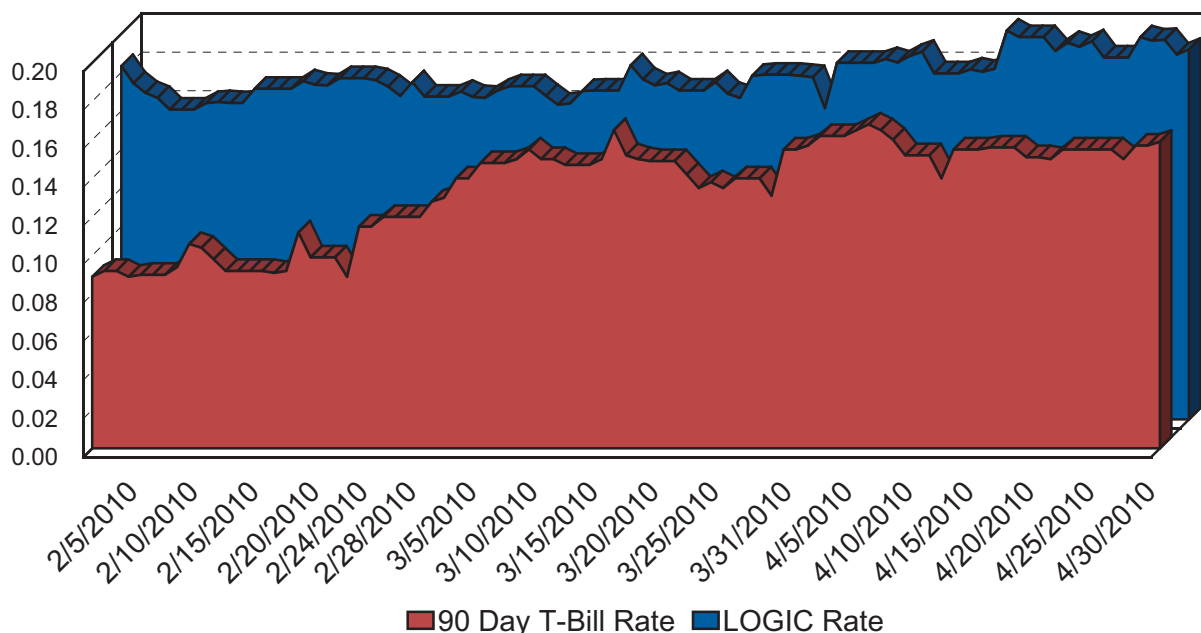
