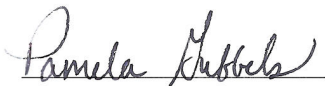

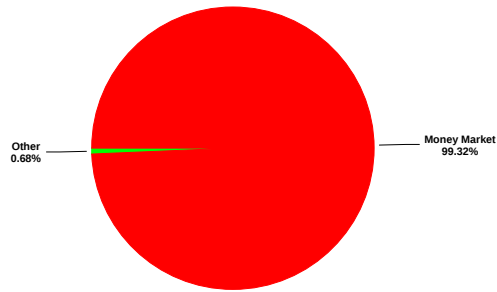

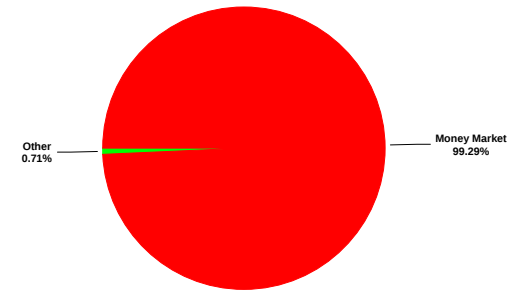

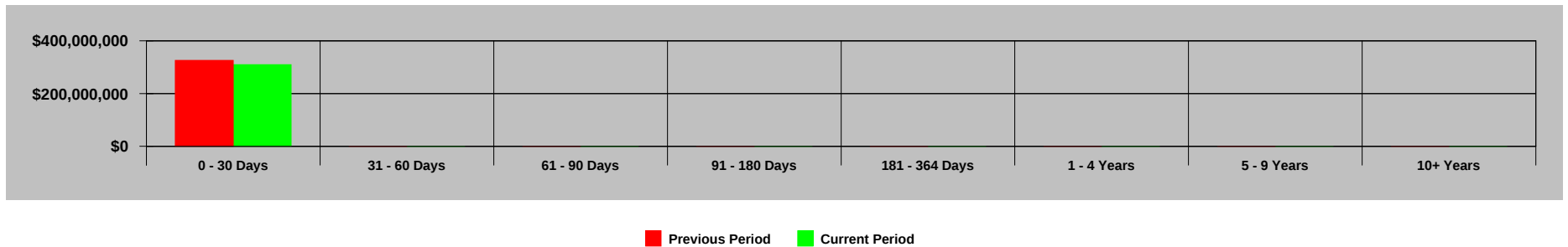
Portfolio Composition - 04/30/10



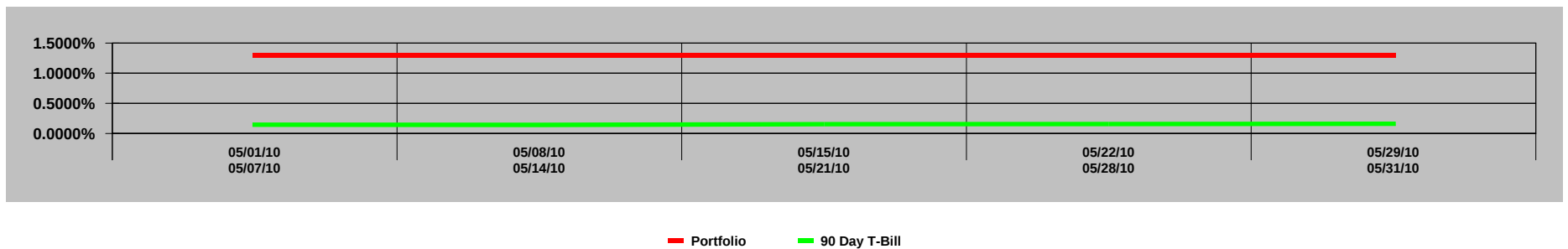
Portfolio Composition - 05/31/10

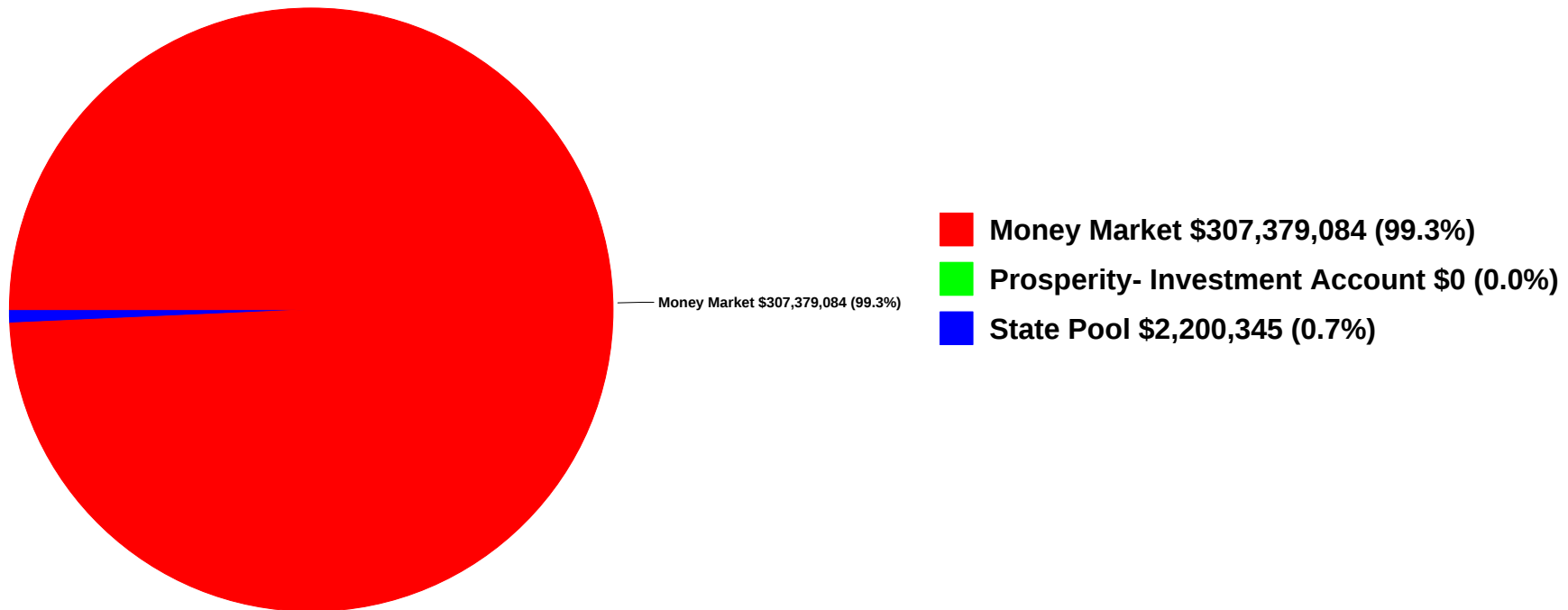

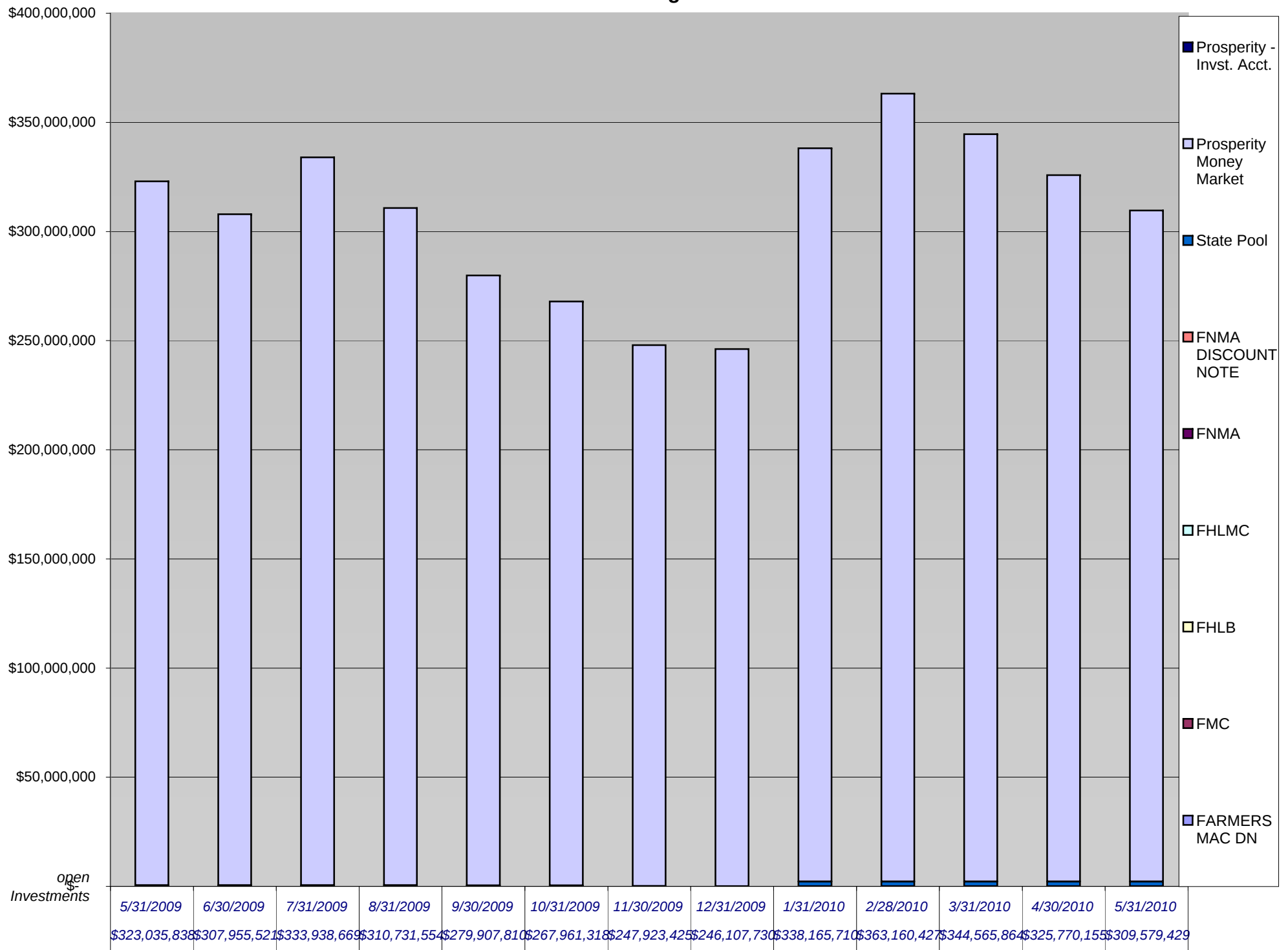

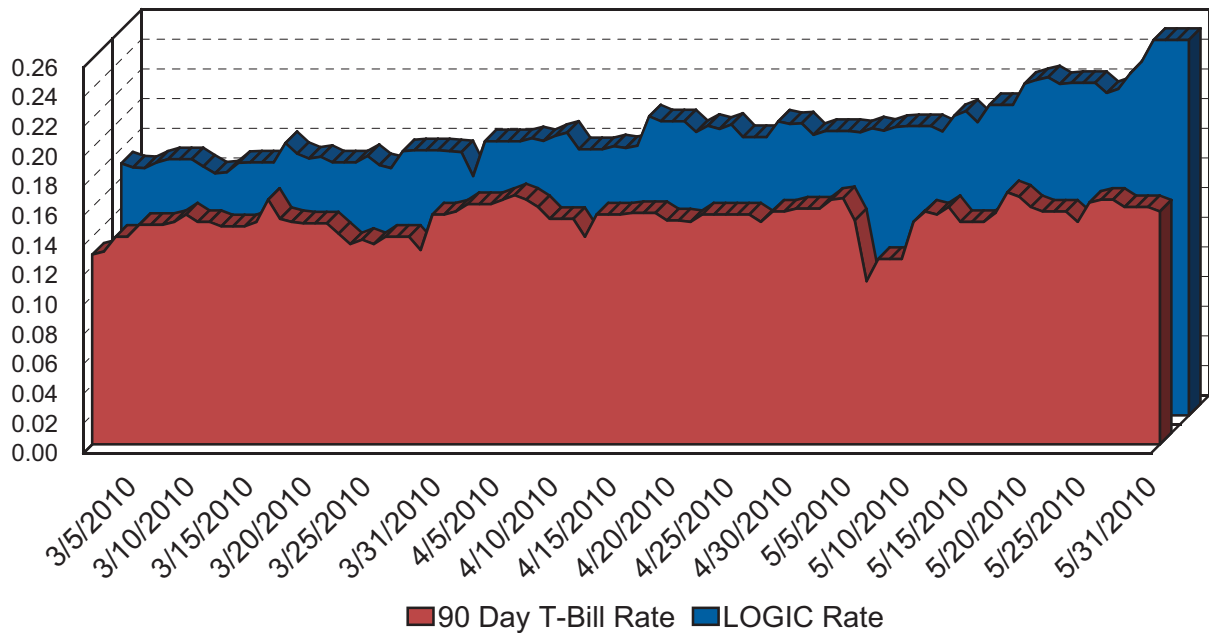
