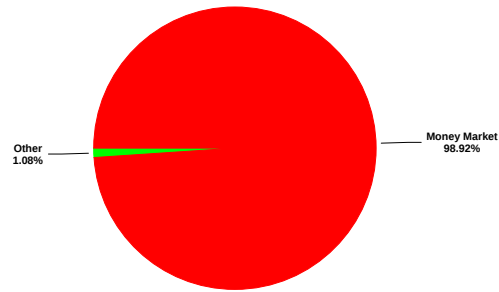

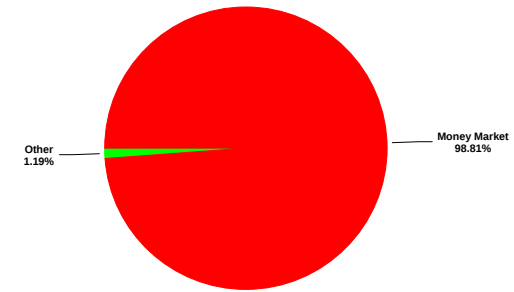

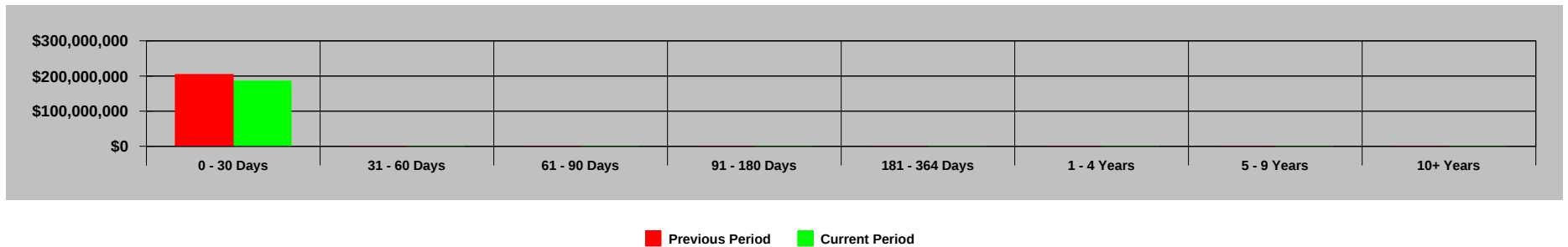
Portfolio Composition - 10/31/10



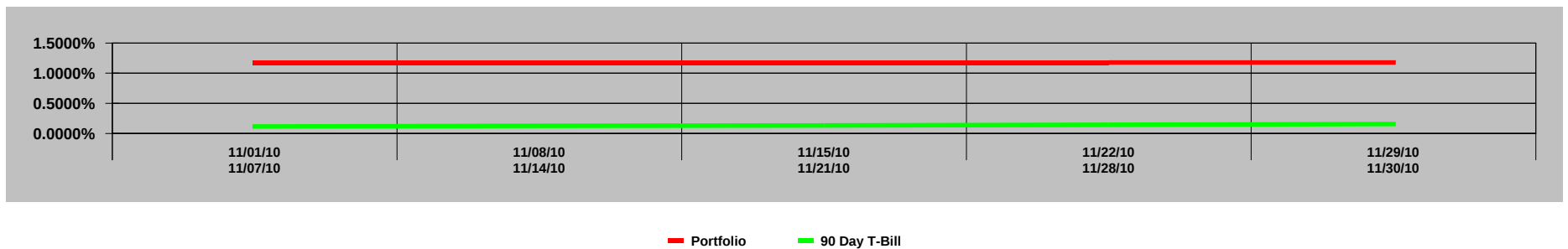
Portfolio Composition - 11/30/10

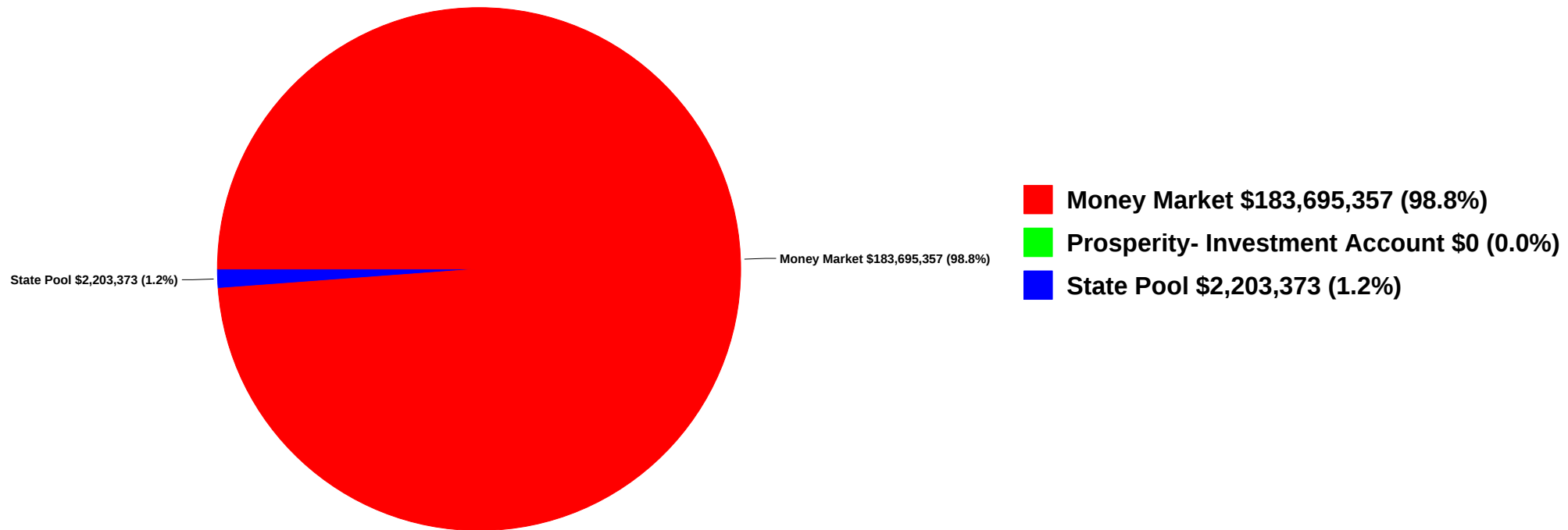

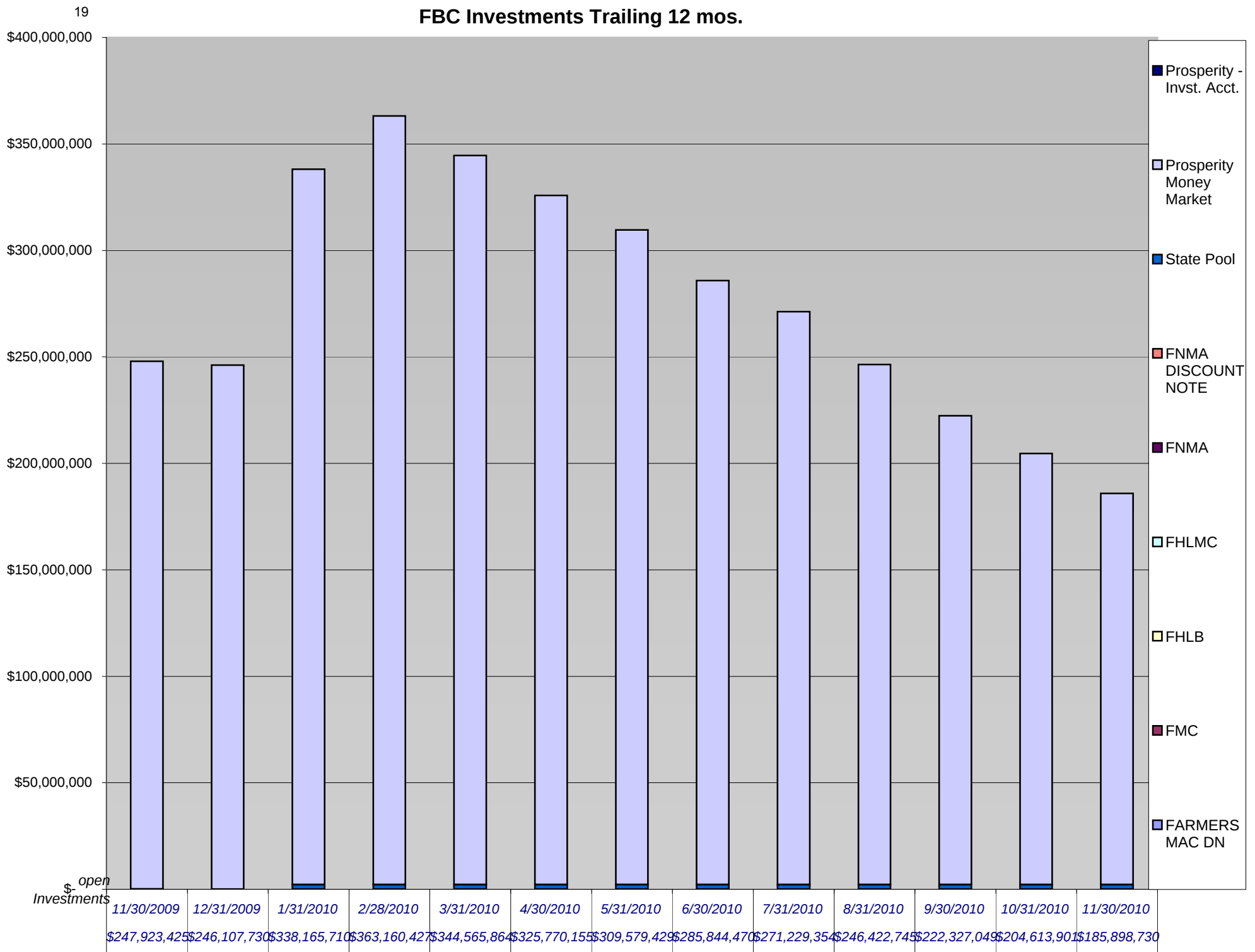

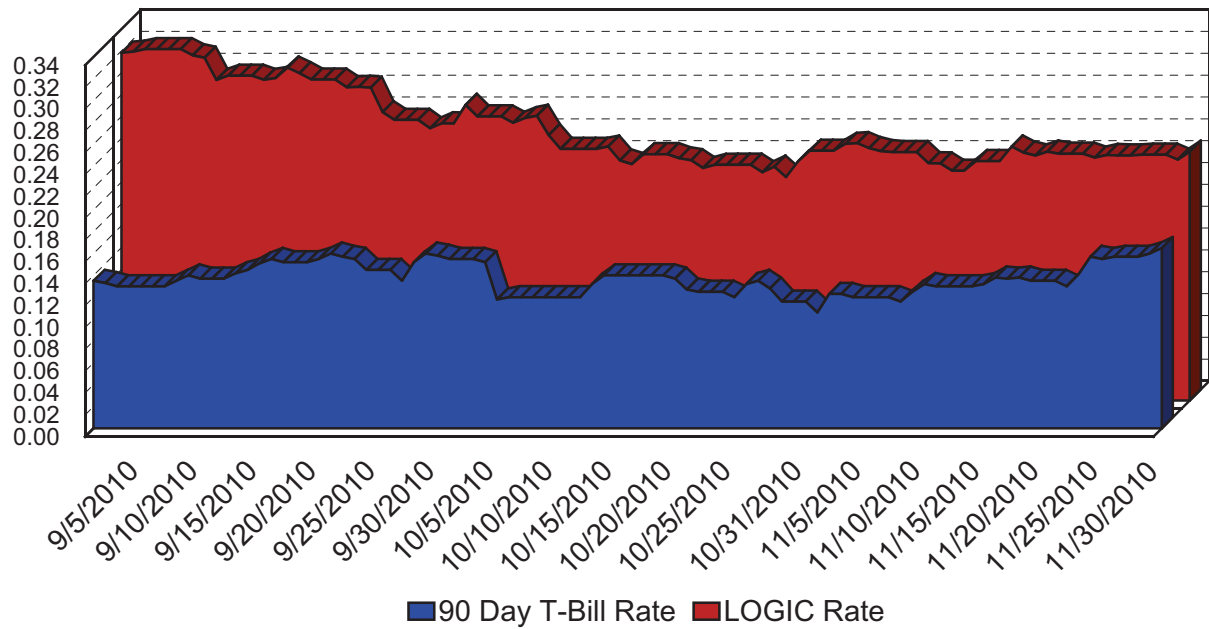
