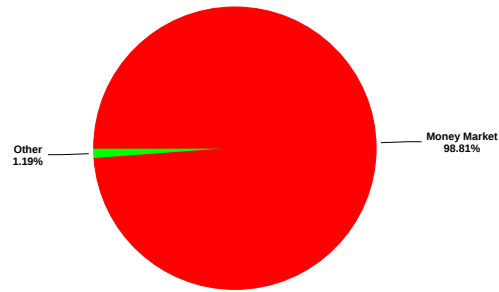

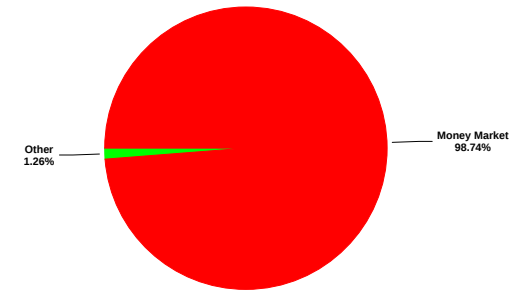

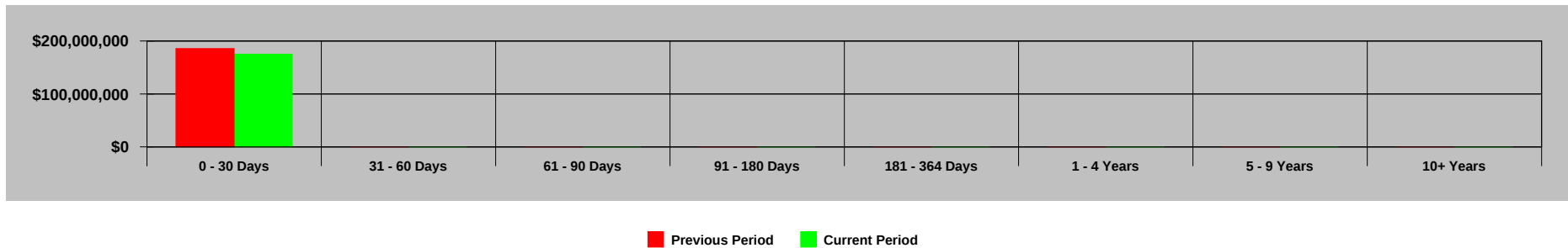
Portfolio Composition - 11/30/10



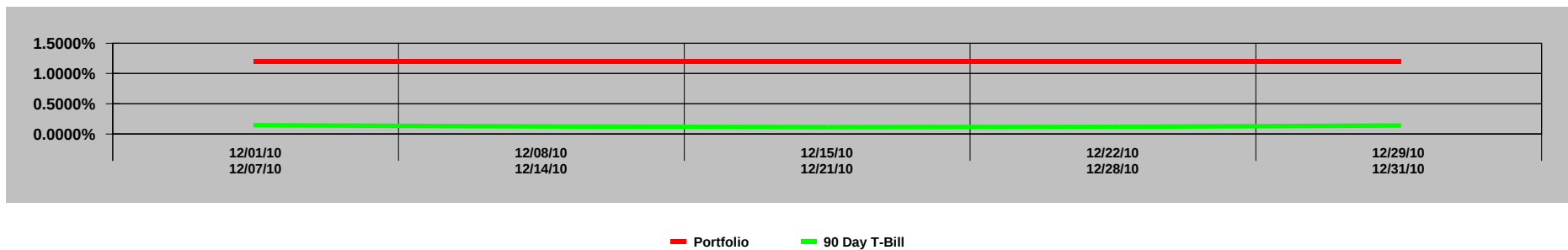
Portfolio Composition - 12/31/10

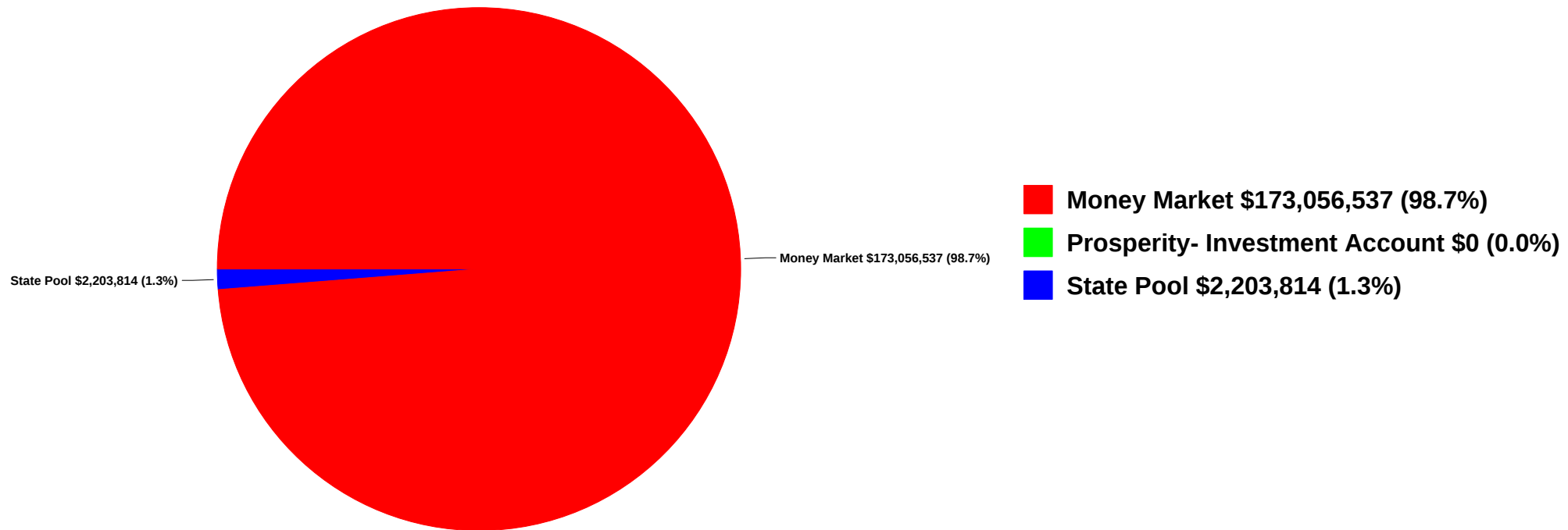

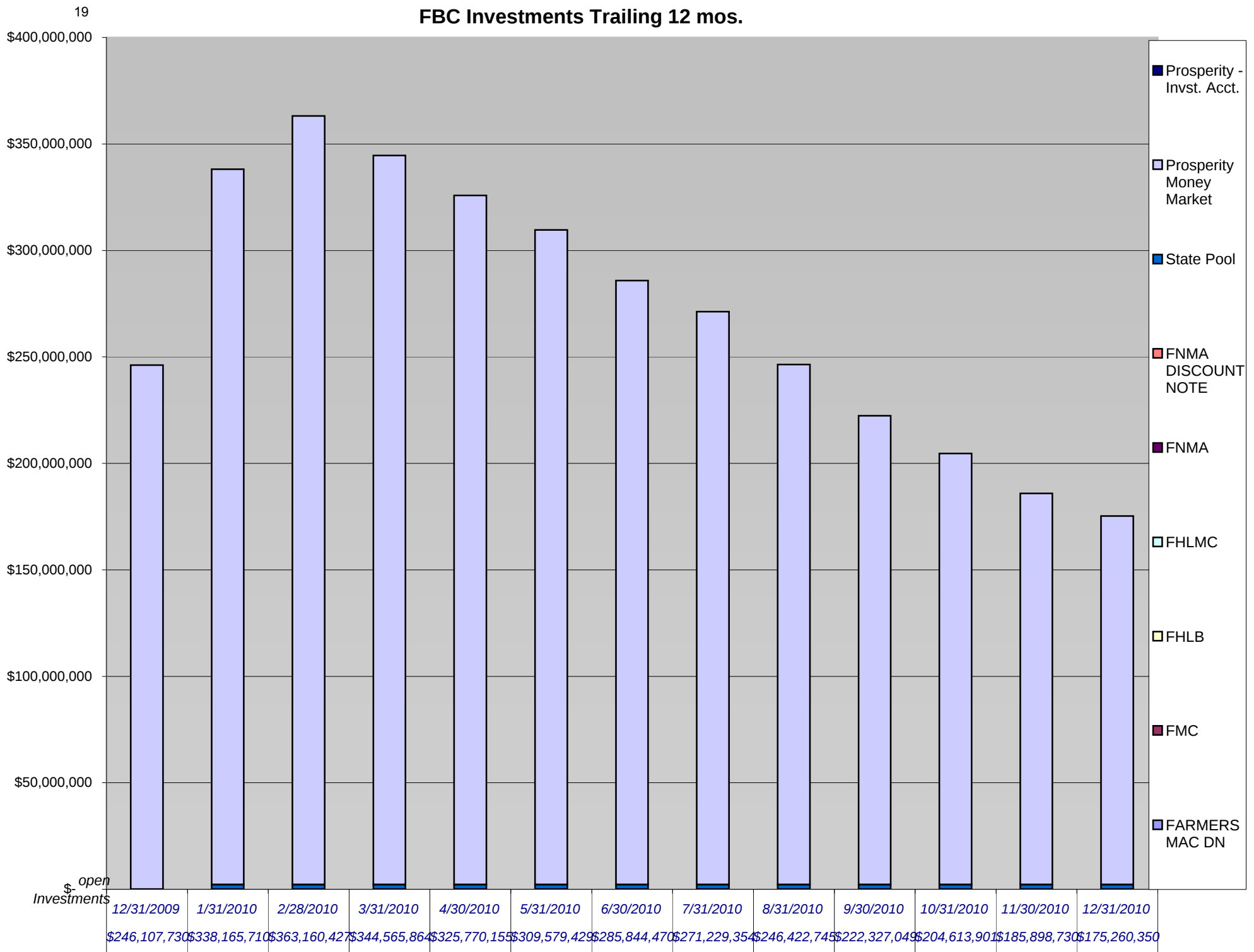

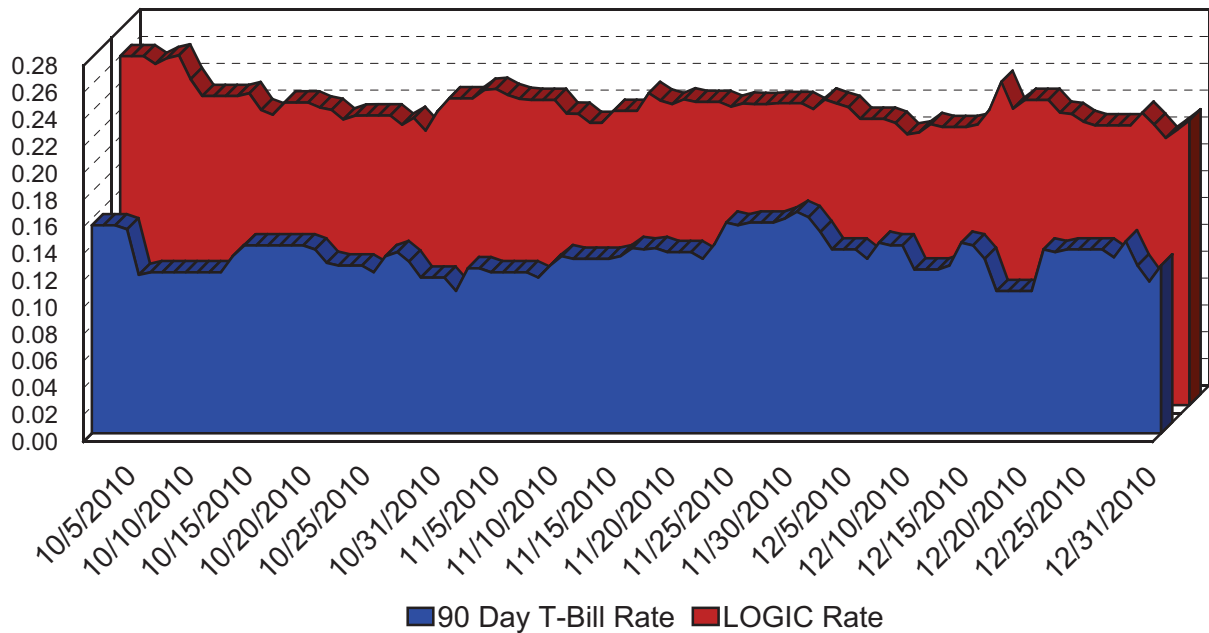
