Mr. H. G. Willrich is requesting waiver of penalty, interest and collection fees on the above referenced account for the 2008 and 2009 tax years because he states he did not receive the original tax statements for those years.

Tax Office records indicate:

- Original deed was filed September 30, 1977 Volume 743 Page 620, with incorrect Lot 22 listed. A
 corrected deed was filed February 17, 1978 Volume 762 Page 244, with correct Lot 29 listed. Neither
 deed showed a mailing address for Mr. Willrich.
- According to Fort Bend County Tax Office Tax Rolls the mailing address for Mr. Willrich for the years 1998 through 2009 was listed as RR 1 Box 1509W, Fresno, TX 77545-9638. For the years 1982 through 1997, the mailing address was listed as PO Box 1192, Fresno, TX 77545-1192.
- Taxes through 2007 were paid for by his mortgage company. A Certificate of Satisfaction (#2008029239) was filed on March 20, 2008, and the actual Release of Lien (#2009051812) was filed May 27, 2009.

2008 Tax Year

- 2008 Tax Year was not coded for a mortgage company to receive the original tax statement...
- 2008 Original Tax Statement was mailed to Willrich H. G., RR 1 Box 1509W, Fresno, TX 77545-9638.

 Office to handle the processing of the waiver of penalty, interest and collection fees and allow the Fort
 Bend County Commissioners Court to make the determination based on 33.011 of the State Property
 Tax Code.
