Ms. Holland & Mr. Kalkattawi are requesting waiver of penalty and interest on the above referenced account for the 2010 tax year because they state that they did not receive their 2010 tax statement. They refinance their home in November 2010 and their previous loan had an escrow account and the previous mortgage company did not pay their 2010 property taxes.

Tax Office records indicate:

- Original deed #2008035126 was recorded on April 8, 2008 with the owner listed as Faisal N.
 Kalkattawi and wife, Catherine M. Holland with no mailing address listed.
- 2010 Original Tax Statement was requested by Corelogic by electronic request.
- 2010 tax roll list the owner as Kalkattawi Faisal N & Catherine M H, 13131 Old Windmill Dr, Richmond, TX 77407-3287.
- February 16, 2011—2010 February Tax Reminder mailed to Kalkattawi Faisal N & Catherine M H, 13131 Old Windmill Dr, Richmond, TX 77407-3287. **2010 Reminder was not returned by Post Office.**
- Taxpayer received the 2010 February Reminder and called the tax office and was told the 2010 original tax statement was sent to the mortgage company.
- There is no evidence of an error by the Ft Bend Central Appraisal District or the Ft Bend County Tax Office.
- Fort Bend ISD has authorized Fort Bend County Tax Office to handle the processing of the waiver of
 penalty and interest and allow the Fort Bend County Commissioners Court to make the determination
 based on 33.011 of the State Property Tax Code.
