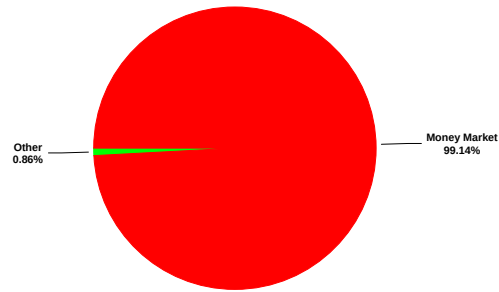

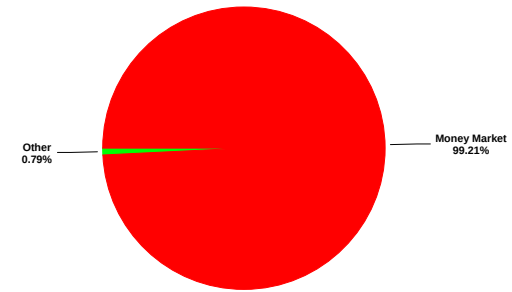

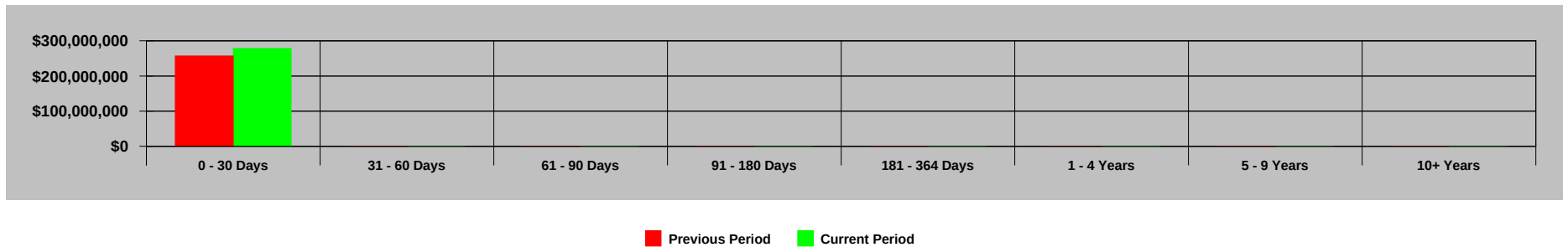
Portfolio Composition - 01/31/11



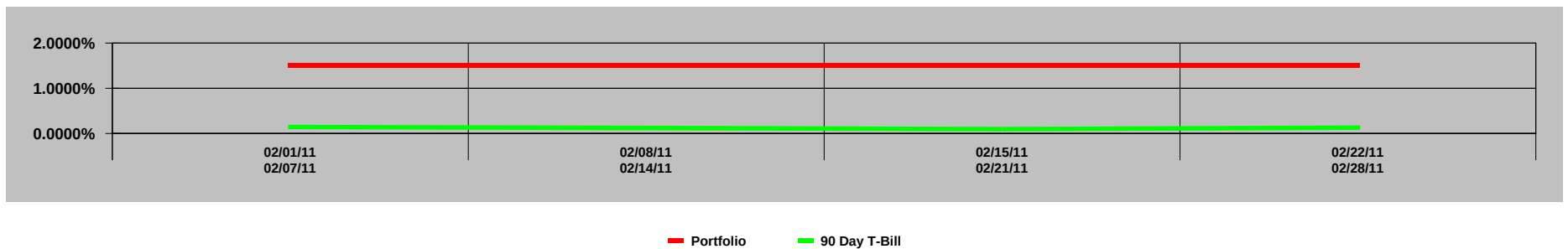
Portfolio Composition - 02/28/11

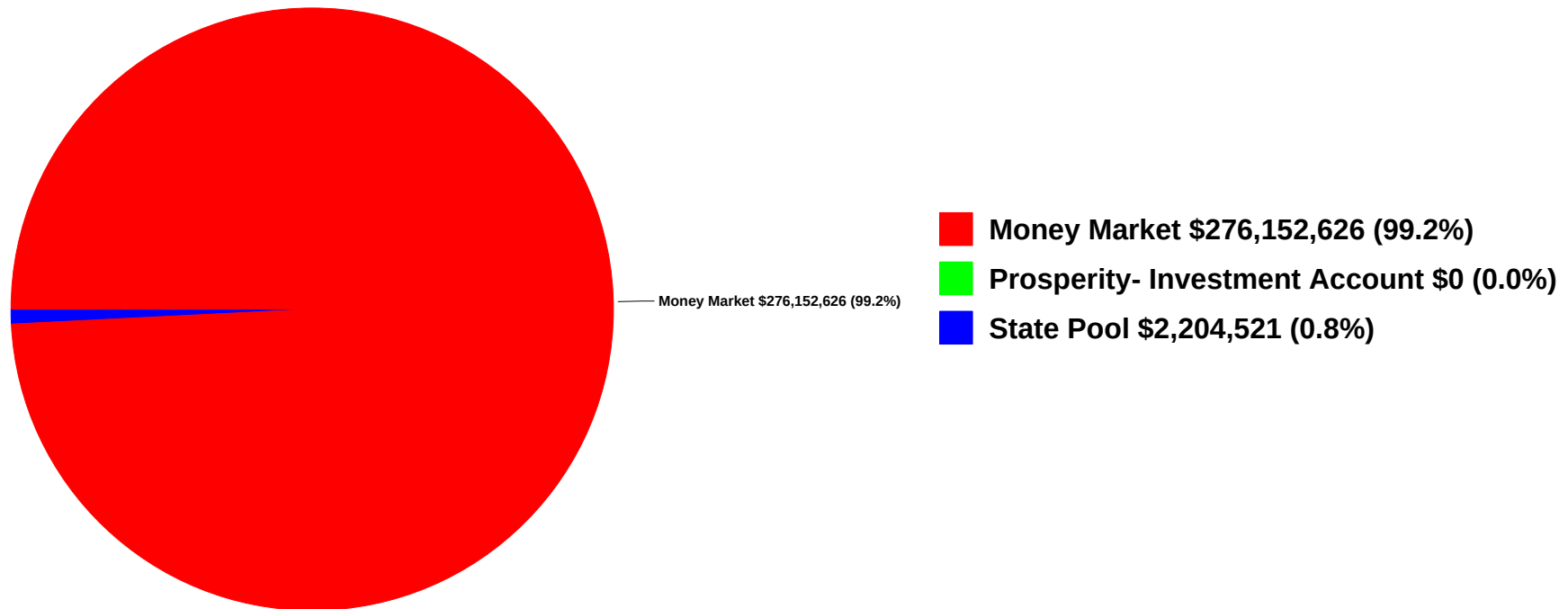

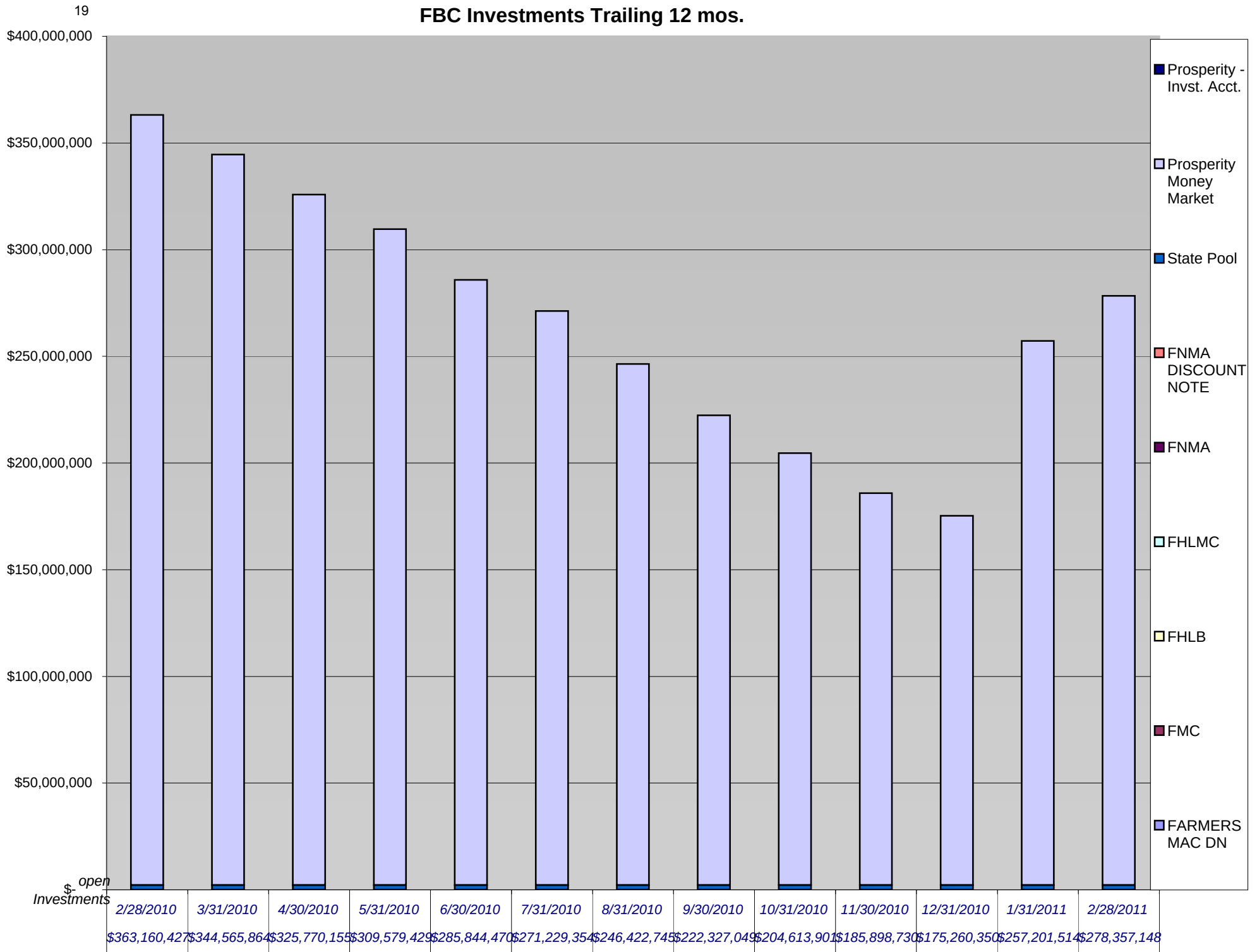

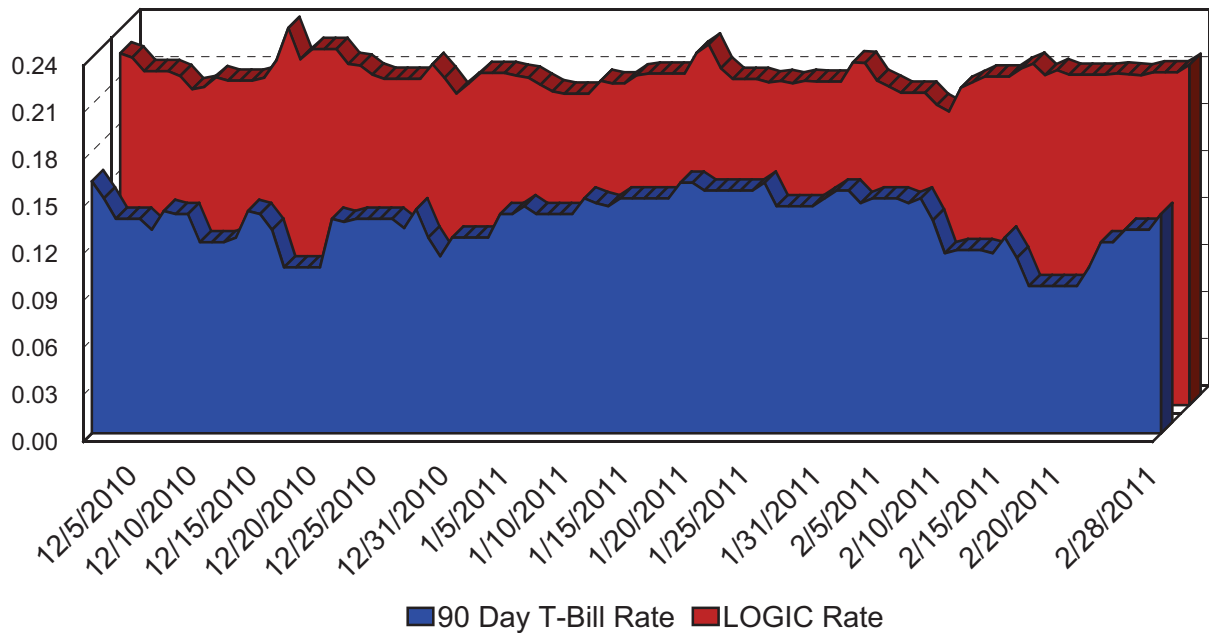
