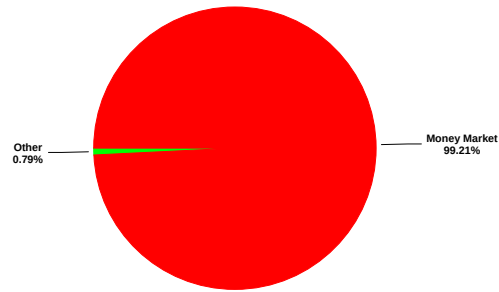

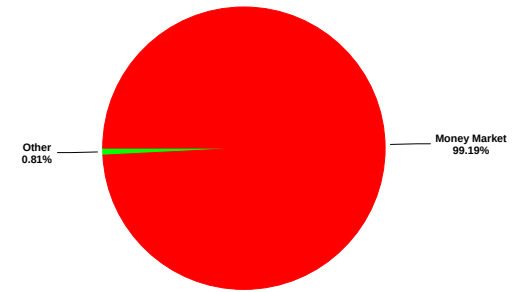

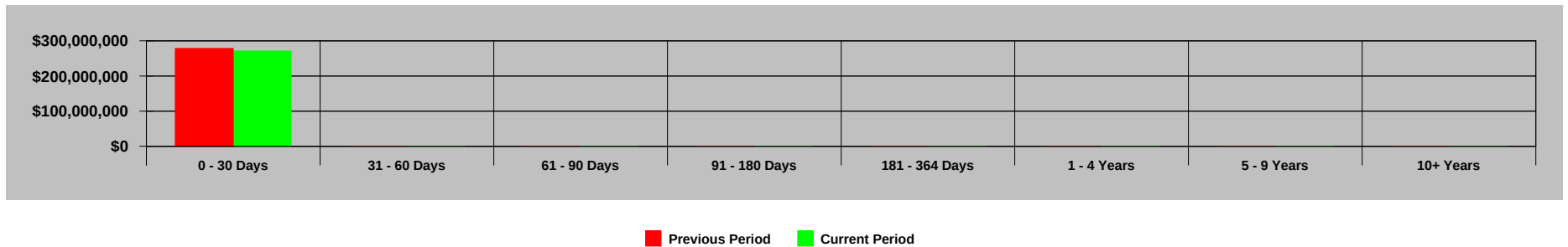
Portfolio Composition - 02/28/11



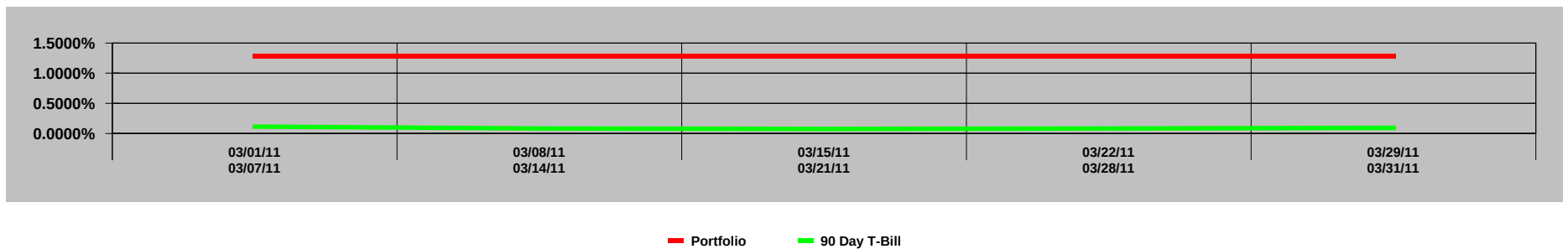
Portfolio Composition - 03/31/11

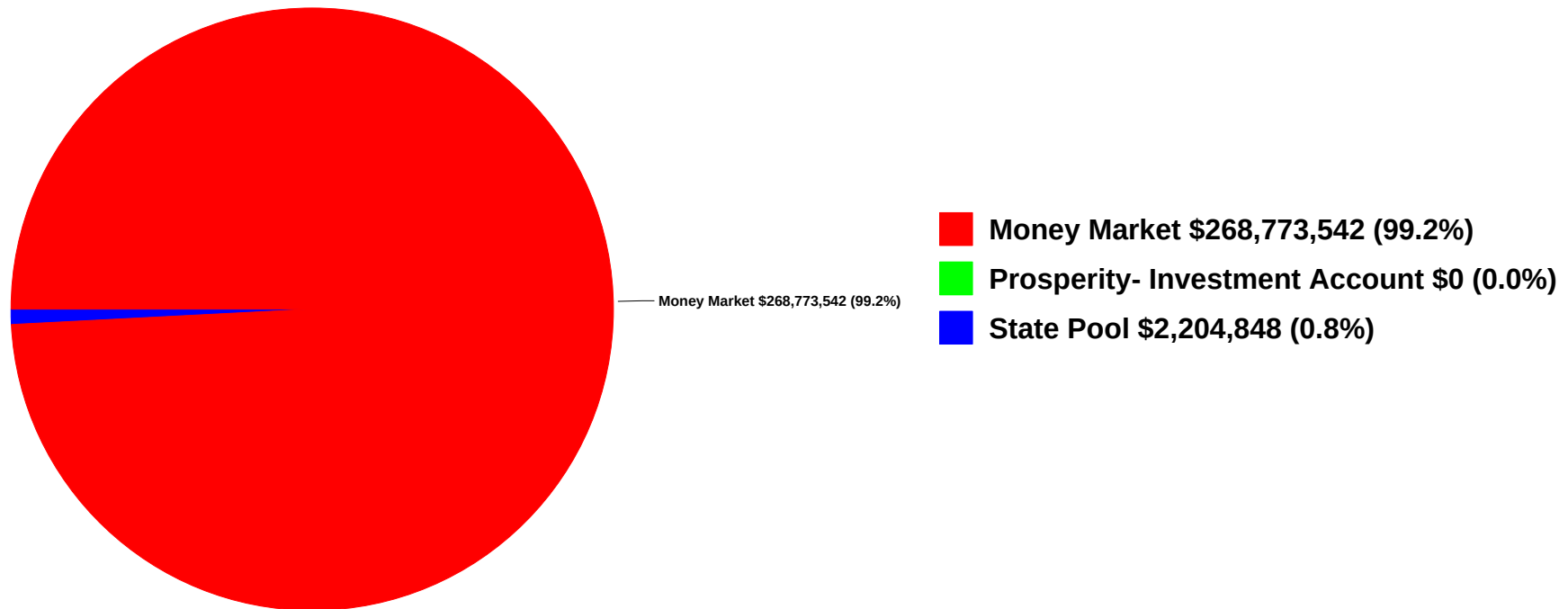

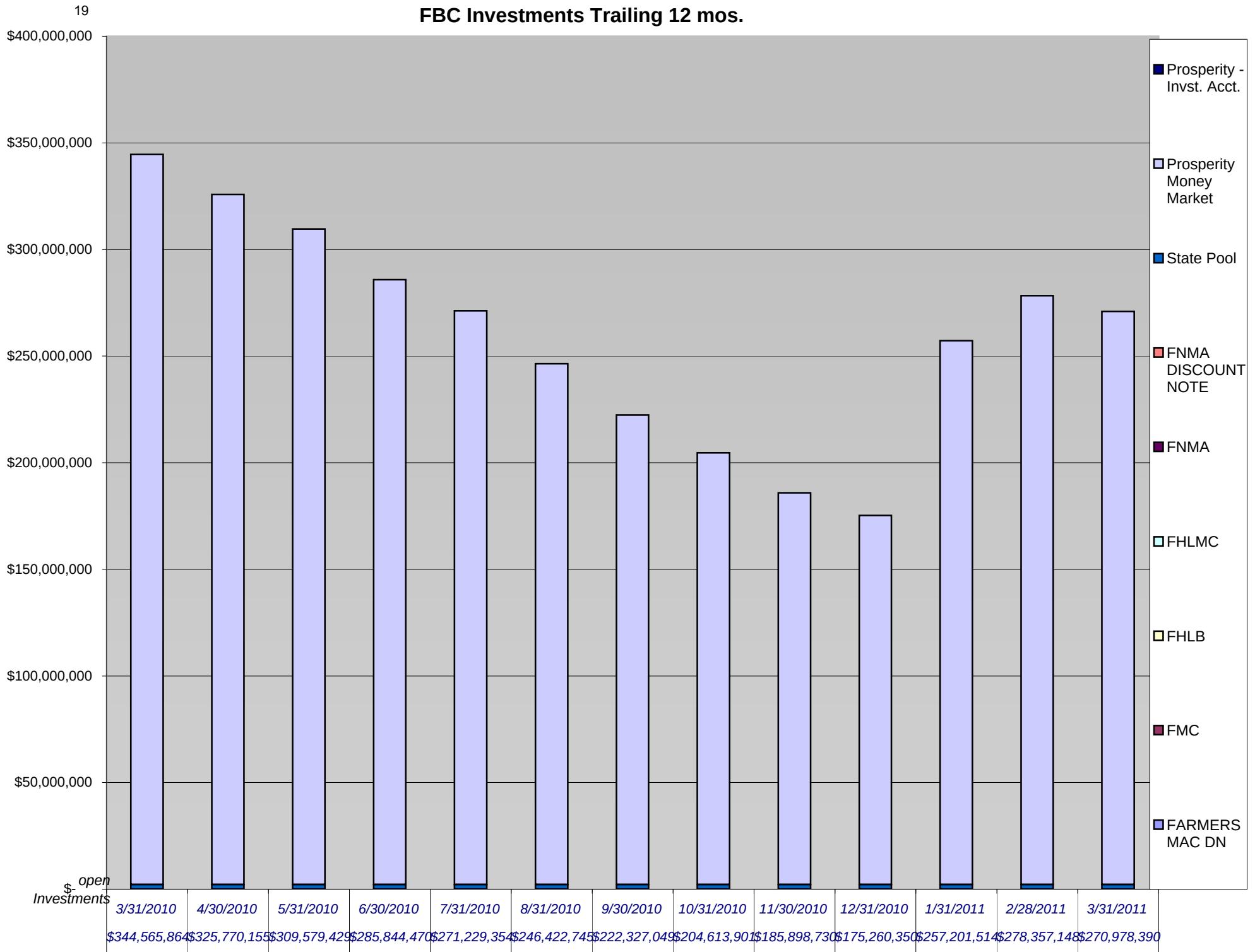

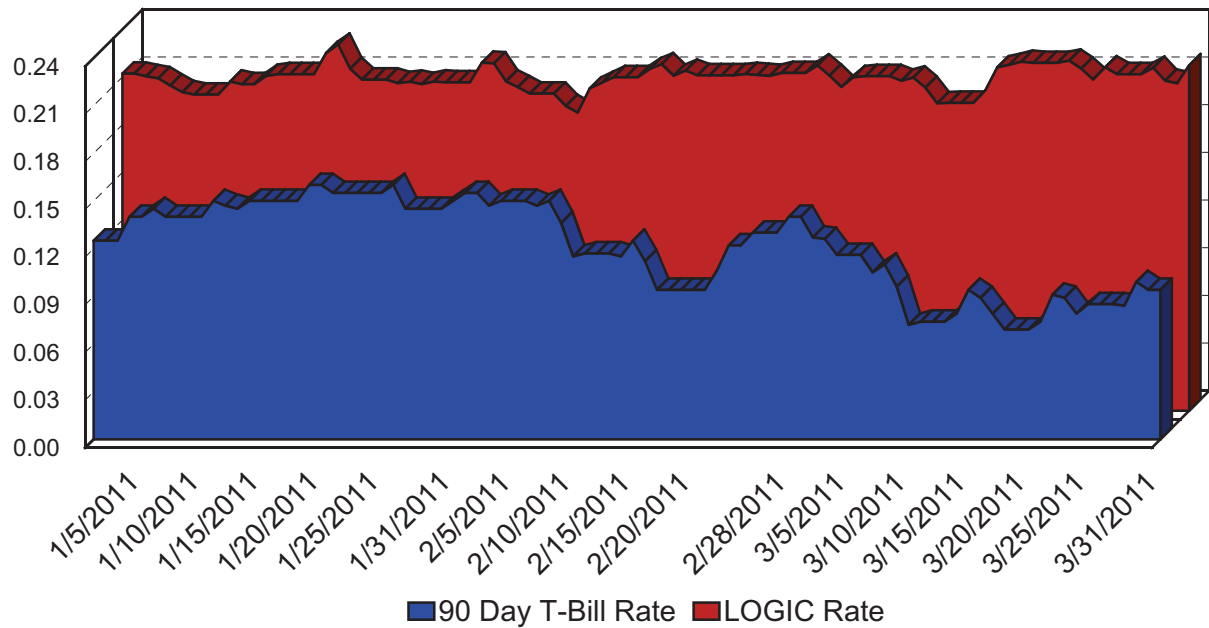
