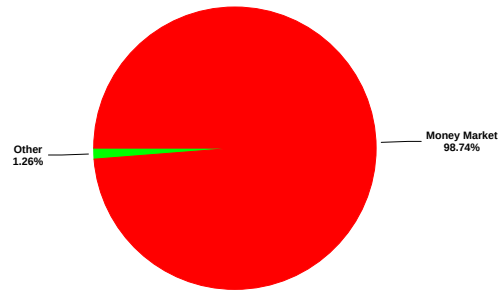

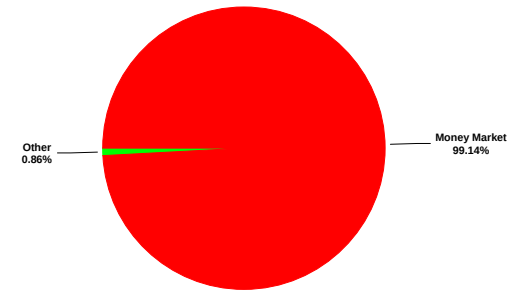

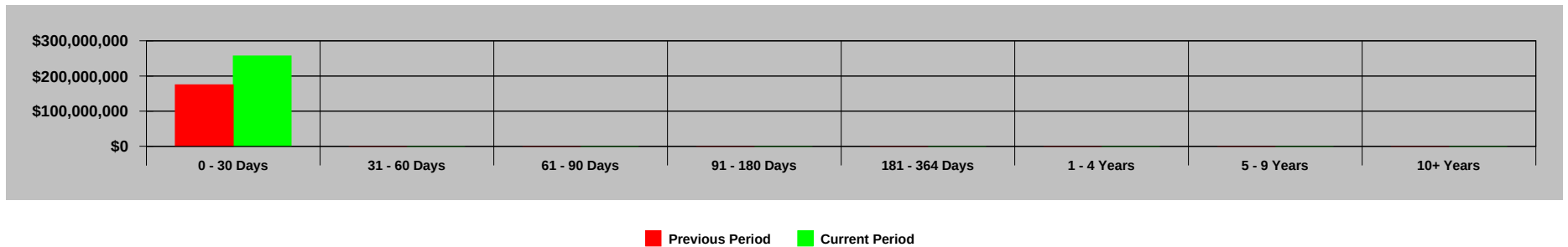
Portfolio Composition - 12/31/10



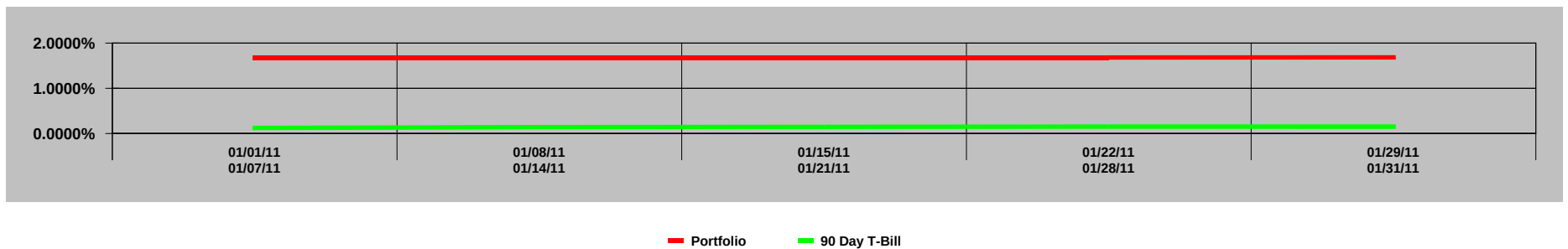
Portfolio Composition - 01/31/11

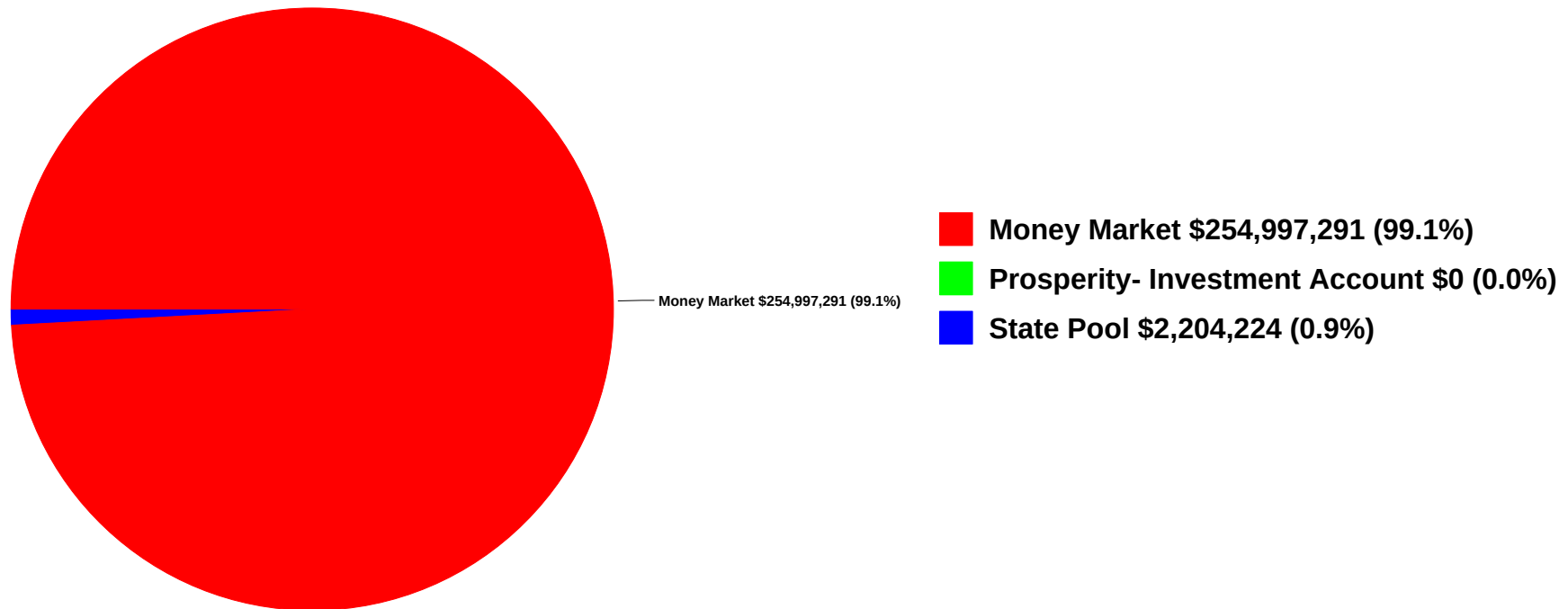

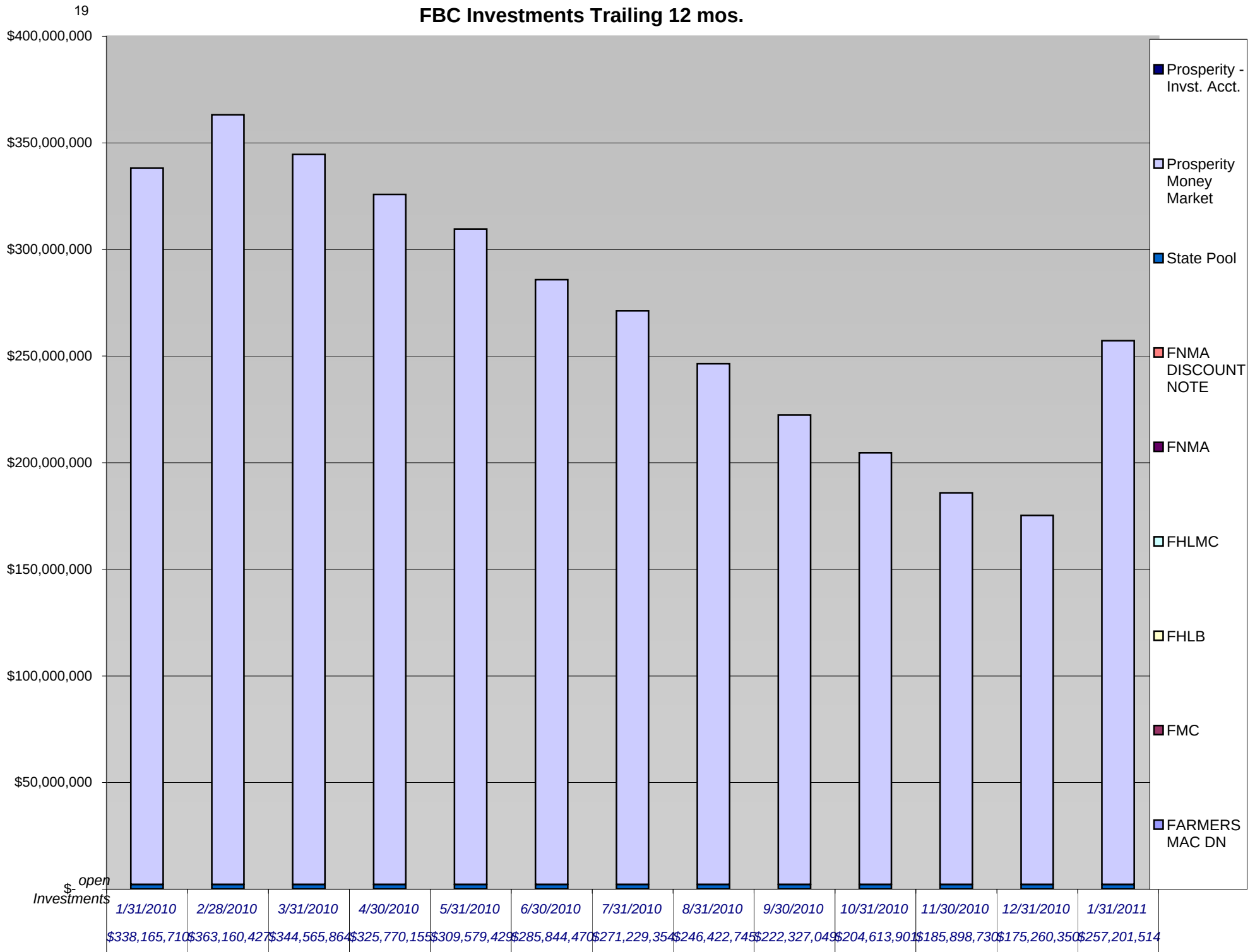

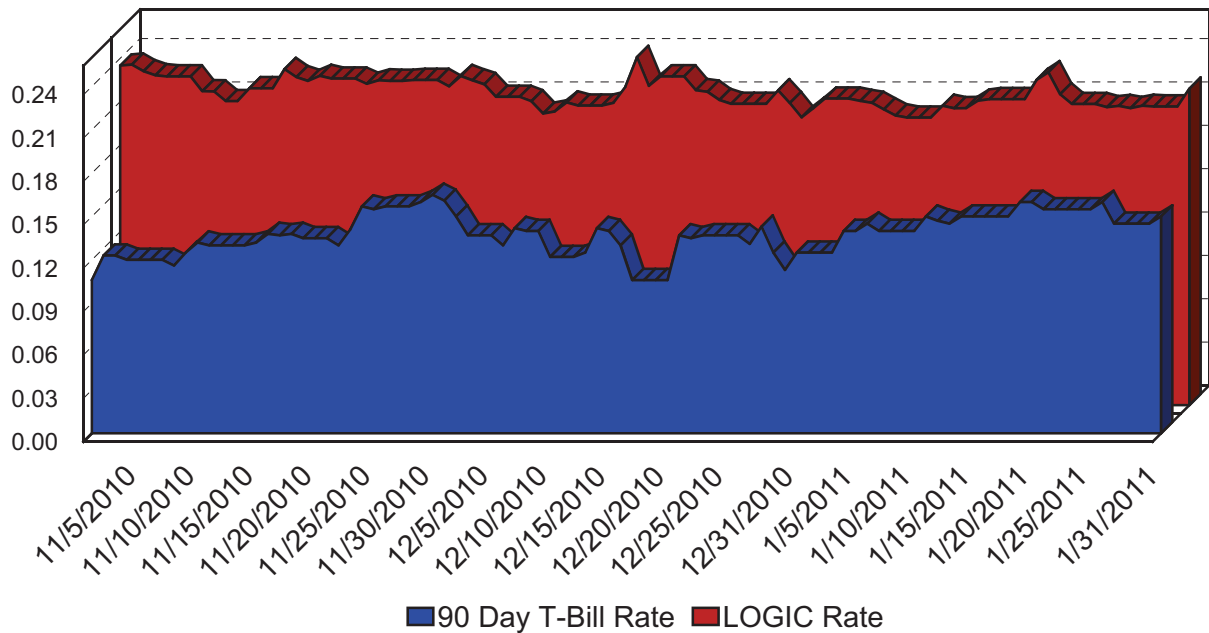
