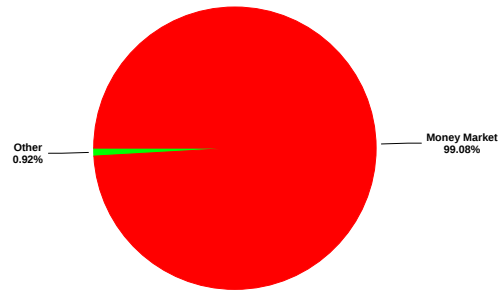

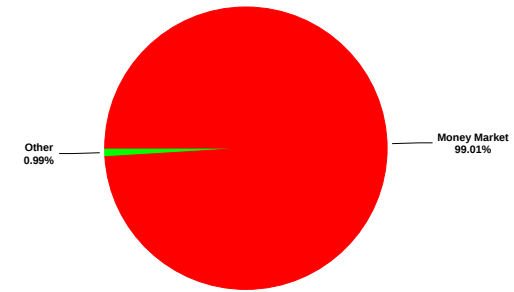

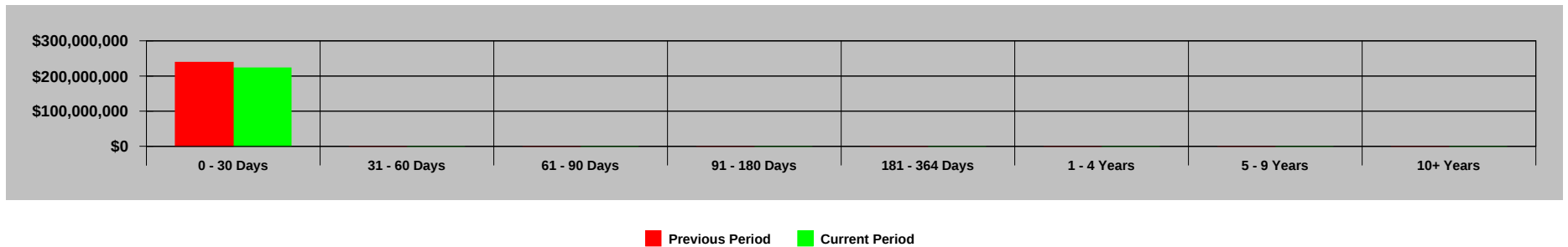
Portfolio Composition - 05/31/11



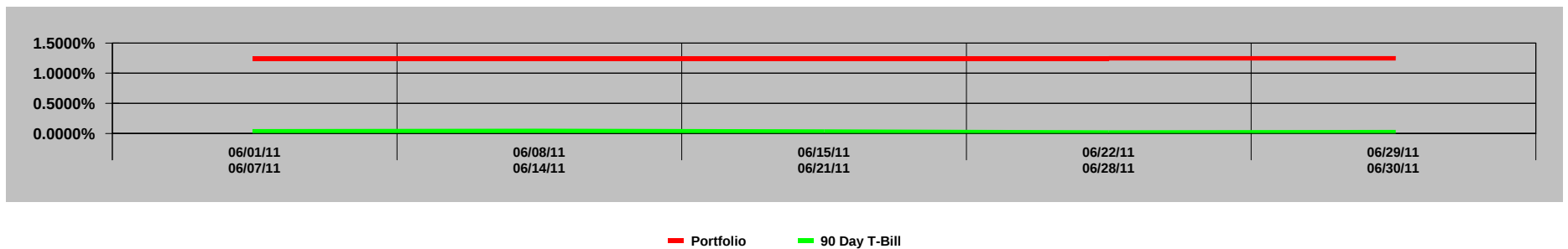
Portfolio Composition - 06/30/11

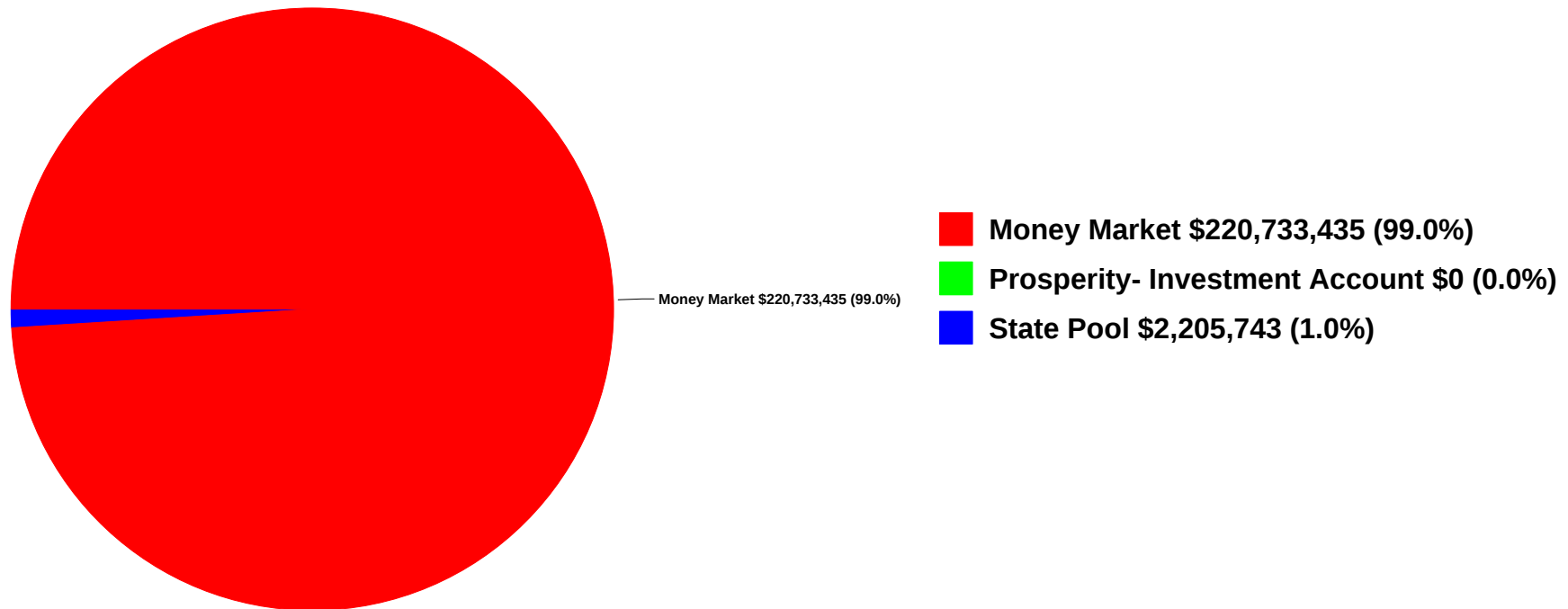

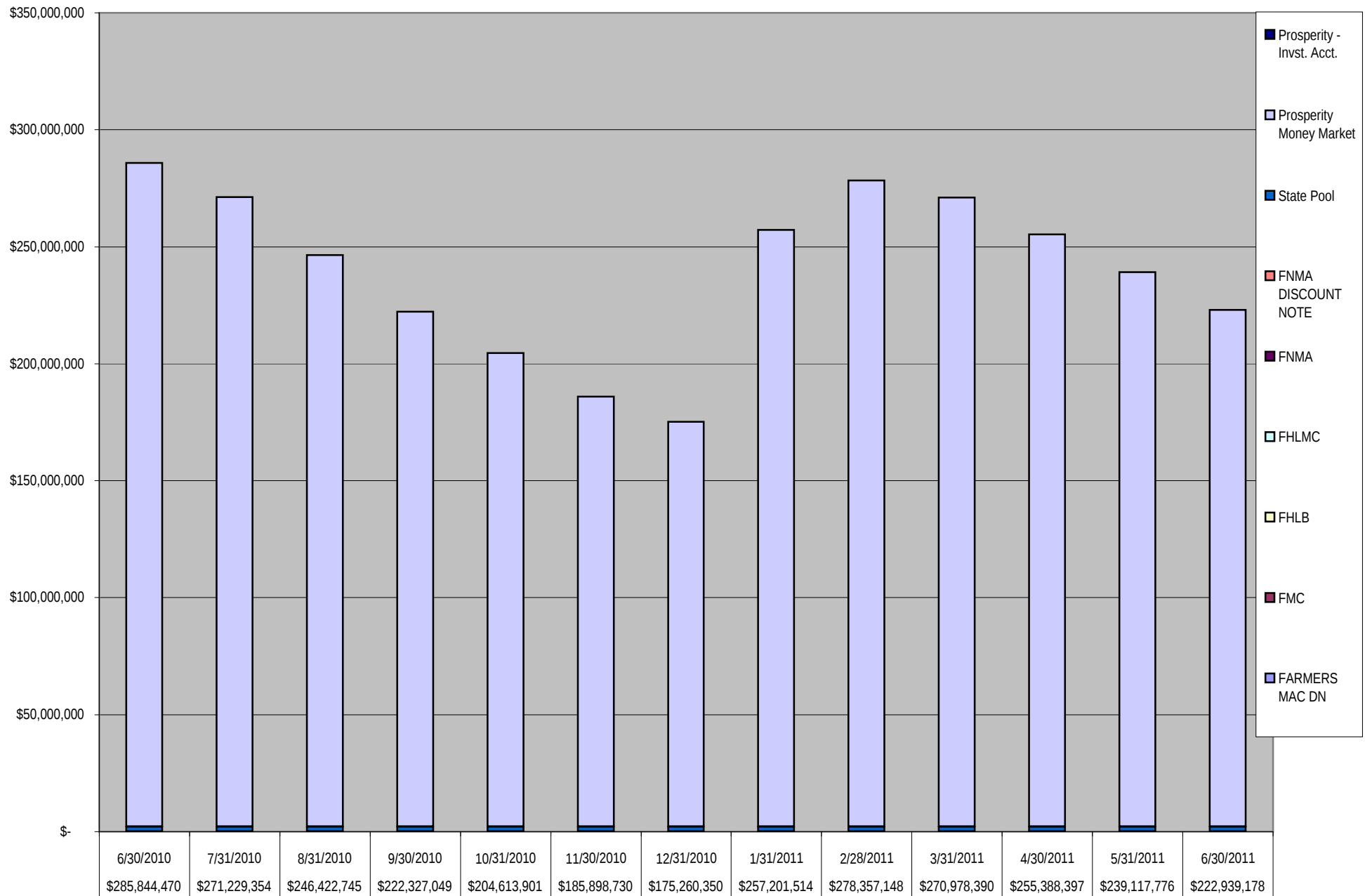

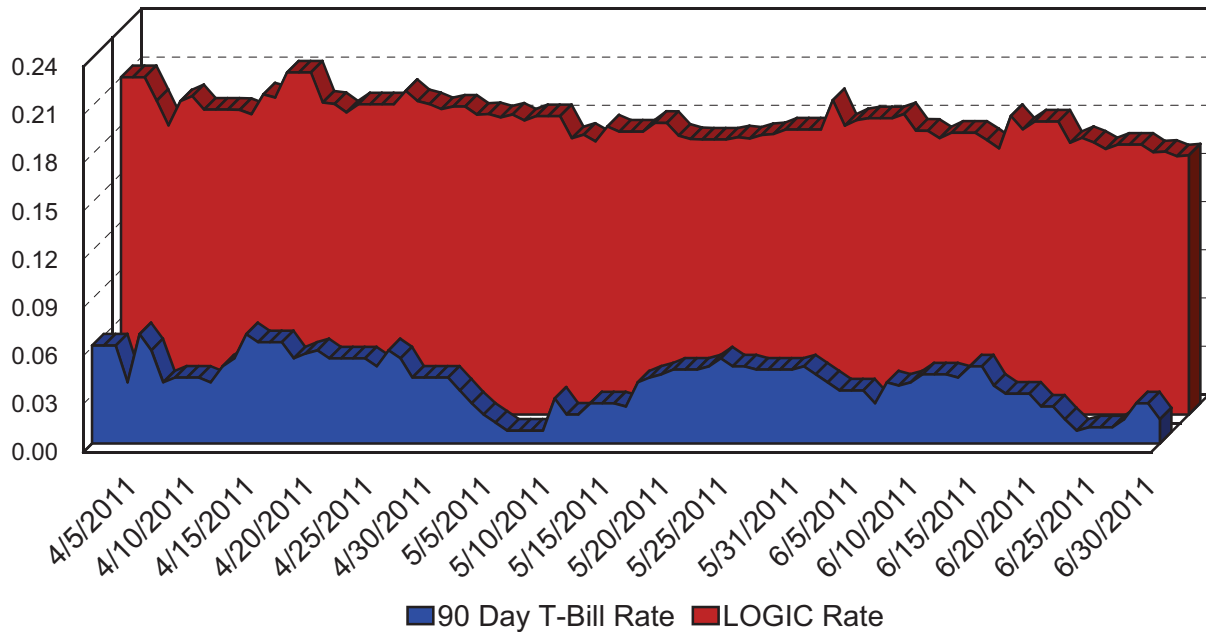
