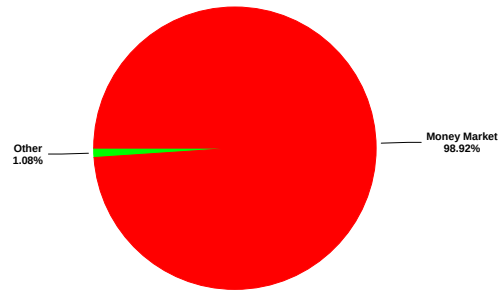

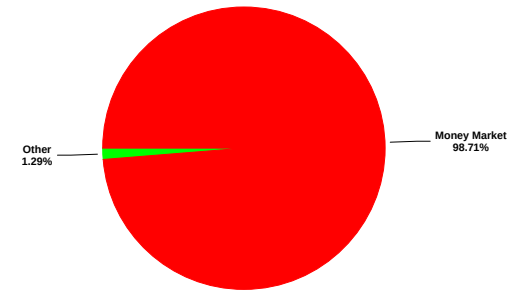

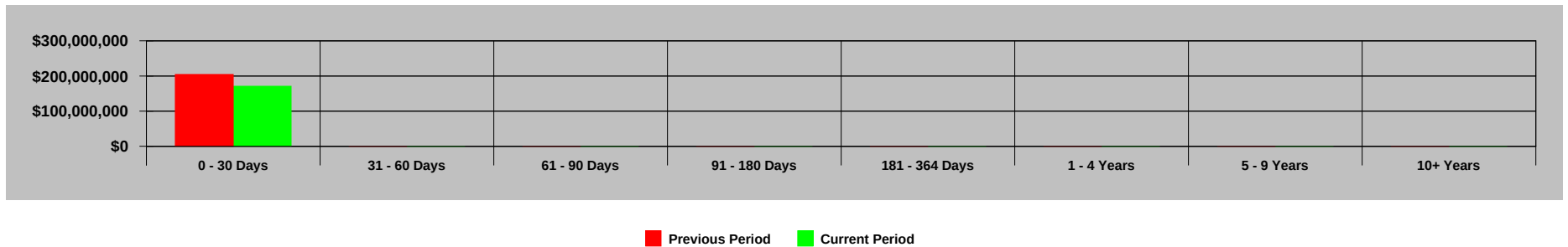
Portfolio Composition - 07/31/11



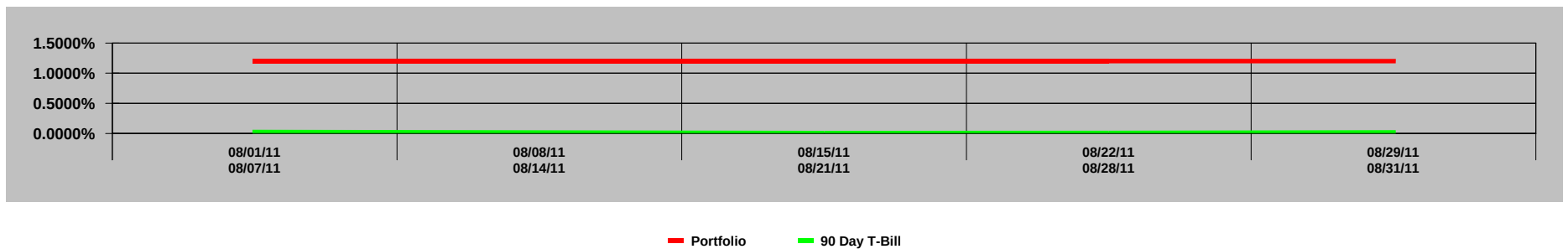
Portfolio Composition - 08/31/11
