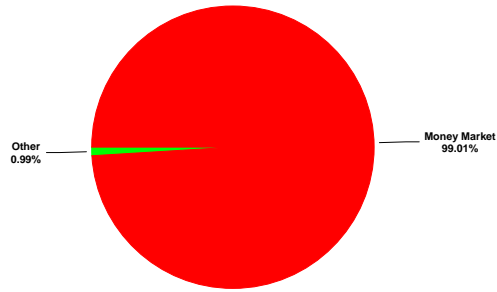

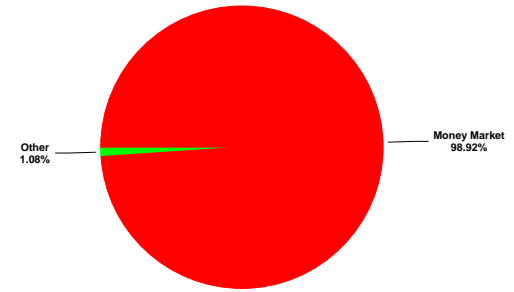

Portfolio Composition - 07/31/11

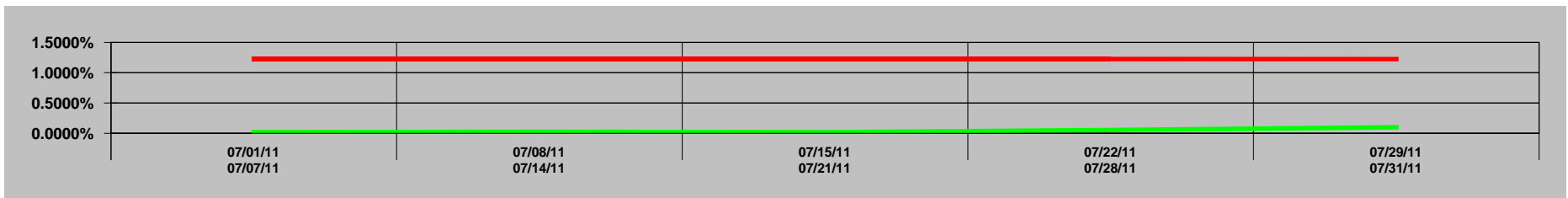


Maturity Aging - 06/30/11 vs 07/31/11

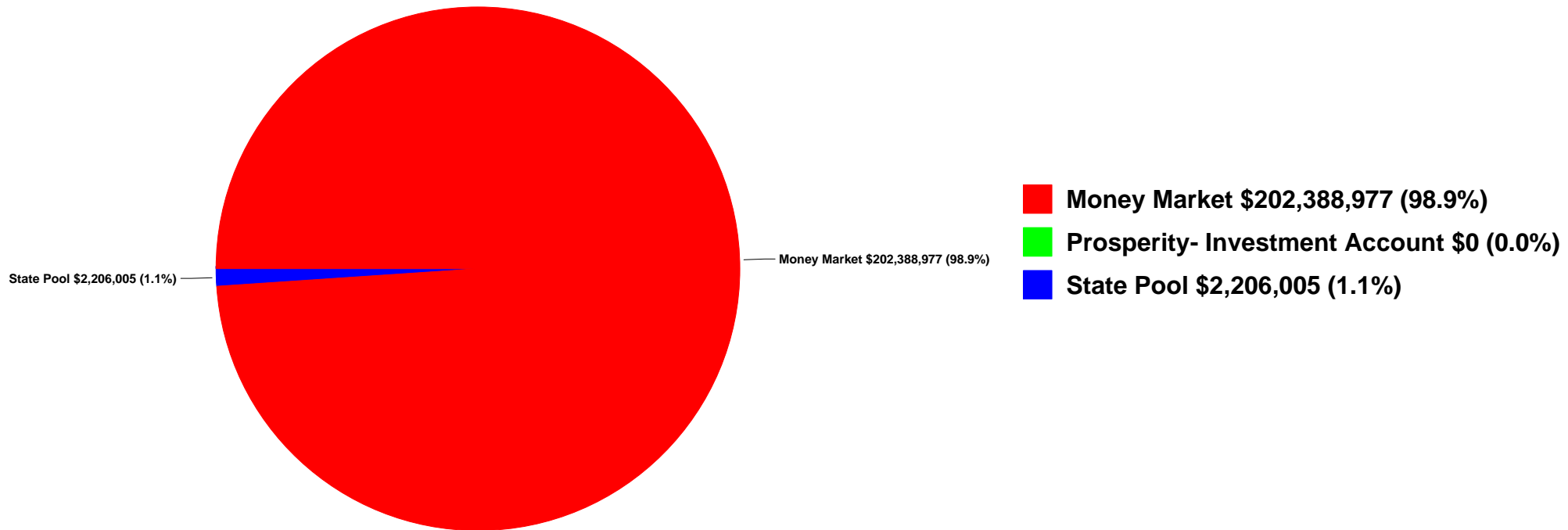

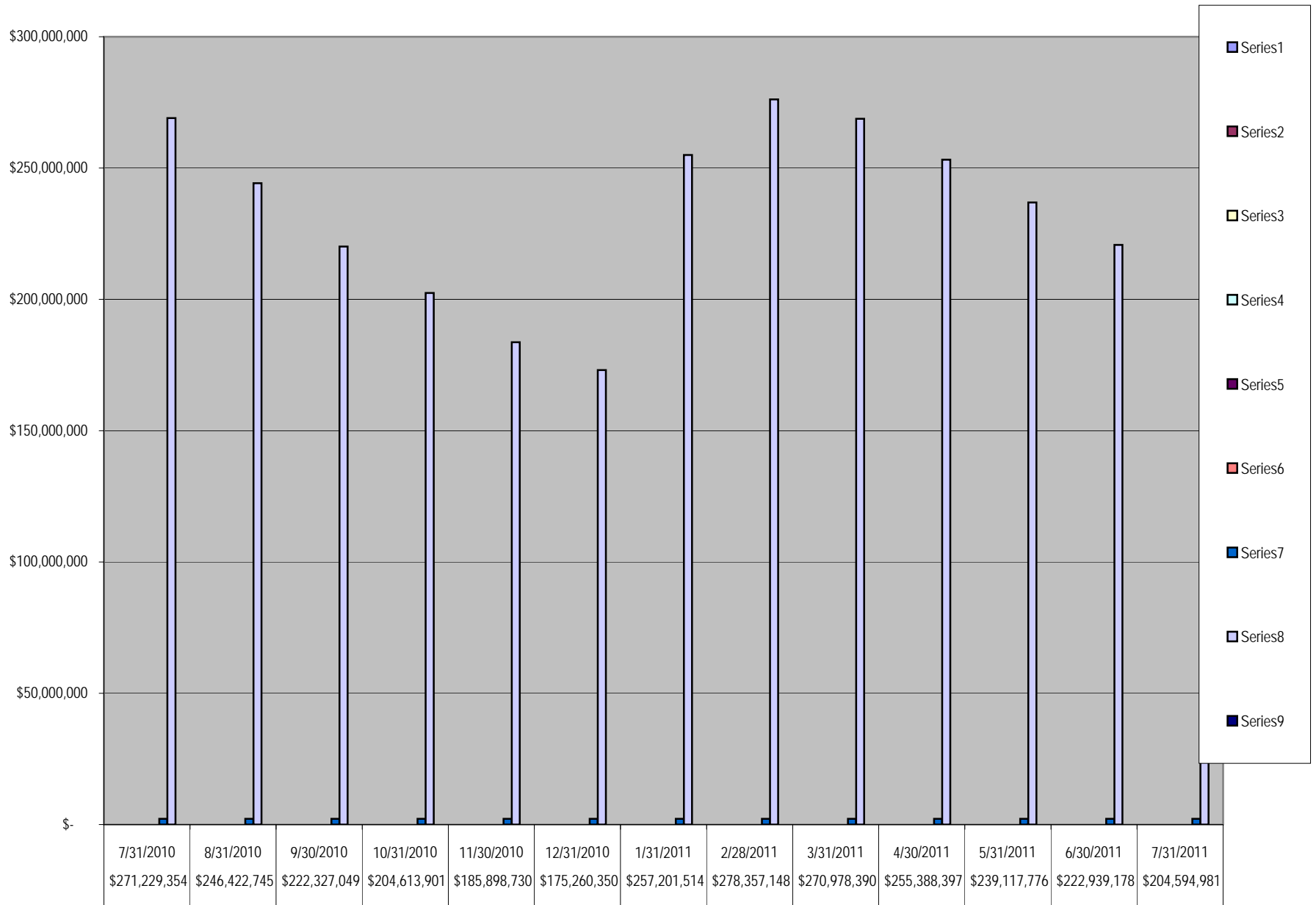

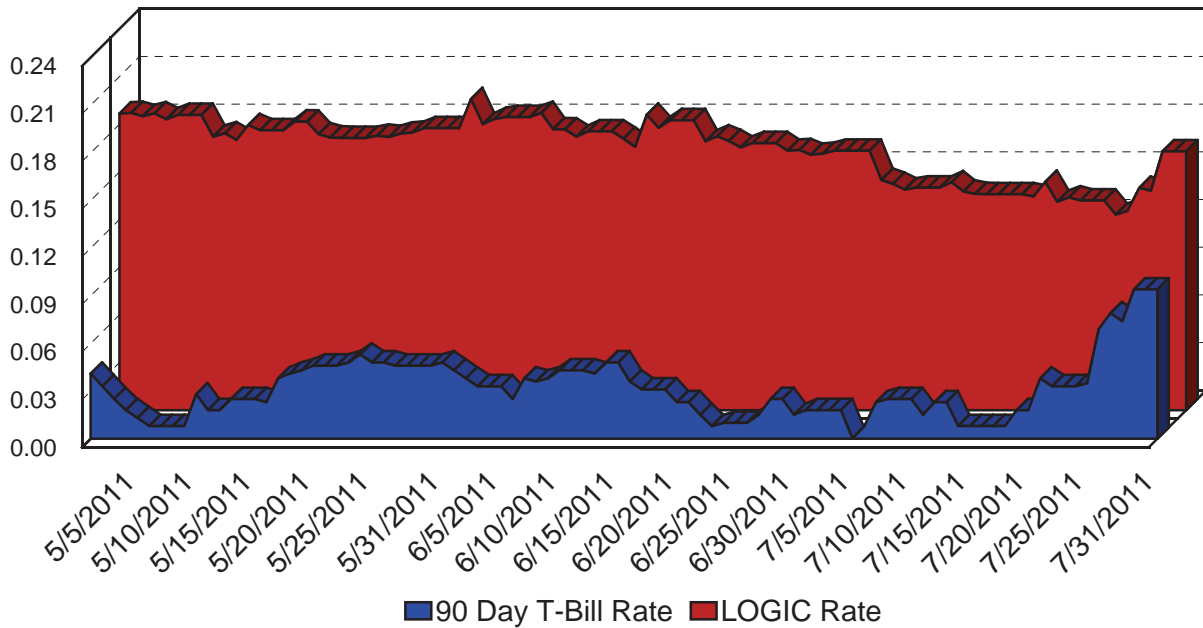
