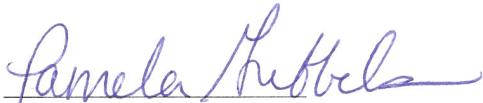

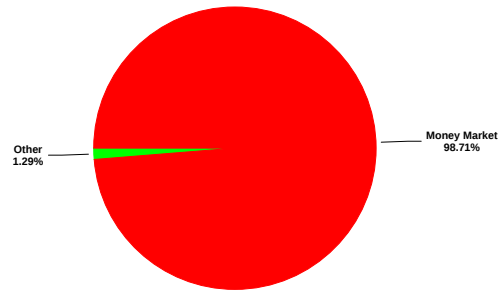

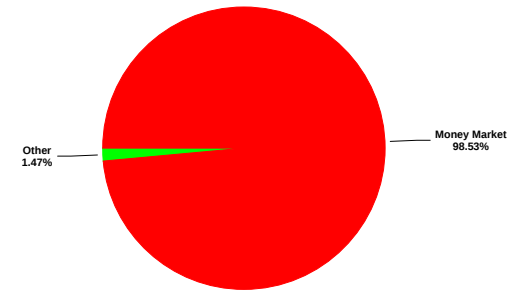

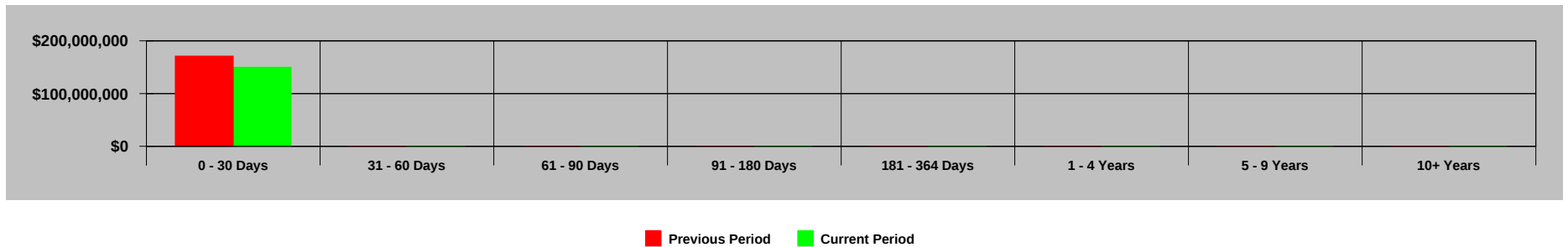
Portfolio Composition - 08/31/11



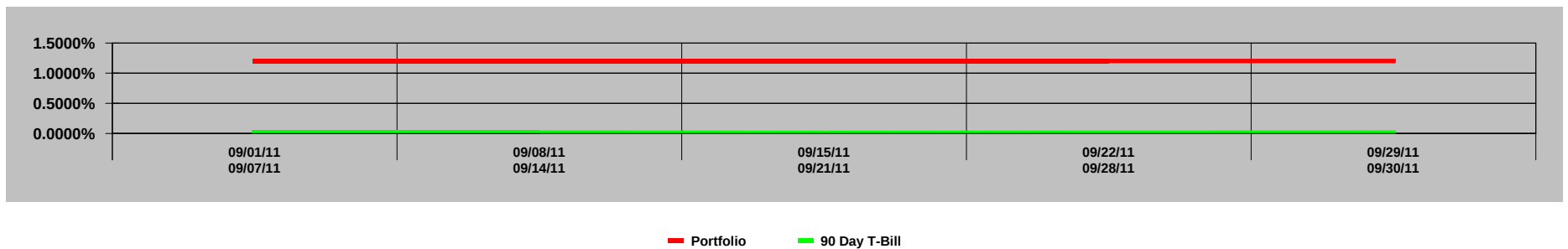
Portfolio Composition - 09/30/11

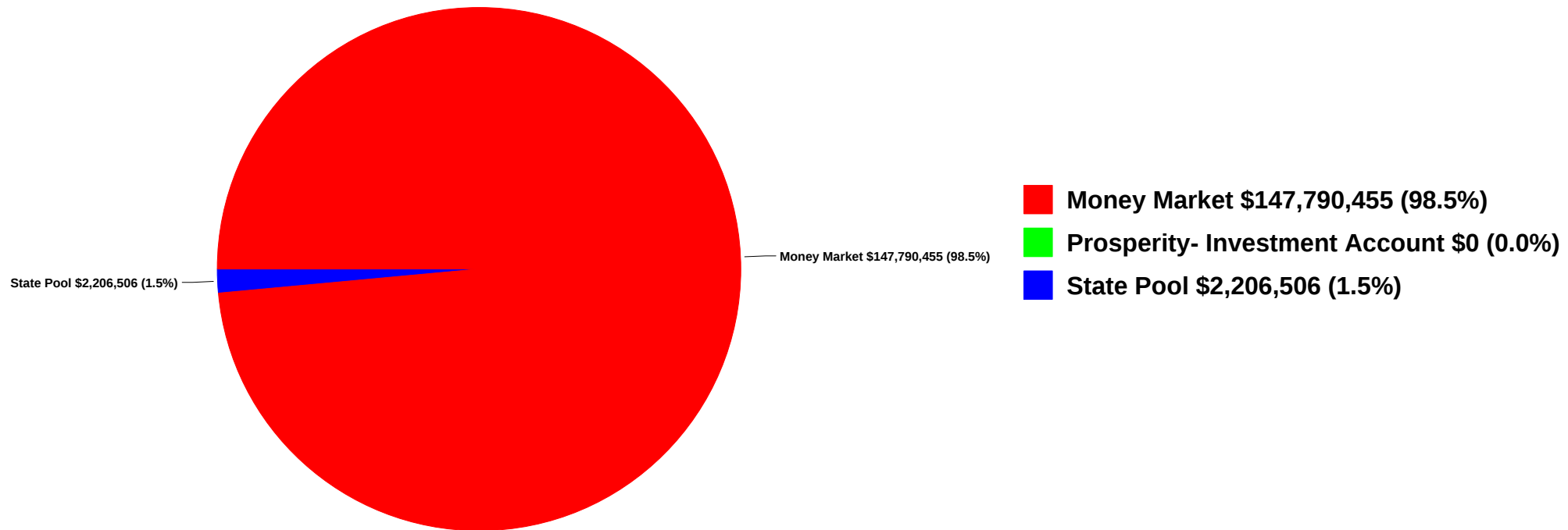

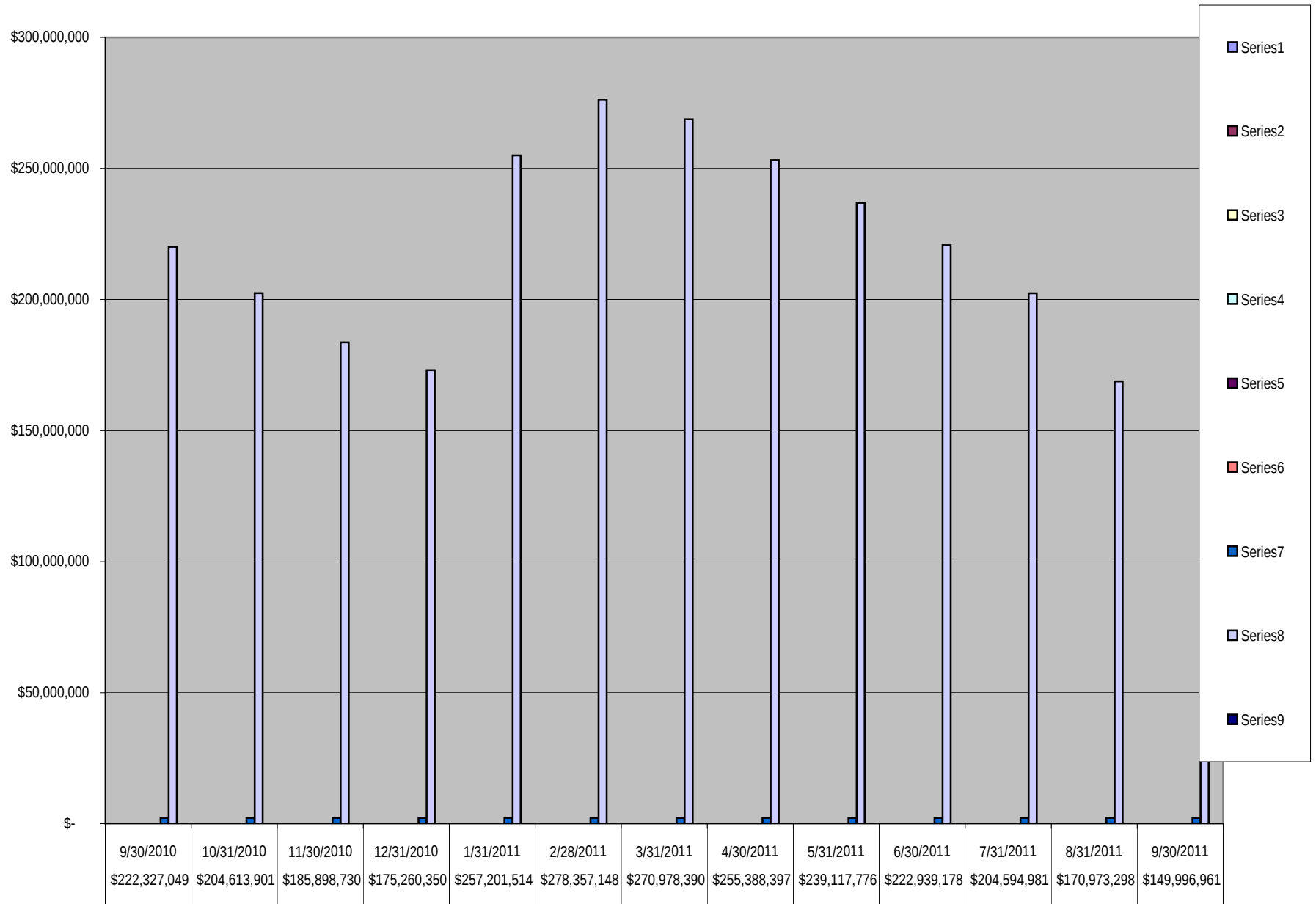

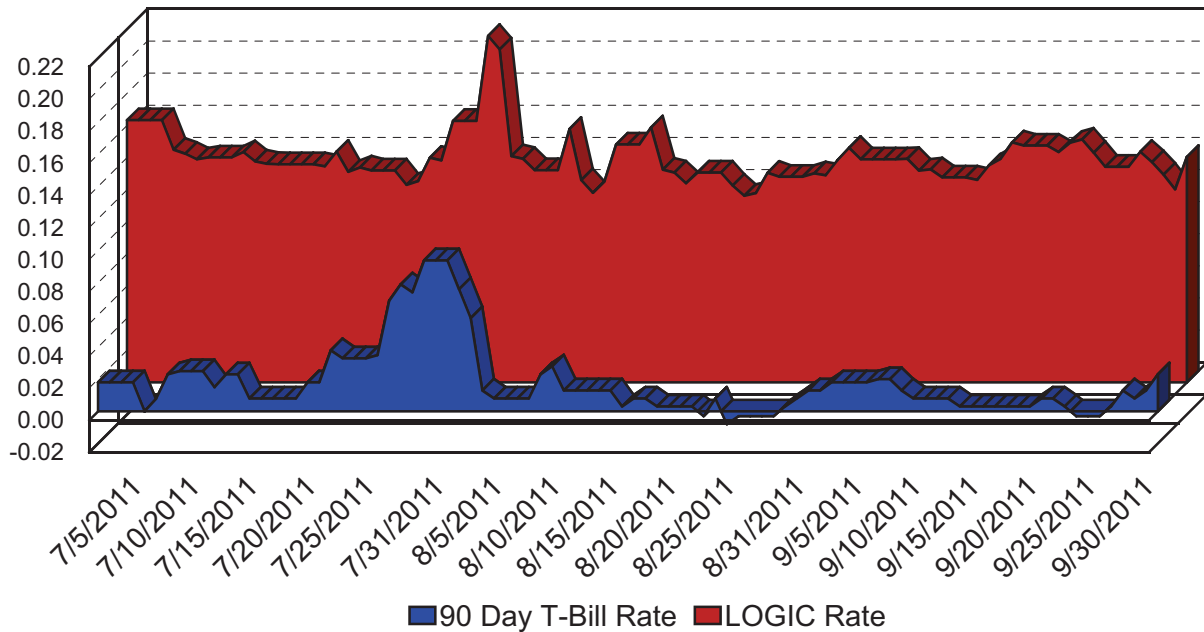
