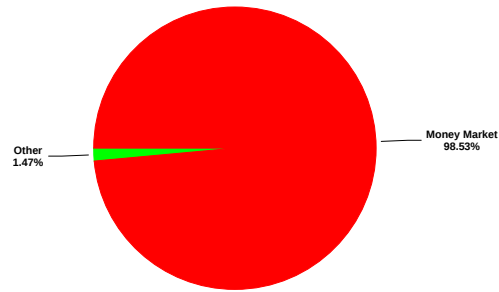

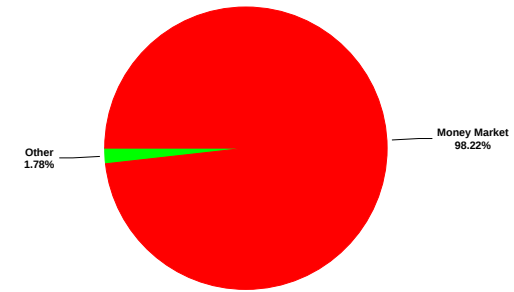

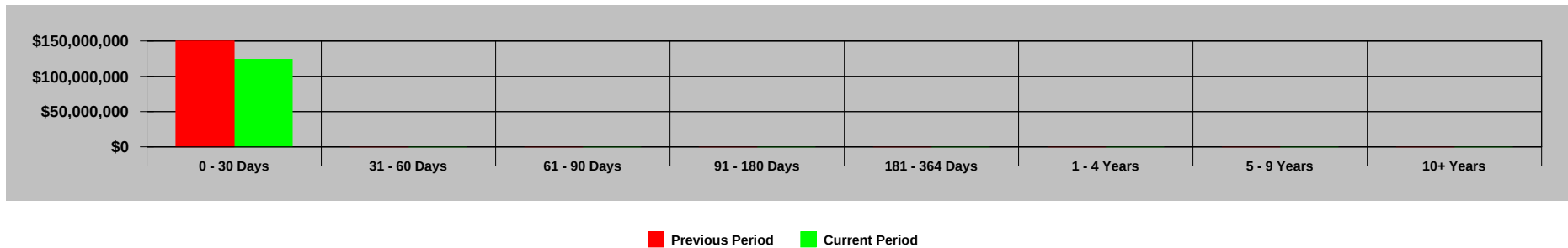
Portfolio Composition - 09/30/11



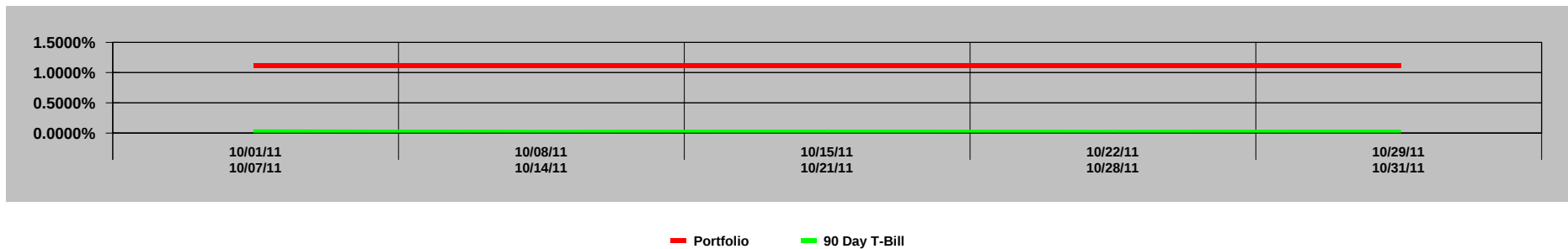
Portfolio Composition - 10/31/11

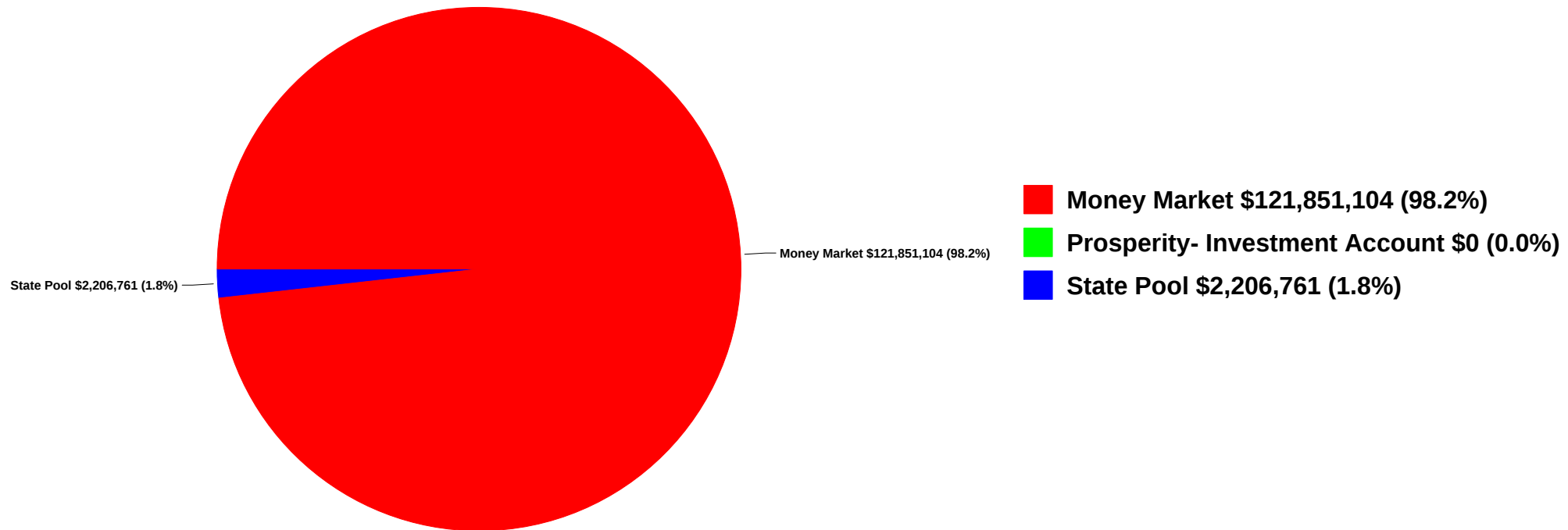

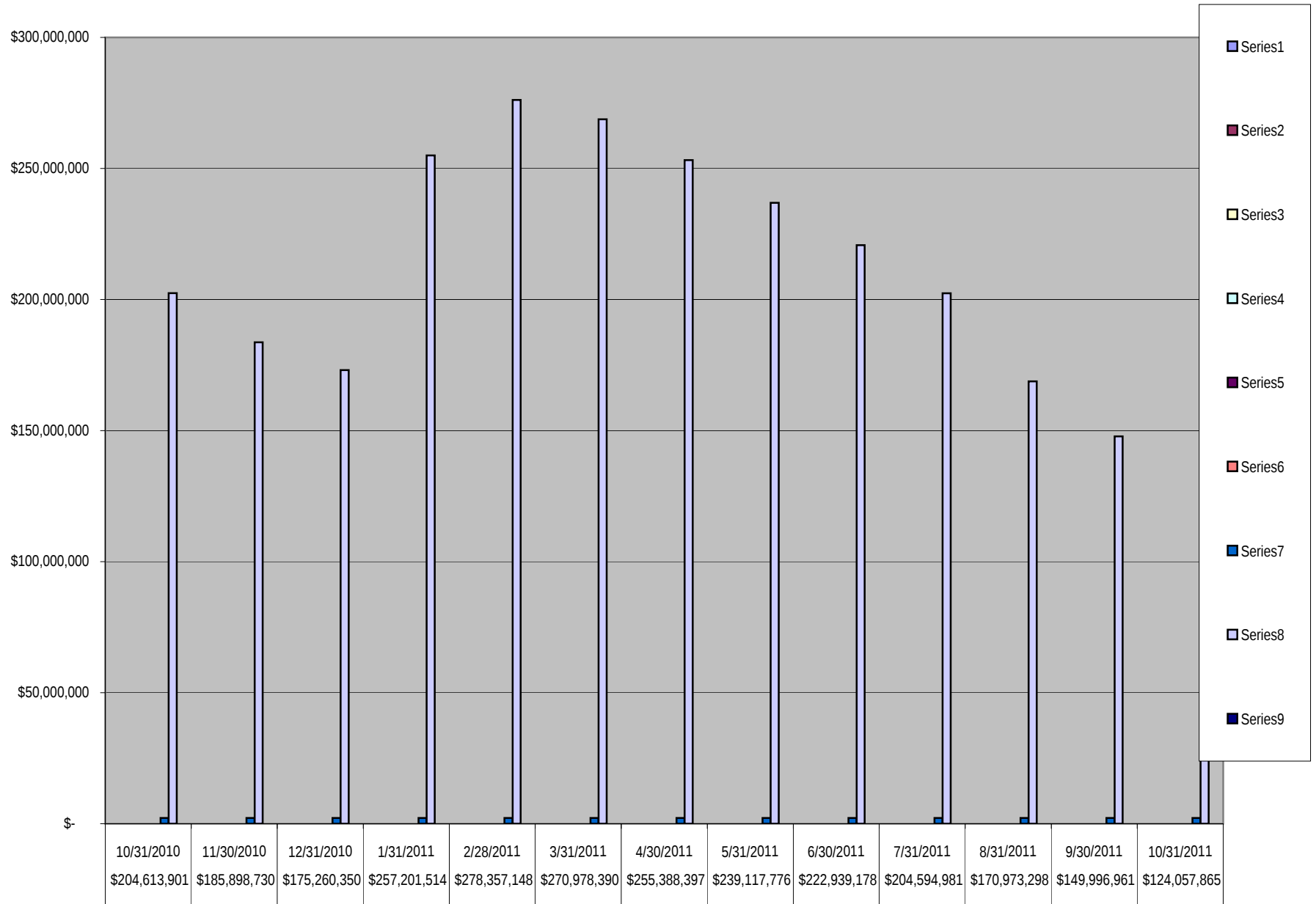

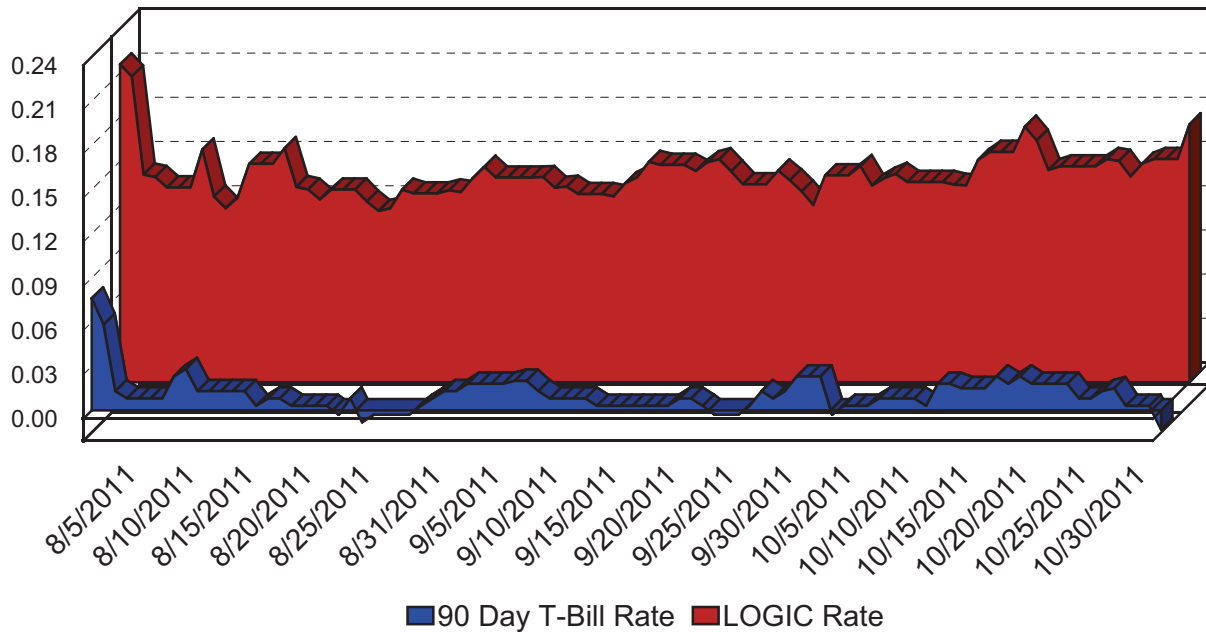
