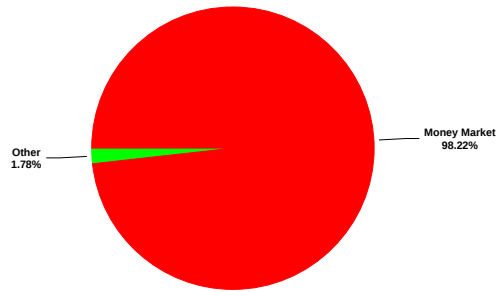

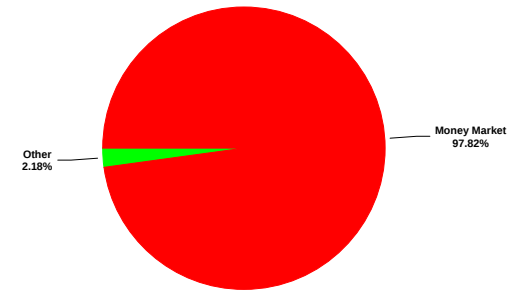

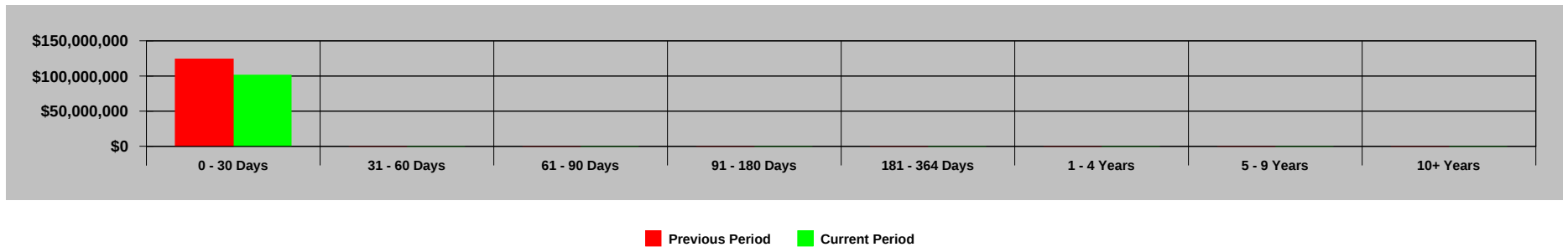
Portfolio Composition - 10/31/11



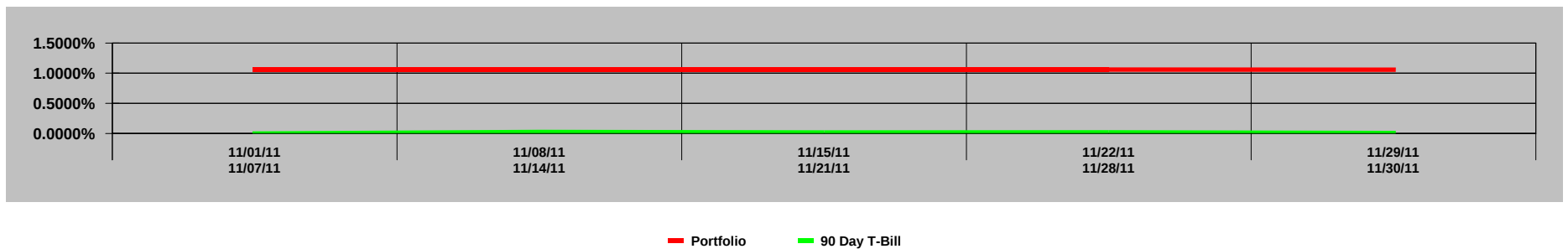
Portfolio Composition - 11/30/11

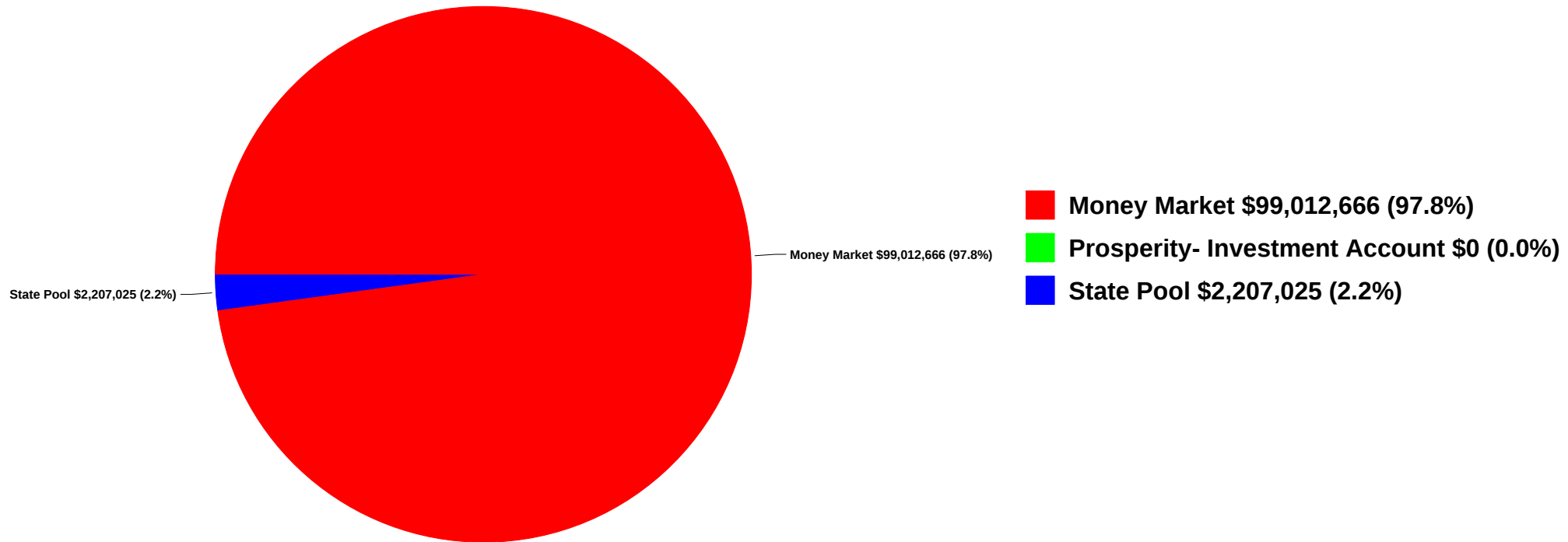

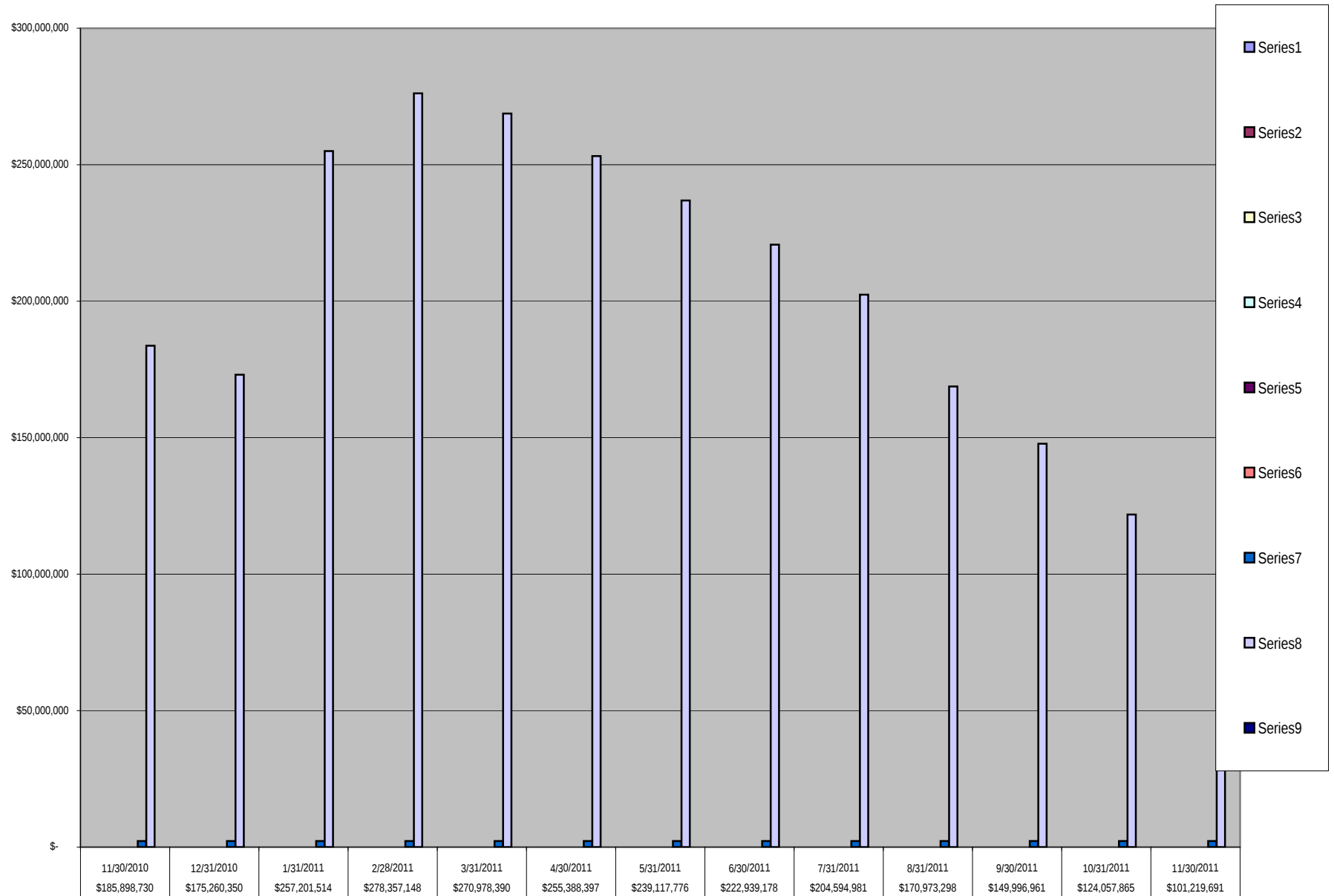

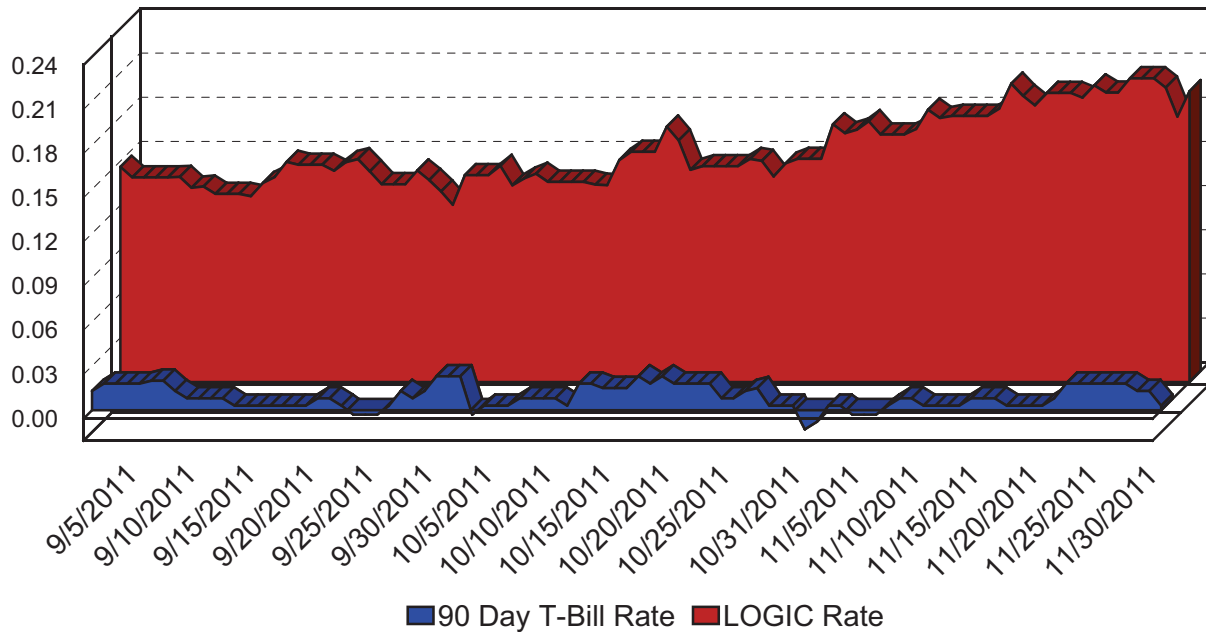
