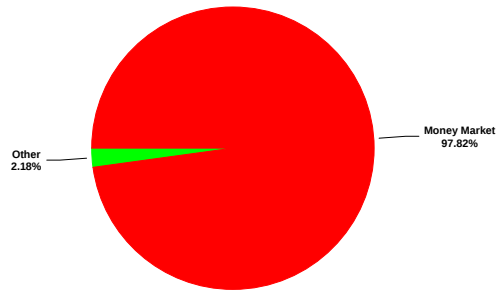

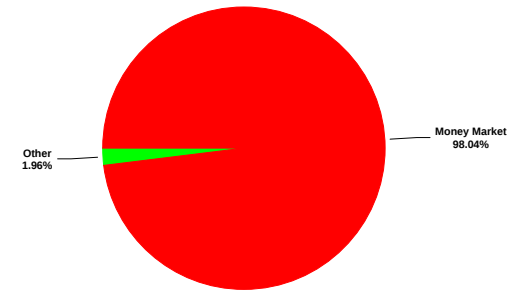

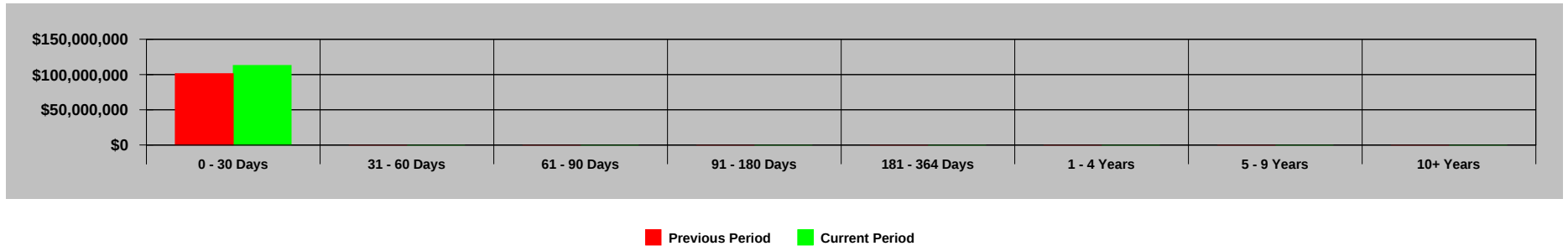
Portfolio Composition - 11/30/11



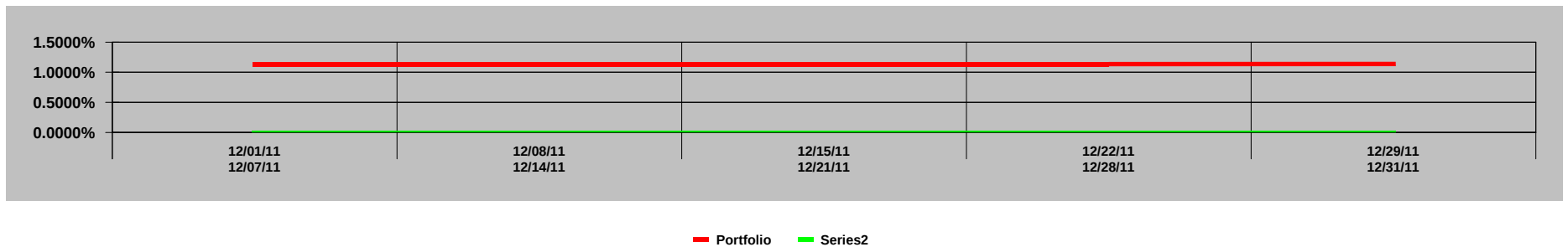
Portfolio Composition - 12/31/11

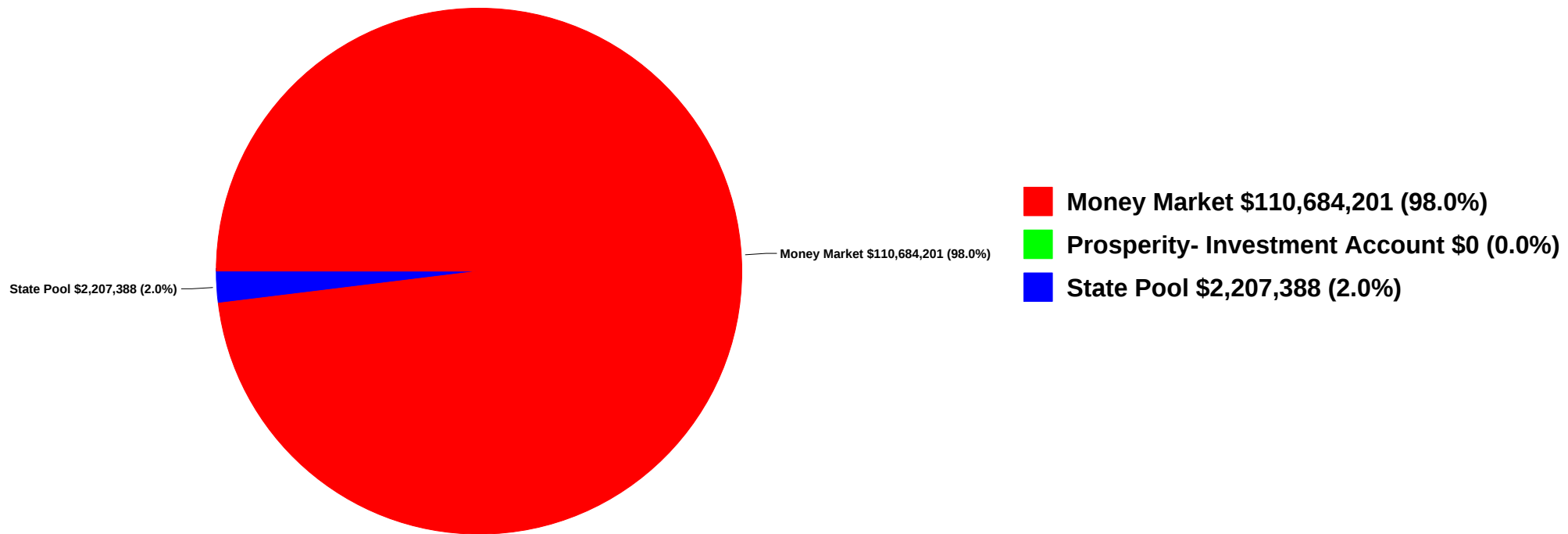

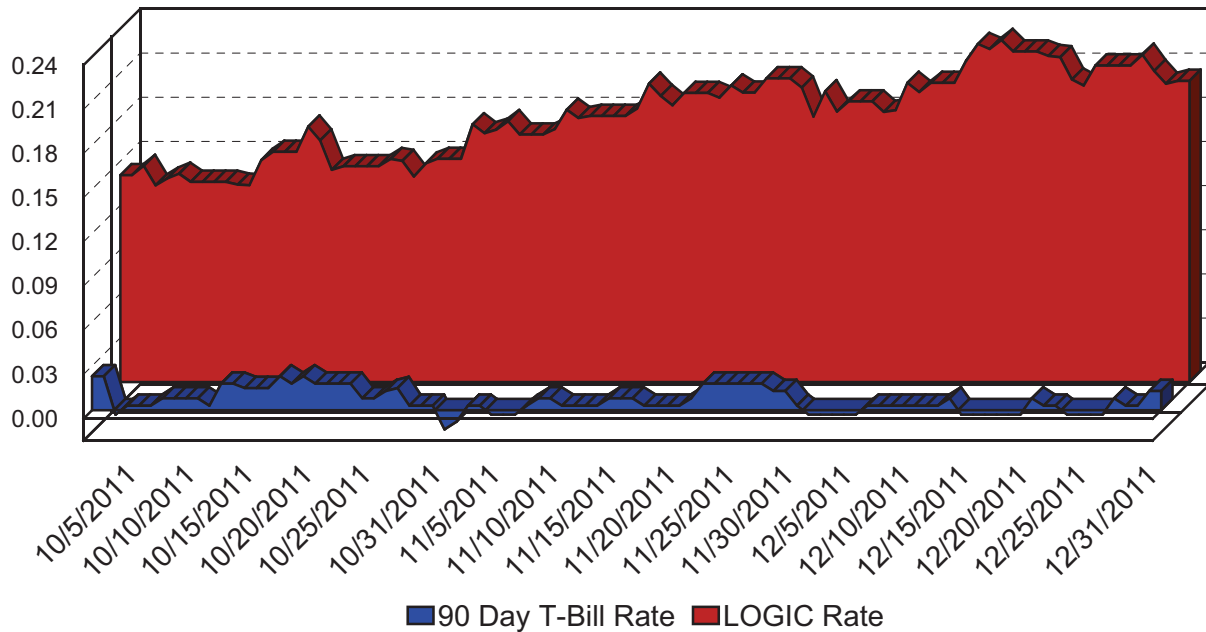
