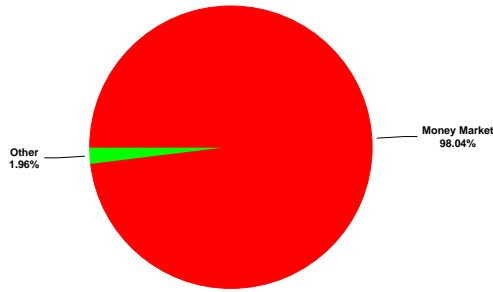

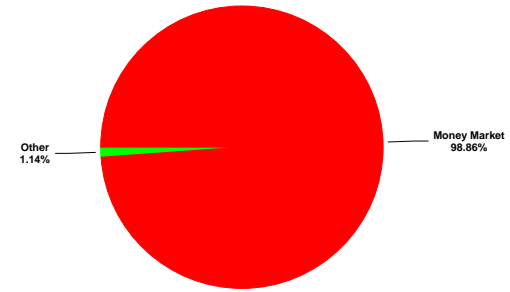

Portfolio Composition - 01/31/12

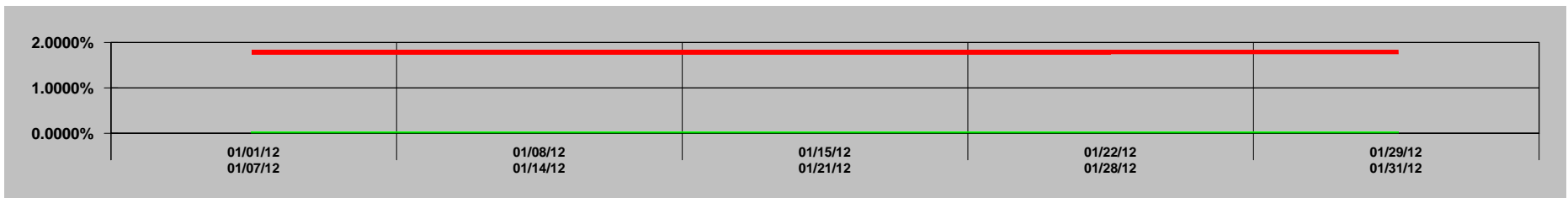


Maturity Aging - 12/31/11 vs 01/31/12

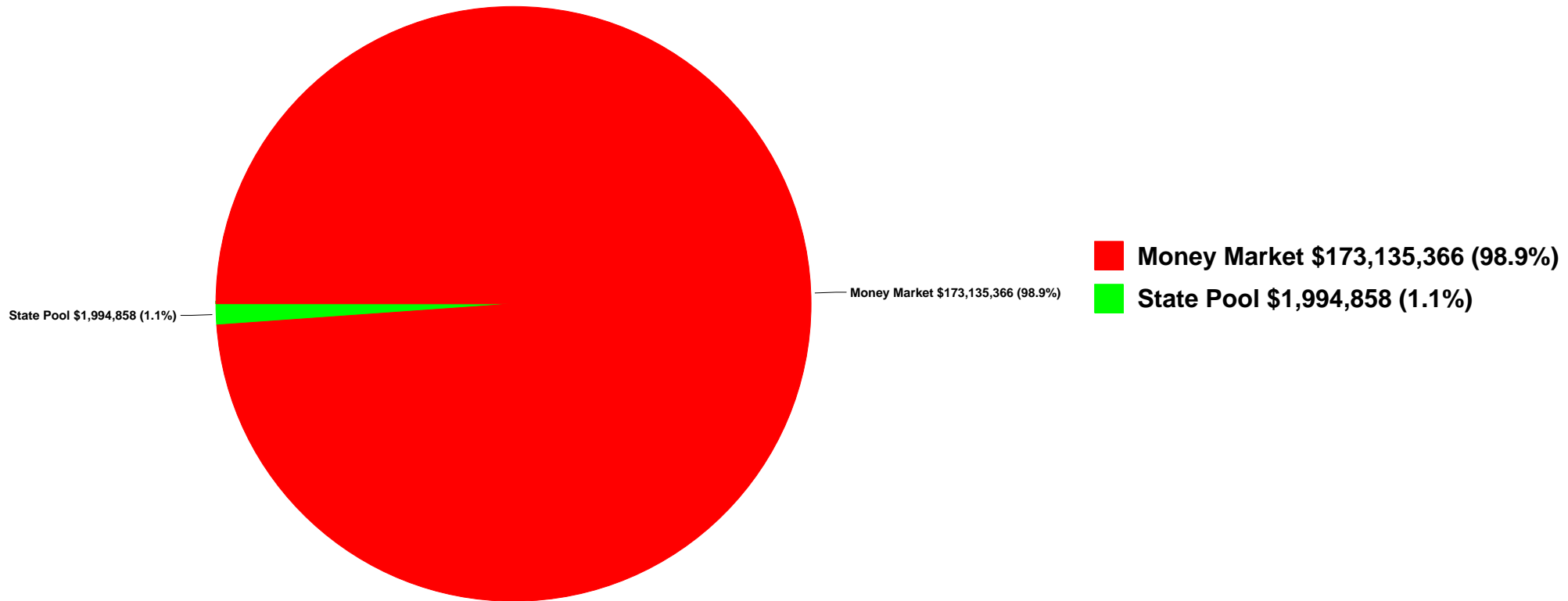

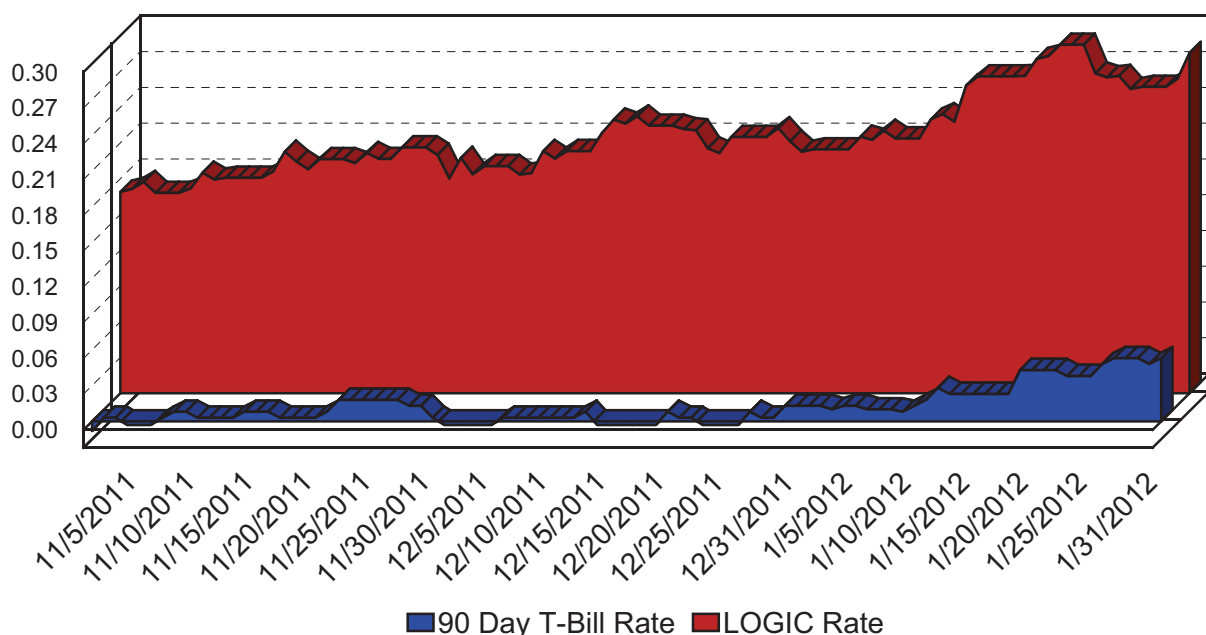
