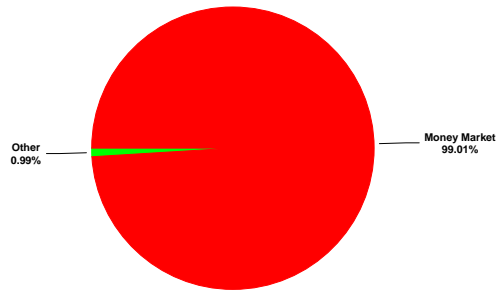

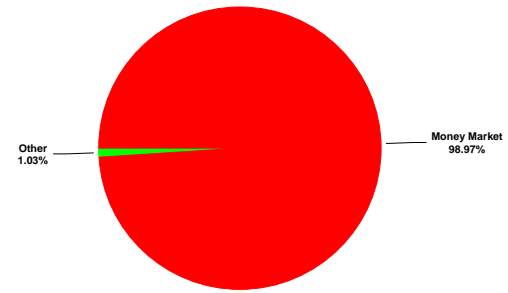

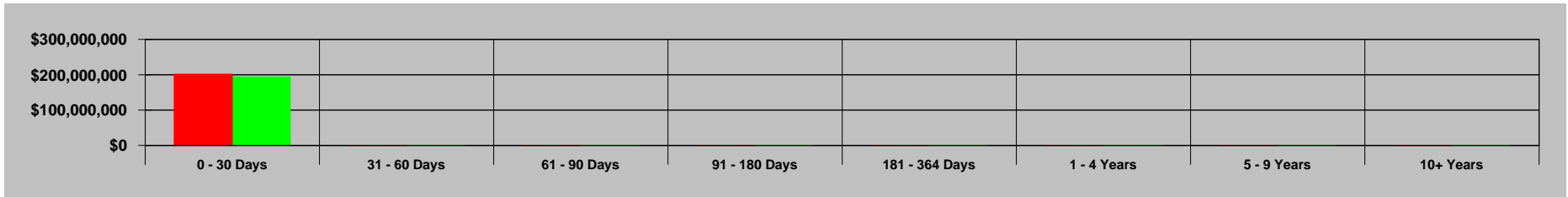
Portfolio Composition - 02/29/12



Portfolio Composition - 03/31/12

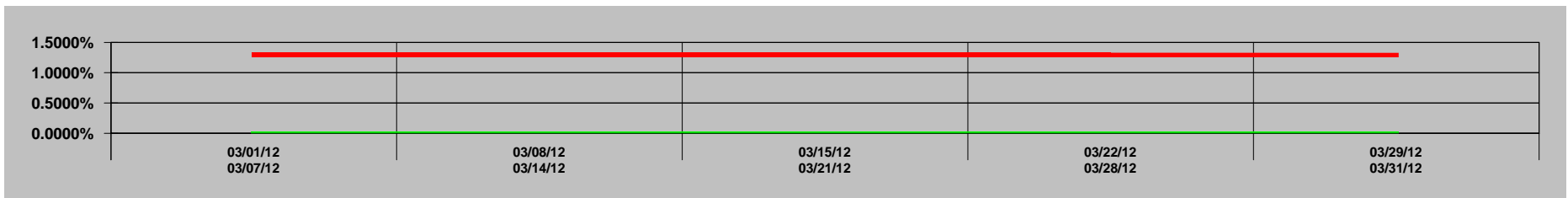


Maturity Aging - 02/29/12 vs 03/31/12

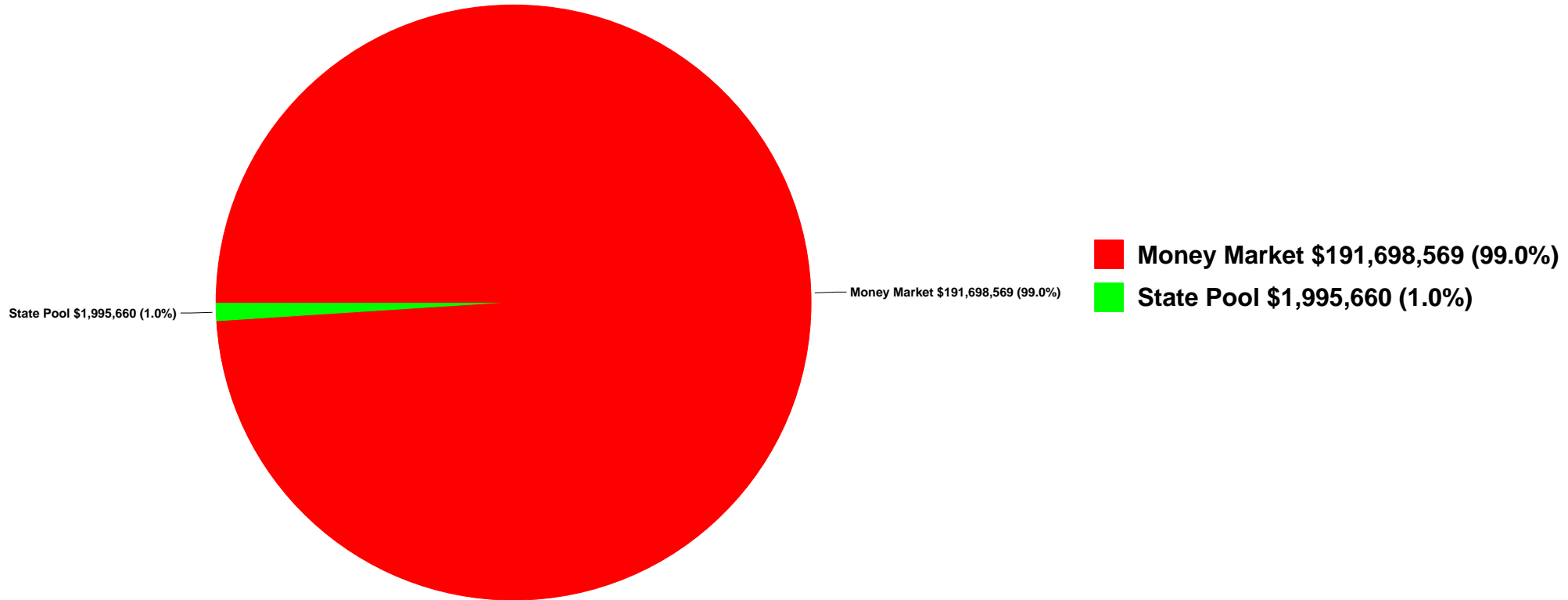

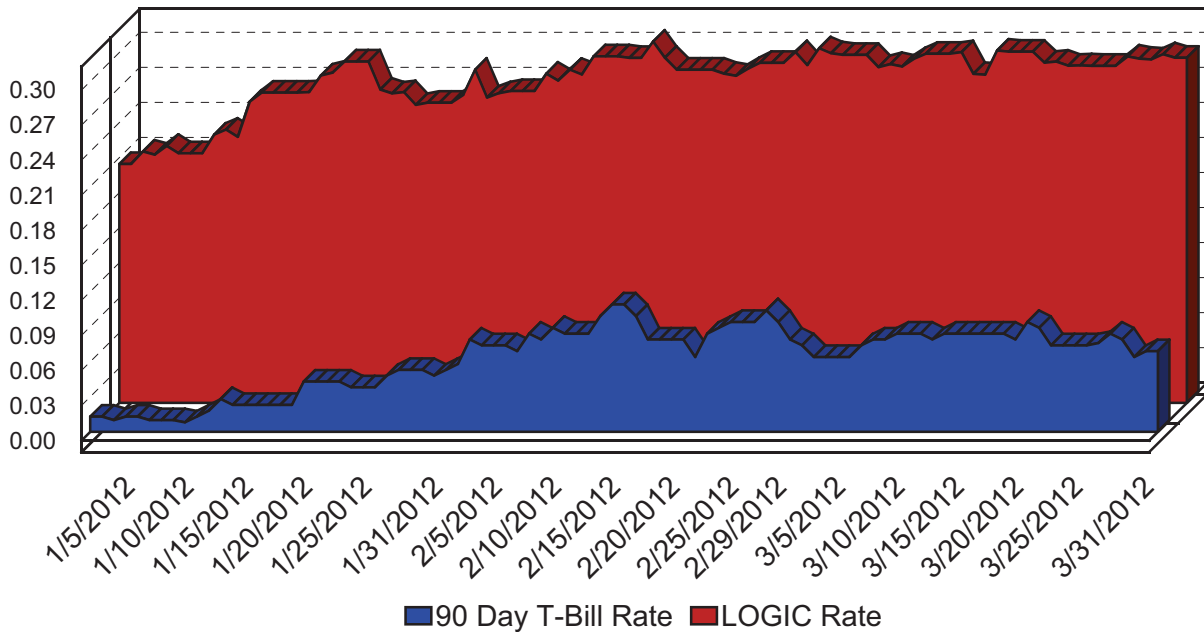
