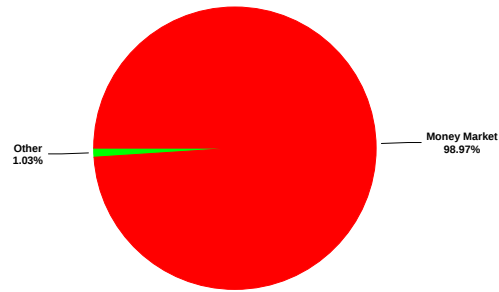

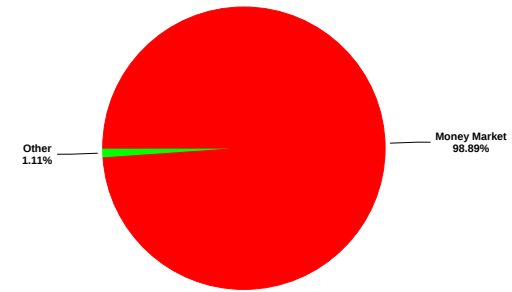

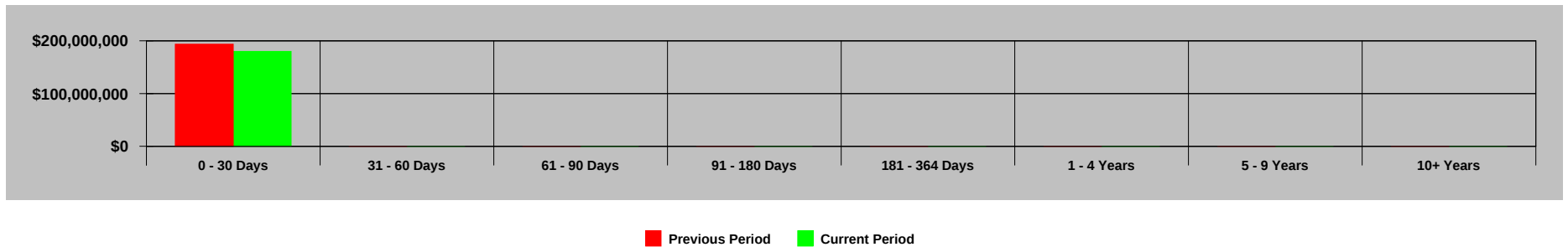
Portfolio Composition - 03/31/12



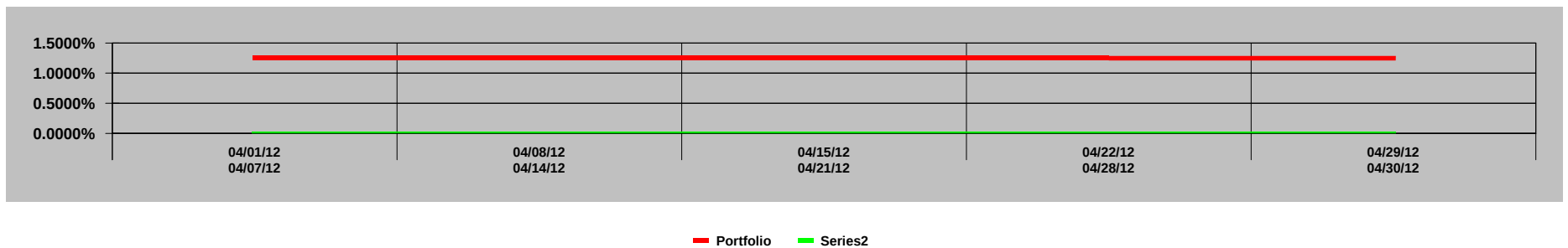
Portfolio Composition - 04/30/12

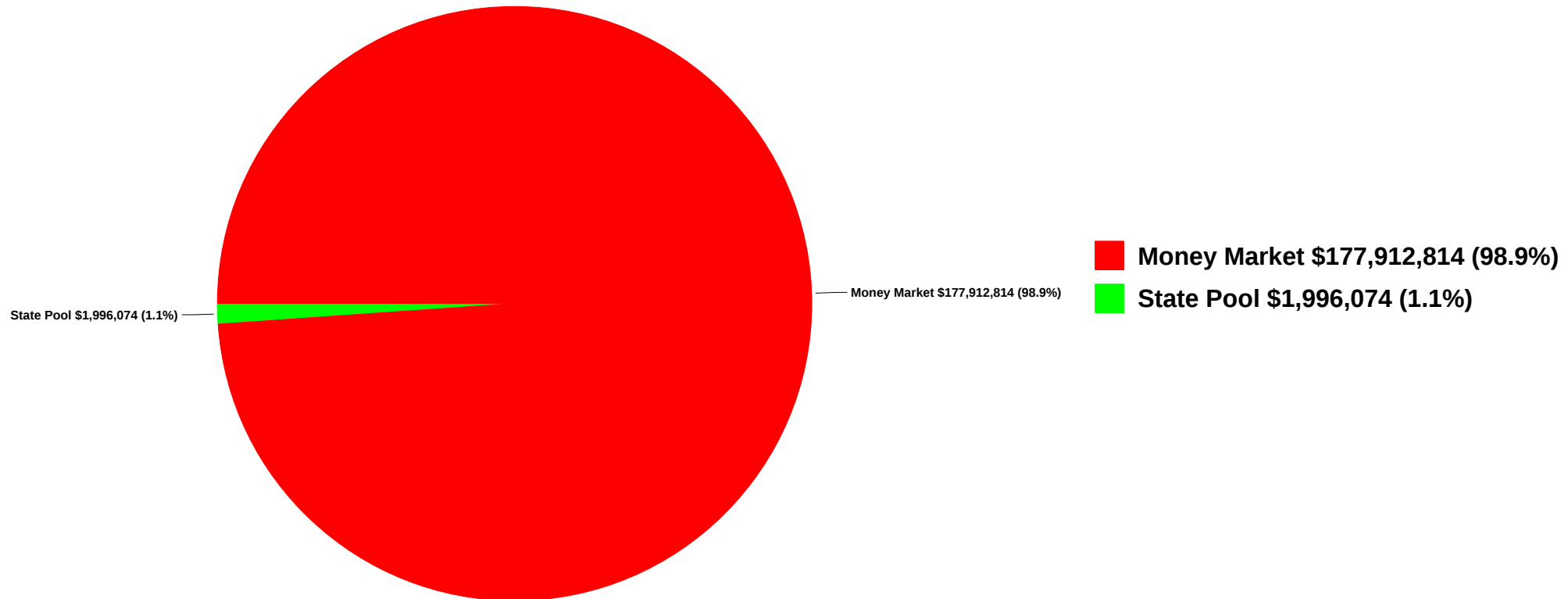

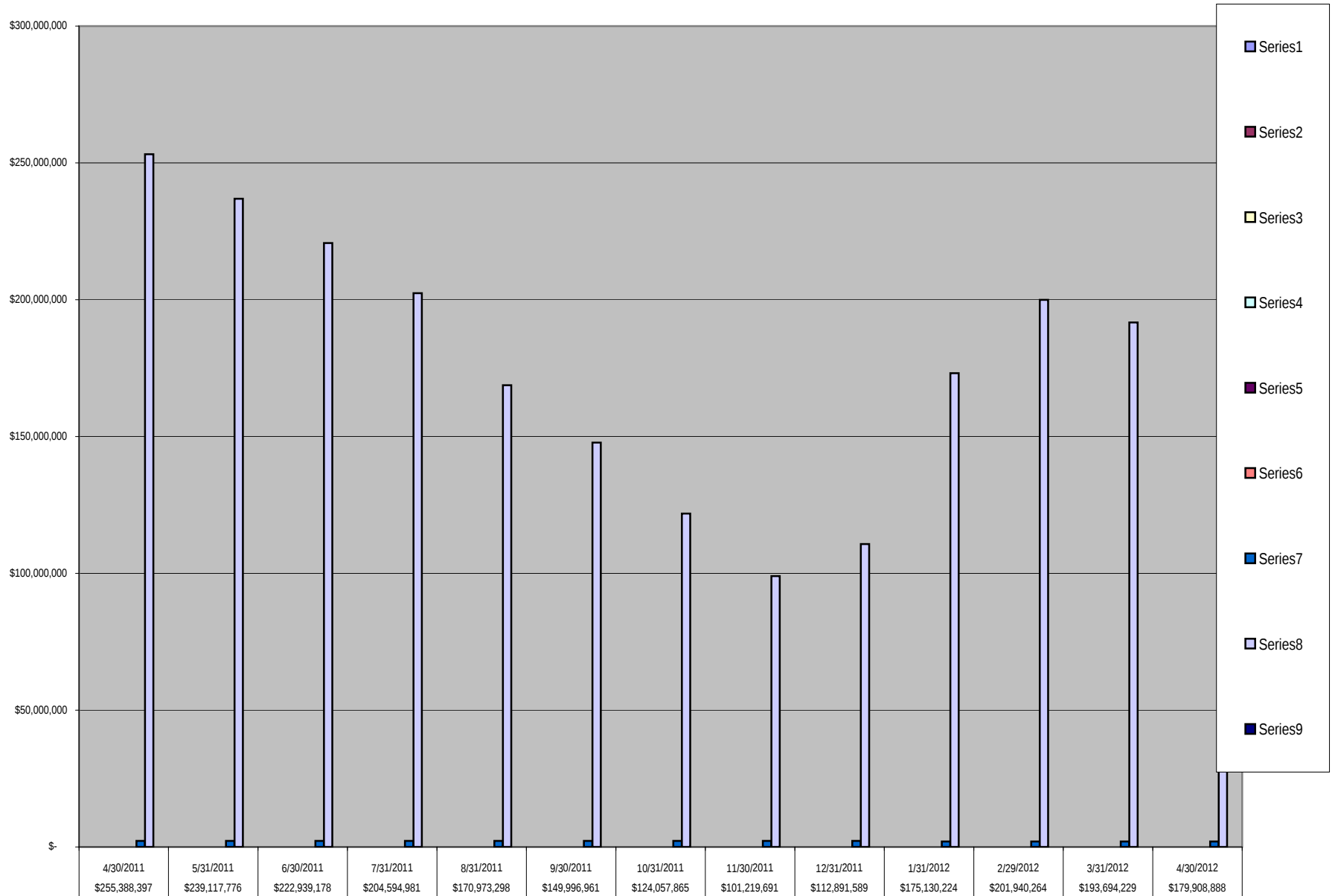

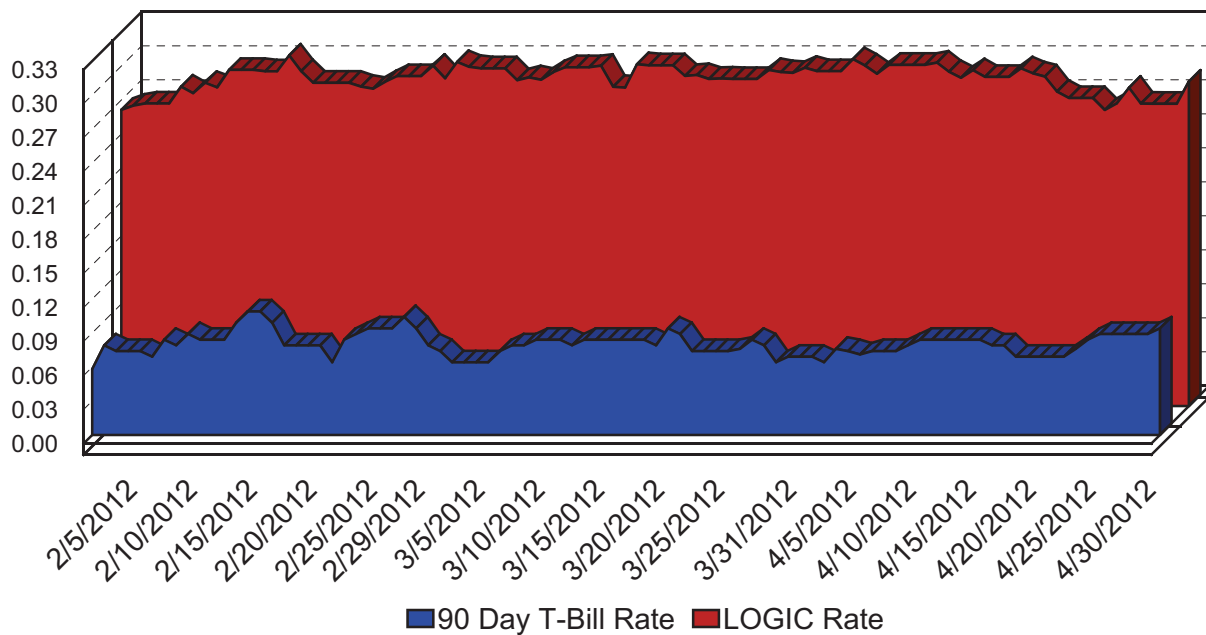
