

THENCE South 61 degrees 36 minutes 27 seconds East continuing along said line, 170.09 feet to a ½ inch iron pipe with cap marked "Kalkomey Surveying" set for the east corner of the herein described tract, same being the north corner of an adjoining 10.149 acre tract (Tract 1) surveyed by the undersigned this date;

THENCE South 44 degrees 16 minutes 15 seconds West establishing the southeast line of the herein described tract, same being the northwest line said adjoining Tract 1, at 1,004.12 feet pass a ½ inch iron pipe with cap marked "Kalkomey Surveying" set on said line at its intersection with the northeast right-of-way line of Thuesen Road, and continuing for a total distance of 1,034.12 feet to a cotton picker spindle set for the south corner of the herein described tract, same being the west corner of said adjoining Tract 1 and being in the southwest line of said E.
