

**SUPPLEMENTAL AGREEMENT NO. 1
TO
AGREEMENT OF MAY 16, 2012
FOR
ENGINEERING SERVICES for
Fort Bend Parkway Toll Road, Segment B**

This Supplemental Agreement is made and entered into this 28th day of November, 2012, and modifies the ENGINEERING SERVICES AGREEMENT made with HR Green, Inc. dated May 16, 2012 for engineering services for the Fort Bend Parkway Toll Road, Segment B.

The agreement is hereby modified as follows:

1. The first sentence of Section 2.a is replaced with the following sentence:

“The Maximum Compensation under this contract is \$636,016.00.”

2. The second paragraph of Section 2.a is replaced with the following paragraph:

“Compensation for performance of services within the Scope of Services described in Attachment A shall be in accordance with the billing rates shown in Attachment B. The compensation shall be increased by \$250,000, for the work shown in Attachment A. The maximum amount payable under this agreement shall not exceed \$636,016.00.”


3. The Compensation for Scope of Services shown in Attachment B shall be expanded to include Exhibit B-1, attached hereto.





**EXHIBIT B-1
ATTACHMENT B
COMPENSATION FOR SCOPE OF SERVICES**

FORT BEND PARKWAY TOLL ROAD: SEGMENT B

This is a unit price contract. The Contractor will be paid at the rate described below only for services actually requested and satisfactorily provided to the Authority. The Engineer must approve each employee's labor classification and rate prior to start of work. The total amount to be paid for services rendered under this contract shall not exceed the amount shown in the supplemental agreement.

<u>Labor Classification</u>	<u>Loaded Pay Rates</u>
Project Manager	\$200.00 Per Hour
Inspector I	\$89.00 Per Hour
Inspector II	\$96.00-\$98.00 Per Hour
Inspector III	\$105.00-\$115.00 Per Hour
Inspector IV	\$120.00-\$125.00 Per Hour
Clerical	\$66.00 Per Hour

Notes:

Rates are inclusive of all normal vehicle expenses, cell phones, laptops, and other misc. equipment normally required and associated with performing inspection services.

Vehicle must be a truck, SUV or other approved vehicle that can transverse through construction projects.

The following shall be provided to the employees and are considered incidental (indirect expenses) and will not be paid for directly:

- A) Contractor shall provide a camera with the ability to download and email photos of the project site.
- B) Contractor shall provide laptop computer with wireless internet capability.
- C) Contractor shall provide all necessary safety equipment, including but not limited to hard hat, safety vest, harnesses, and safety shoes/boots.
- D) Contractor shall provide copies of the TxDOT Standard Specifications for Construction and Maintenance of Highways, Streets, and Bridges.

Direct Costs ("ODCs") – Shall mean authorized expenditures incurred by Contractor and specifically related to the Contract and the Services.

- A) Reproduction Costs for plans and bid book – approved invoice amount +10%
- B) Other expenses as approved
