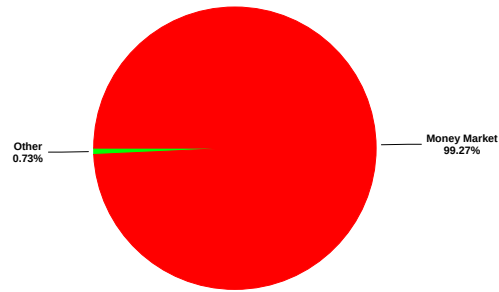

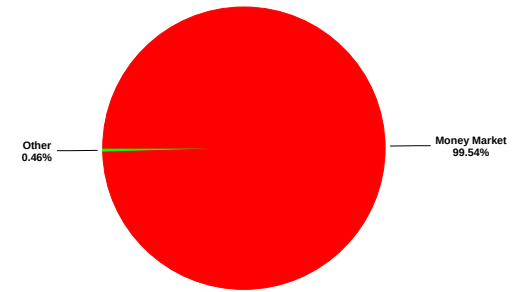

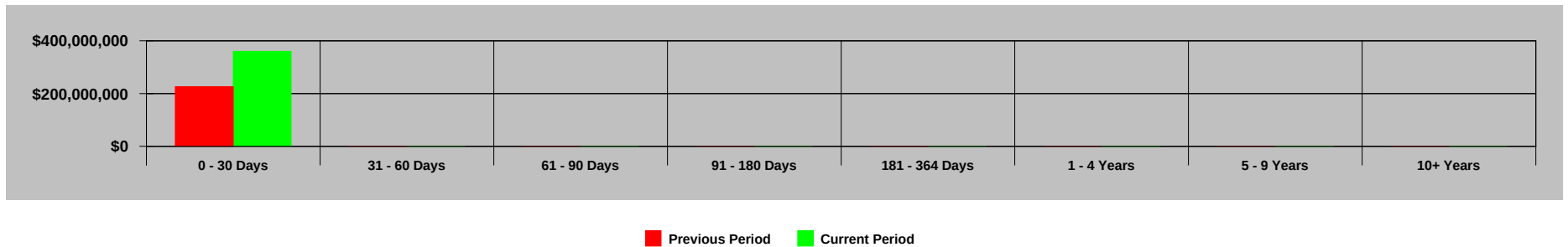
Portfolio Composition - 07/31/12



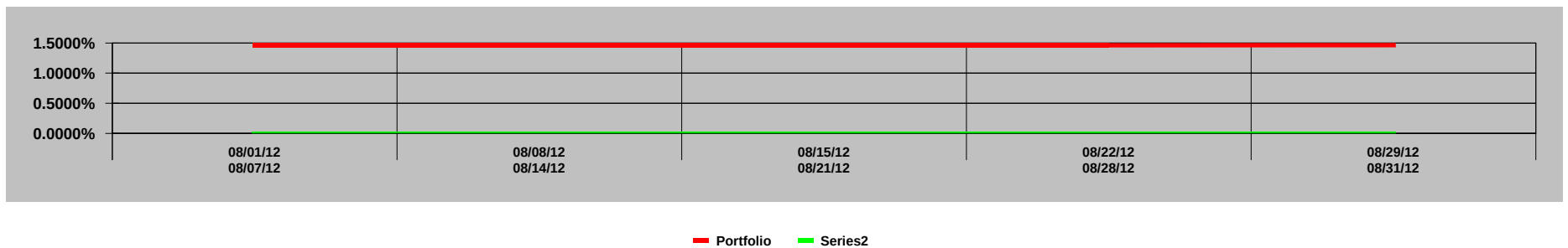
Portfolio Composition - 08/31/12

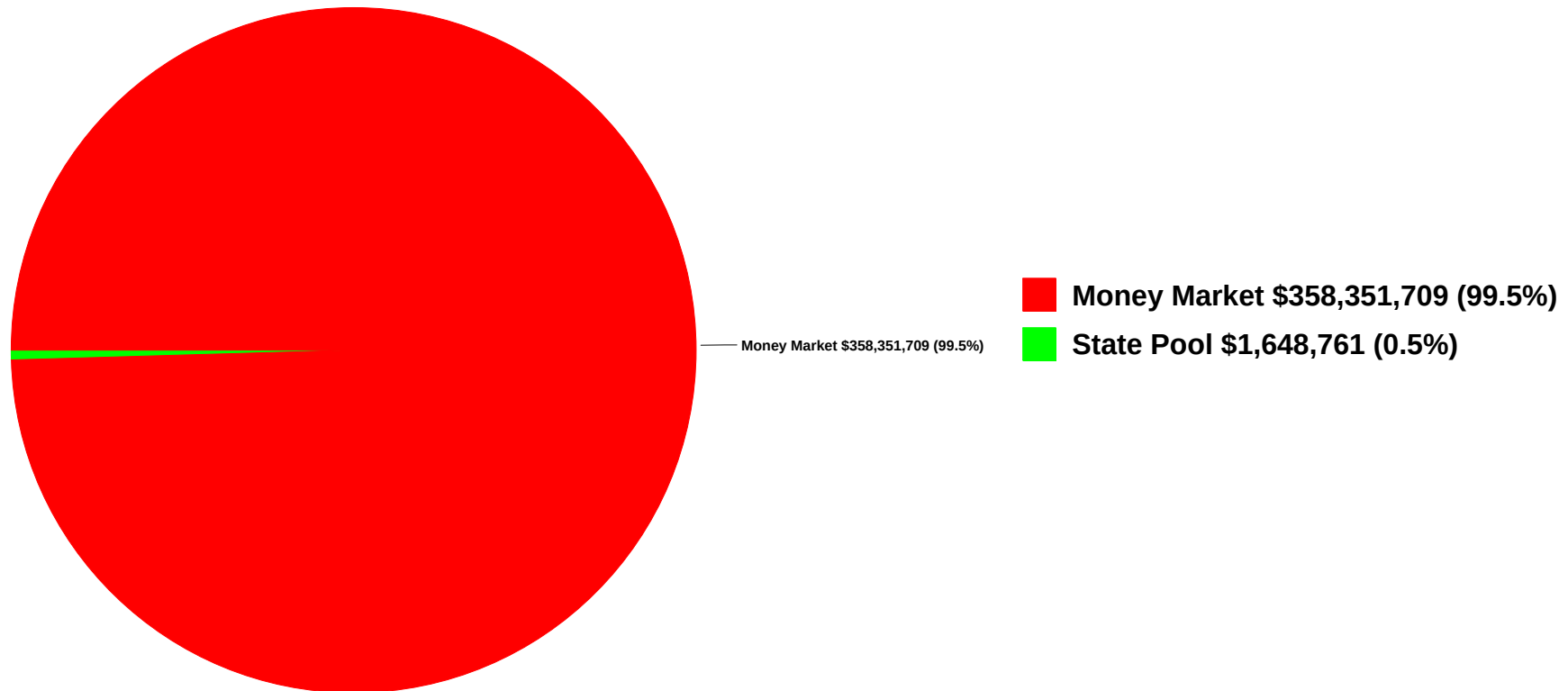

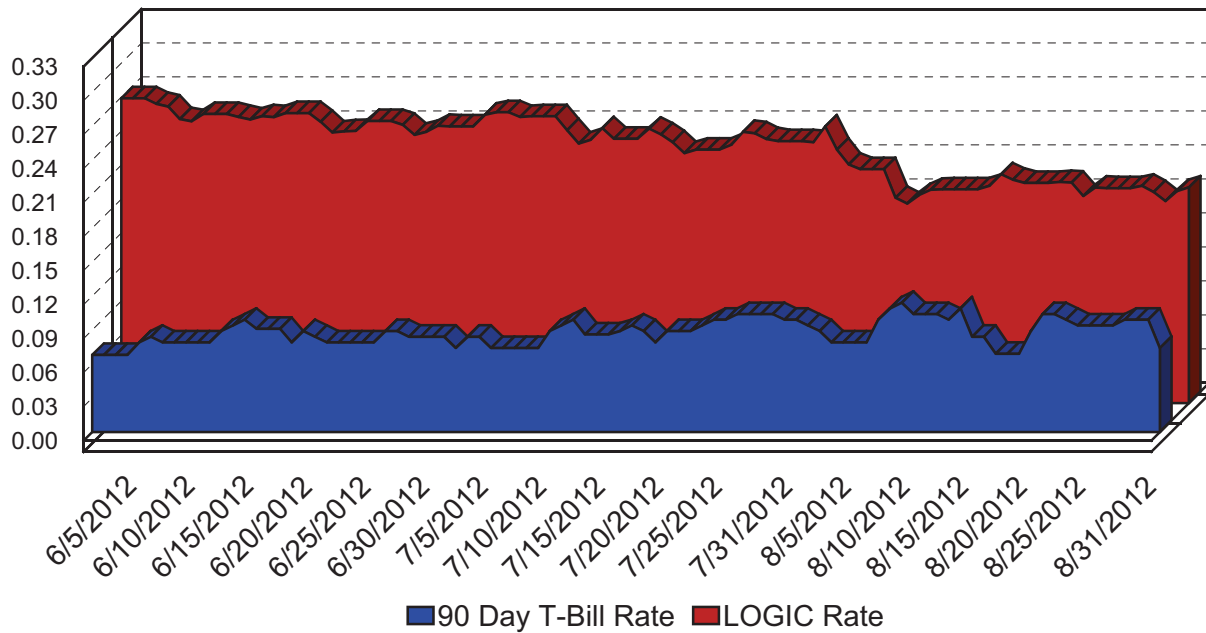
