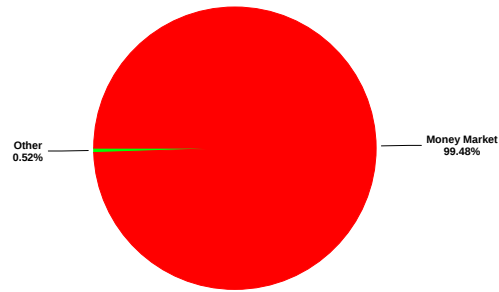

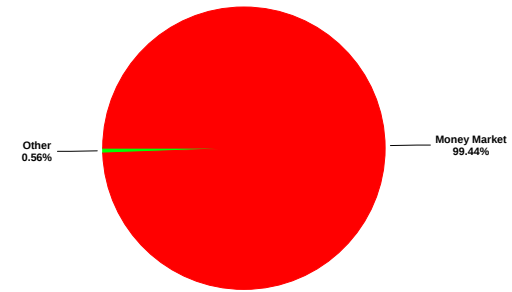

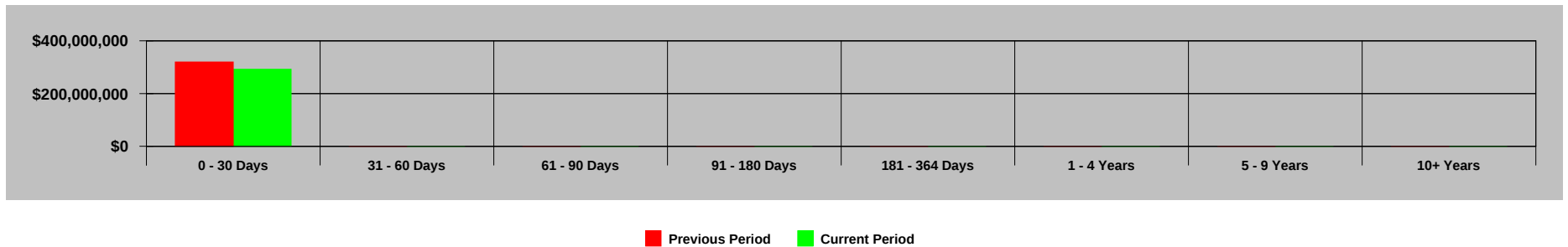
Portfolio Composition - 10/31/12



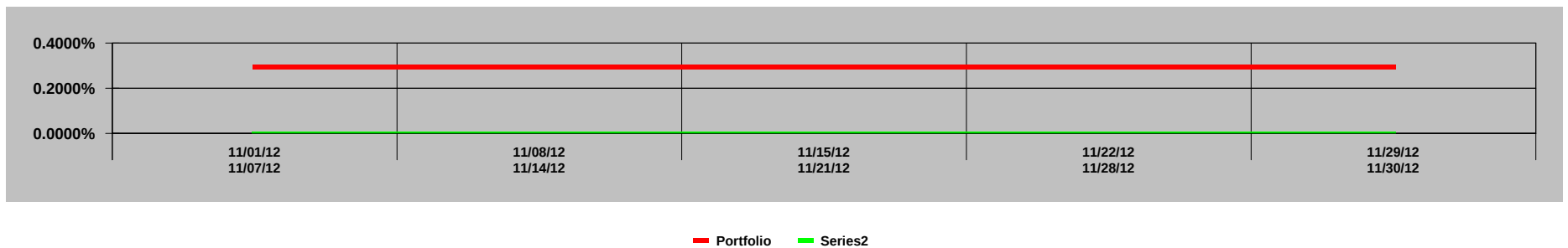
Portfolio Composition - 11/30/12

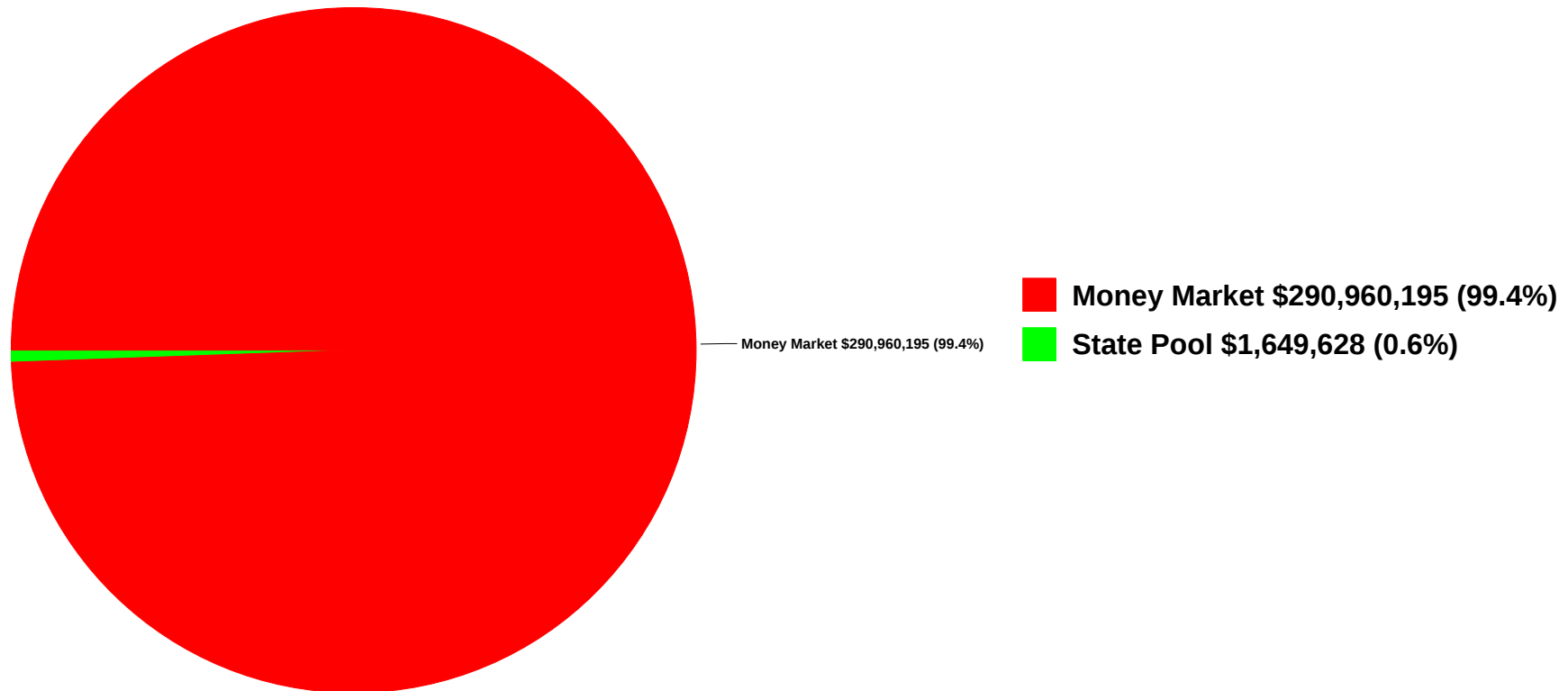

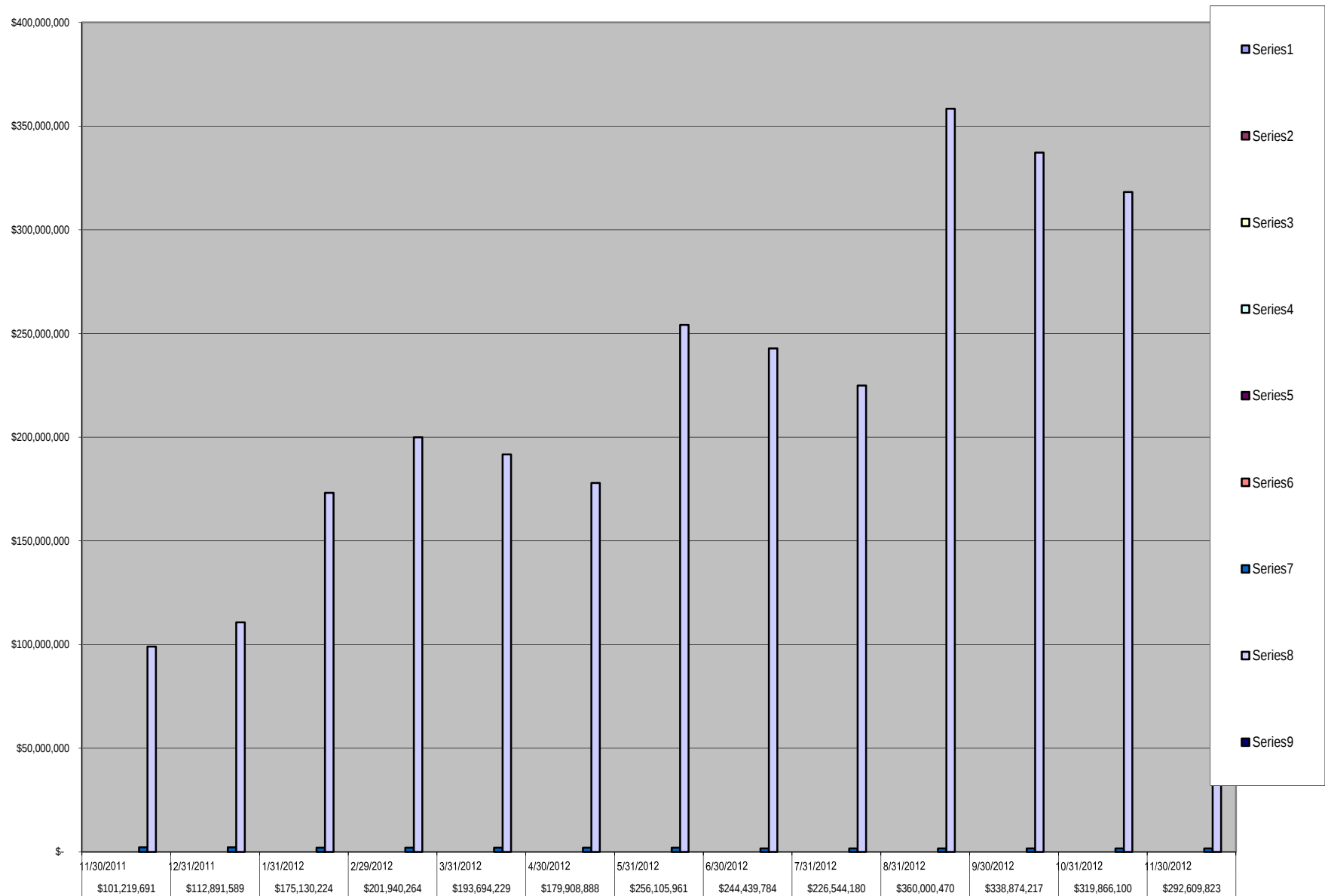

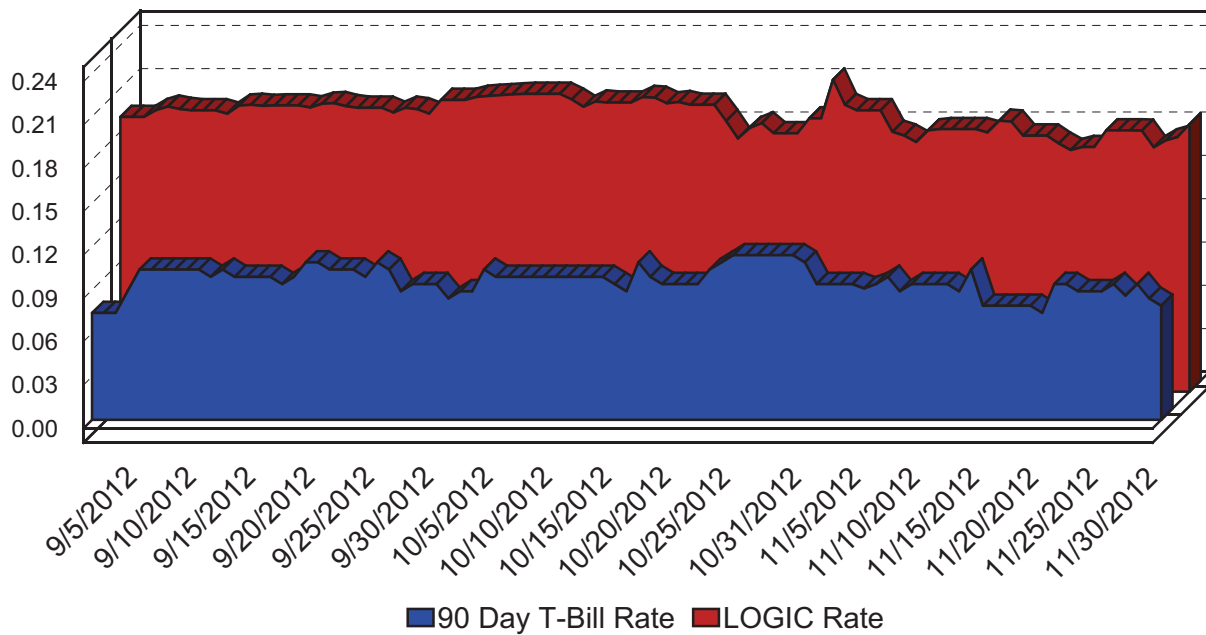
