Human Resources is submitting the attached reimbursement request for the March 12, 2013 agenda. On Tuesday March 5, 2013, Beatrice Galan, HR Generalist, Training, ordered and purchased food items from Subway Sandwiches for a Lunch and Learn training scheduled for that day. The purchase was pre-approved and was to be funded by the Special Funds Account.
