Zahara S. Hooda, is requesting waiver of penalty and interest for 2012 tax year because according to her online banking payment information her original payment sent on January 9, 2013, and to be delivered by January 16, 2013, was returned to her bank on February 11, 2013, and not cashed.

## Tax Office Records Indicate:

- 1. Original deed # 2011004538 recorded on January 12, 2011, with the owner listed as Zahara S. Hooda, 3415 Chandler Hollow Ln, Missouri City, Texas 77459.
- 2. November 16, 2012 2012 Original Statement was mailed to Hooda Zahara S, 3415 Chandler Hollow Ln, Missouri City, TX 77459-5089. According to Tax Office records 2012 Original Statement was not returned by Post Office.
- 3. January 16, 2013 Taxpayer called to see if 2012 payment had been received. Tax Clerk advised that it had not been received.

4. February 12, 2013 – Taxpayer called and told Tax Clerk that her payment was returned to her bank mid-January and wanted to know if we could waive P&I if she made another payment. Clerk informed her of Waiver Instructions. She verified our mailing address and said that coupon she had showed incorrect mailing address for us. Tax Clerk asked her to fax copy so we could see what address was on coupon. No notation was made showing we received a faxed copy of the coupon.

Taxpayer talked to another Tax Clerk and also told her that her payment was returned as non deliverable. Taxpayer was told that she would have to check the address on the returned check to be sure it was sent to correct address. Taxpayer said she couldn't give proof due to it being Bill Pay.

Department Coordinator—Collections Department faxed Waiver Instructions to Taxpayer.

- 5. February 22, 2013 -- Taxpayer called and asked Tax Clerk if payment had been received. Tax Clerk advised that it had not been received.
- 6. Fort Bend ISD has authorized Fort Bend County Tax Office to handle the processing of the waiver of penalty and interest, and allow the Fort Bend County Commissioners Court to make the determination based on 33.011 of the State Property Tax Code.
