Antun Aneed, is requesting waiver of penalty and interest for 2012 tax year because he did not receive a tax statement in a timely manner.

#### Tax Office Records Indicate:

- 1. Original deed # 2012051080 was recorded on June 3, 2010, with the owner listed as Antun Aneed, 1814 Lakefront Dr., Missouri City, Texas 77459.
- 2. November 16, 2012 2012 Original Statement was mailed to Aneed Antun, 1814 Lakefront Dr, Missouri City, TX 77459-1649. According to Tax Office records 2012 Original Statement was not returned by Post Office.
- 3. February 12, 2013 Tax Office received 2012 payment short from Antun and Nayla Aneed. Also enclosed was copy of 2012 tax statement with corrected address notated.

Assistant Division Property Tax Supervisor sent and received several emails from taxpayer regarding delinquent taxes and short pay due to not receiving tax statement. Taxpayer stated he had notified FBCAD of address change before.

- 4. The tax office requested additional research by FBCAD to determine whether they had received request prior to February 1, 2013 request to change mailing address. We have received correspondence from Mr. Glen Whitehead with the Fort Bend Central Appraisal District confirming that February 1, 2013, was the first request they had received to change mailing address.
- 5. Fort Bend ISD, City of Missouri City and Houston Community College-Missouri City have authorized Fort Bend County Tax Office to handle the processing of the waiver of penalty and interest, and allow the Fort Bend County Commissioners Court to make the determination based on 33.011 of the State Property Tax Code.
