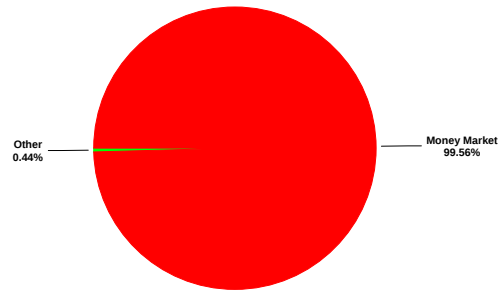

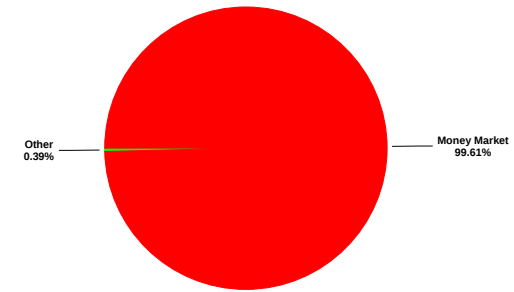

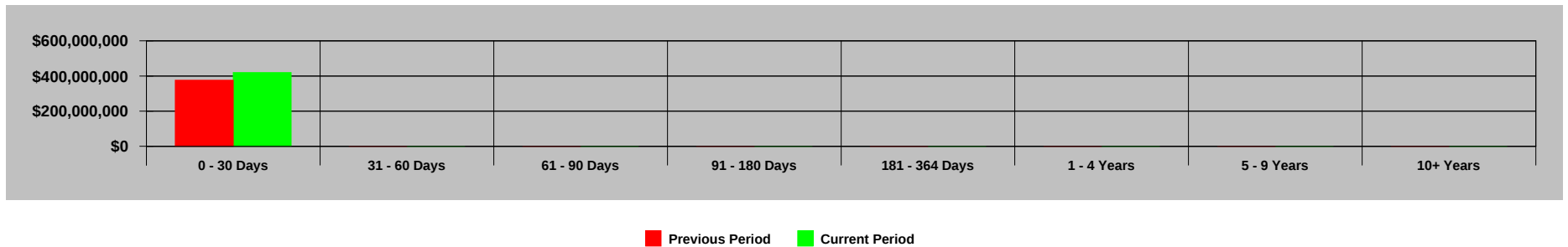
Portfolio Composition - 01/31/13



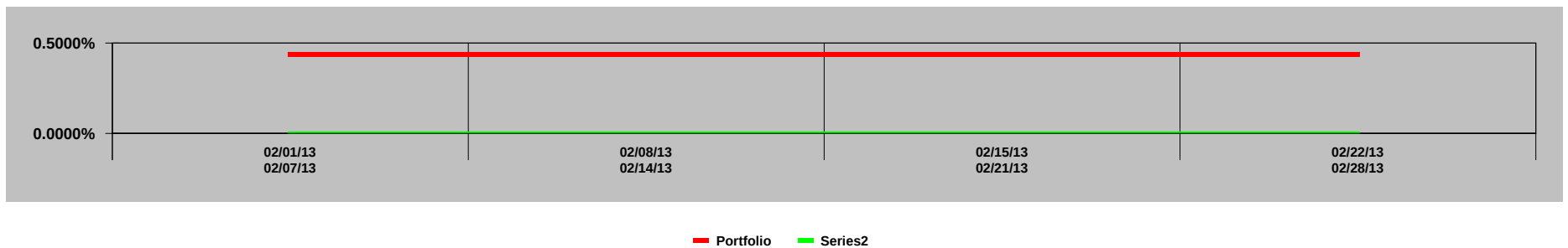
Portfolio Composition - 02/28/13

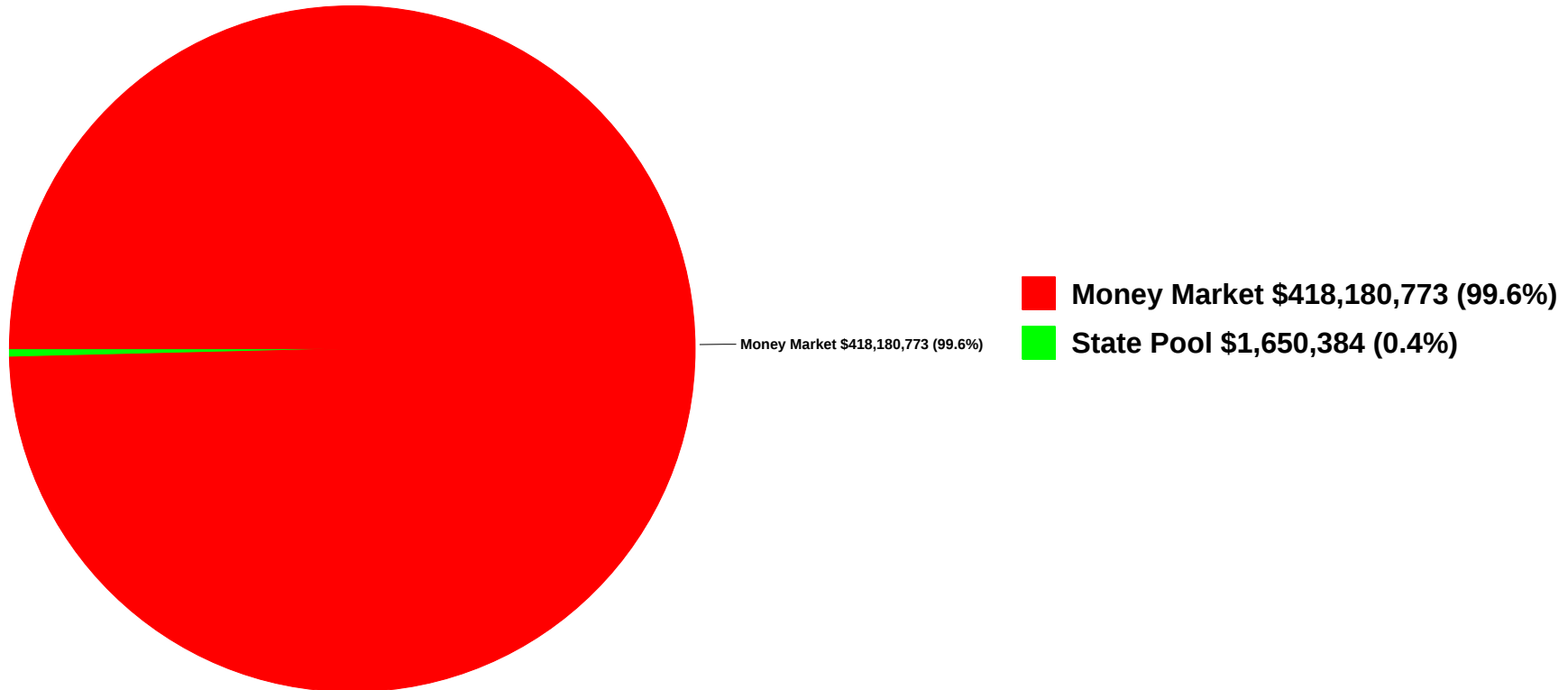

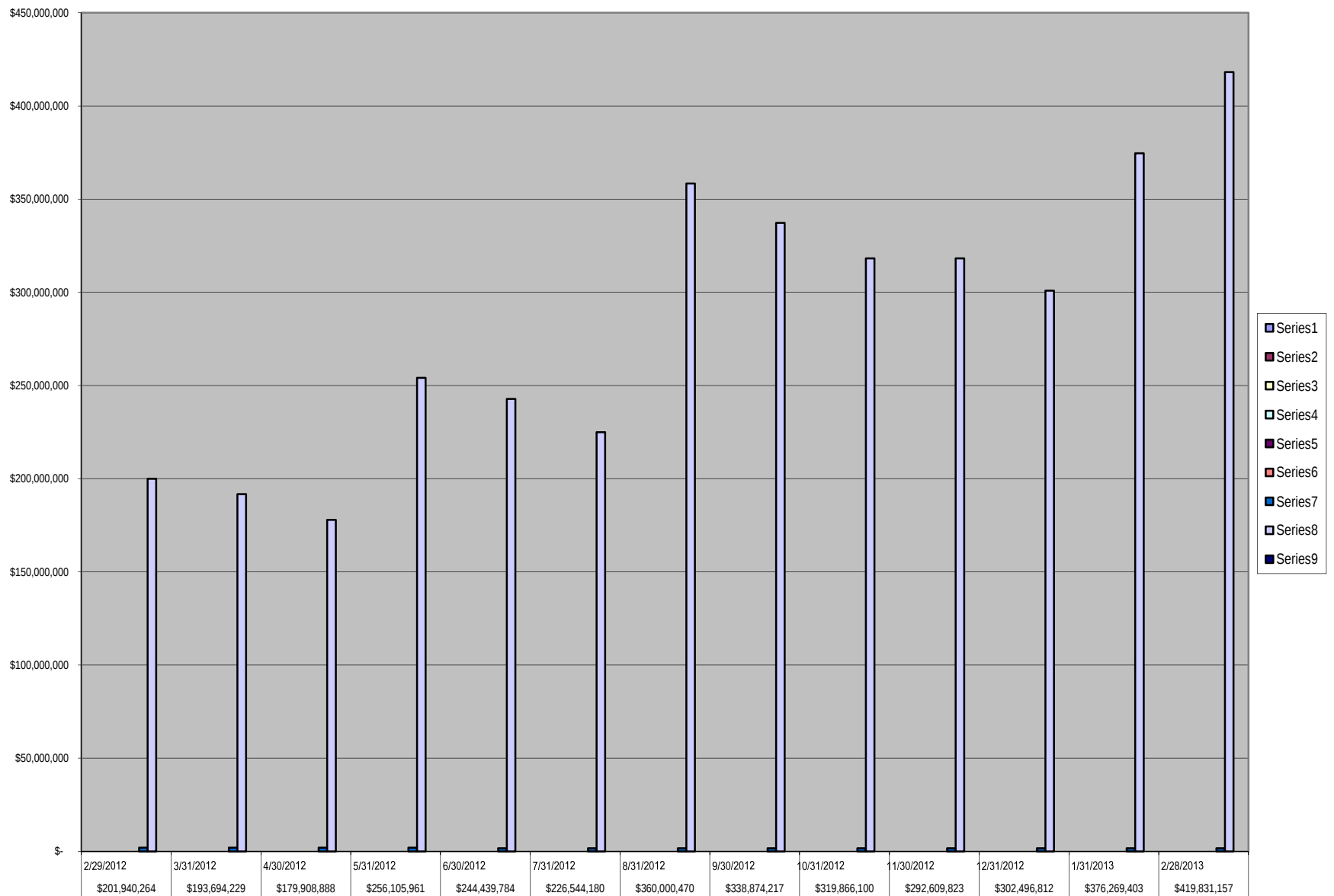

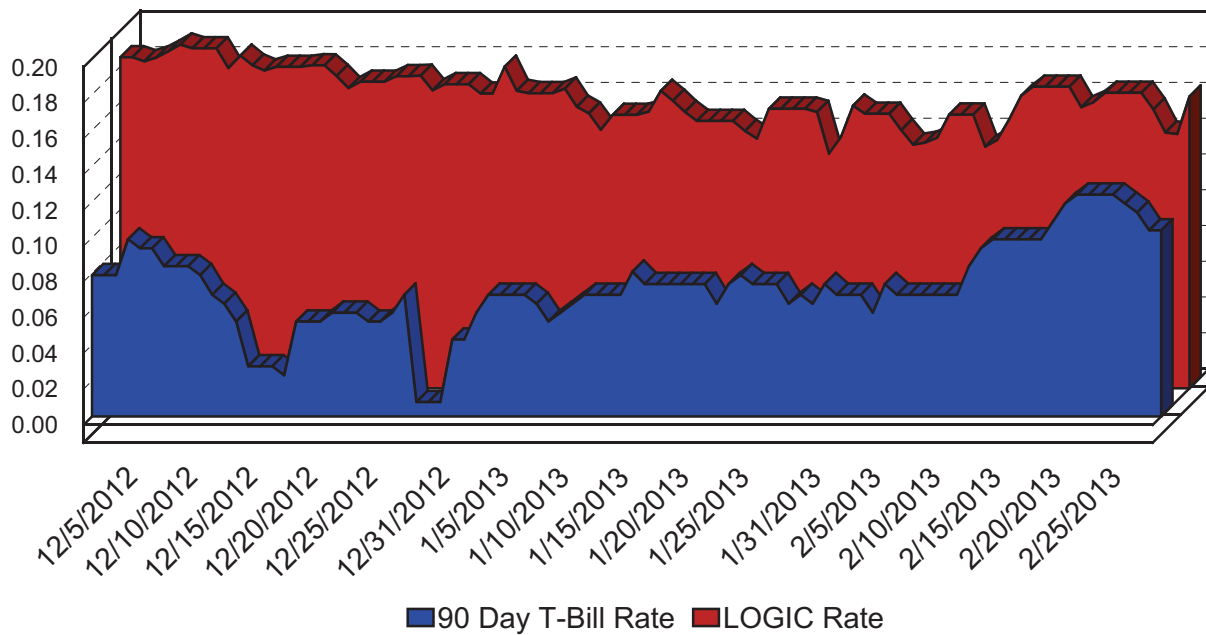
