Dear Judge Herbert,

I write to you in the hope that you may consider my request to have the penalties and interest waived from my 2012 property taxes for the above reference property in Katy, Texas. I sincerely apologize that these taxes were not paid in a timely manner, however the reminder I received recently was the first correspondence indicating any payment was due.

Once received, I wrote a cheque and posted it as the funds have been sitting waiting knowing that these taxes would be due at some point. I am not suggesting that the initial invoice was not sent, however I've not received anything up until recently at which time I received the reminder. I had the ability to pay with funds available, and the intention to do so, however due to some problem along the way I never received the first invoice. I have only been a Texas home owner for a short time and am not familiar with when the property taxes are due, so I saw no red flag when I didn't receive anything before the end of 2012.

I can provide proof of funds with bank account records if required, as I mentioned earlier there was always an intention and ability to pay. Additionally, while writing this letter, I noticed the address on the attached reminder statement differs from my correct address, which may have caused the problem with the posting of the initial invoice. May I kindly ask that my records are changed to reflect the correct address as it is shown at the top of this letter.

The 9% levy is a significant amount of money and something I had not budgeted for which is why, especially given the circumstances I ask for your consideration. I am not in the habit of missing payments, tax or otherwise, but I do feel that this was out of my control.

I would greatly appreciate it if you could take the time to consider my waiver application and hope you can grant me a positive outcome.
