Between the dates of August 7th and August 8th, I traveled to Tacoma, Washington for the purpose of extraditing a prisoner back to Texas. In preparation for the trip, I contacted Avis Car Rental and made a reservation for a vehicle. I requested a full size, four door vehicle since I would be using the vehicle for a prisoner transport. The representative told me the only vehicle available was a two door Ford Mustang. I had no choice at this time but to book the Ford Mustang. I was unaware at this time but apparently there was a large conference in Tacoma and all the rental cars and hotel rooms were nearly fully booked.

The county only allows us to use Avis or Enterprise car rental for extraditions. I did not attempt to contact Enterprise because I've had too many bad experiences with them in the past.

When I arrived at the Avis Car rental in Tacoma, Washington, the representative told me that a 4 door SUV vehicle was available. I decided to change the reservation and take the 4 door SUV because it is a more practical vehicle for a safe prisoner transport.
