- March 4, 2013 -- 2012 Reminder Notice was mailed to Oswaldo Hazbon and Martha Juliana Granados without a physical mailing address listed on the statement. This statement was not returned by the Post Office
- May 30, 2013--2012 33.07 Notice was mailed to Oswaldo Hazbon and Martha Juliana
 Granados without a physical mailing address listed on the statement. This statement
 was returned by the Post Office ---as return to sender, not deliverable as addressed,
 and unable to forward
- June 5, 2013-- Tax Office forwarded a Delinquent Statement to Oswaldo Hazbon and Martha Juliana Granados at 2206 Pearl Bay Court Pearland, TX 77584-3761
- There is evidence of an error by the Fort Bend Central Appraisal District.
- Fort Bend ISD has authorized Fort Bend County Tax Office to handle the processing of the waiver of penalty, interest and collection fees and allow the Fort Bend County Commissioners Court to make the determination based on 33.011 of the State Property Tax Code.

I <u>do</u> recommend waiver of penalty and interest for **2012**. Property Tax Code Section 33.011 (a) (1). "The governing body of a taxing unit: shall waive penalties and may provide for the waiver of interest on a delinquent tax if an act or omission of an officer, employee, or agent of the taxing unit or the appraisal district in which the taxing unit participates caused or resulted in the taxpayer's failure to pay the tax before delinquency..."

Honorable County Judge Robert E. Herbert,

A week ago my wife and I received a delinquent tax statement bill from the Fort Bend County Tax Assessor/Collector for the value of \$664.70, which states that we have to pay an additional penalty of \$99.71 because this tax bill was not paid in December 2012, bringing the total to \$764.41 (Please see enclosed document). This is the first time we receive this bill, or any bill for that matter, from Fort Bend County: we never received any such document in December.

We moved from Dallas to Houston and purchased this house in September 2012. We have never before owned property in the Houston area. In December 2012, we received tax bills from Brazoria-Fort Bend Co Mud and from Brazoria County which we paid before the end of the year, as we always did in Dallas (Please see enclosed documents). We were unaware that we had to pay a third tax bill.

We called the Fort Bend County Tax Assessor Office, and spoke with Mrs. Irene Arreguin, the Collections Department Coordinator, about this issue. She responded that they could not send this bill until June 2013 because they did not have our home address until now.

Mrs. Arreguin sent us a document with instructions to apply for a reimbursement on this penalty. The instructions said to pay the amount including fees in full before sending this letter, so we are enclosing a copy of the check we used to pay the \$764.41 on the bill to you to prove we have paid it in full.

Since we did not receive or were made aware of this bill, we could not pay it during December 2012. We did not ignore the bill: the Fort Bend County Tax Assessor/Collector did not send it out until June, six months later. We believe that for this reason we should not be penalized with the \$99.71 fee on this bill.

Through this letter, we are formally requesting a waiver of the penalty, interest and attorney fees on our bill to you, Judge Hebert. The following is the information we were told was required:
