General Description

Fort Bend County Toll Road Authority is constructing an extension of the Fort Bend Parkway from State Highway 6 to Sienna Parkway, Segment B-1, and includes one tolled location. The additional work to be performed by Xerox State and Local Solutions, Inc. under this scope of services includes the provision of violation processing services for Fort Bend Parkway Segment B-1.

The performance requirements for Segment B-1 shall comply with all the requirements of the Violation Processing Services Agreement. The schedule for implementation of violation processing services for Segment B-1 shall be separate and distinct from the Violation Processing Services Agreement and will be determined at the time a Notice to Proceed is issued. Assumptions and costs for violation processing services for Segment B-1 of the Fort Bend Parkway performed pursuant to this Change Order are:

Assumptions for the Addition of the Sienna Parkway (B1 Plaza)

- 1) The existing FBGPTRA business rules will apply to the B1 Plaza. Including, but not limited to: timing of notice mailing, fees, escalation rules, penalty adjustments.
- 2) The FBGPTRA lane vendor will combine transactions from the B1 Plaza with the other roadways and send Xerox a single file containing violation transaction information and images.
- 3) Financial processing (e.g. deposits) for the B1 Plaza will be combined with the other roadways.
- 4) Deployment (Xerox violation processing) for the B1 Plaza will be concurrent with the other roadways.
- 5) FBGPTRA provided a report that indicated that the Average Weekly Traffic Transaction volumes for the B1 Plaza are expected to be: 2014 = 5,400; 2015 = 7,000; 2016 = 7,500
- 6) All performance standards, service level agreements and any associated liquidated damages will be the same as the base contract.
- 7) Transaction pricing and collection revenue sharing will be consistent with the base contract; inclusive of the annual CPI-based adjustment.

The one-time price to add the B1 Plaza will be: \$24,982
