**RE: Lamar CISD Elem. School No. 21 - Joe Hubenak Elementary - Request for
"No Parking" signs, Lakes of Bella Terra Development**

Dear Commissioner Meyers:

The Fort Bend County Engineering Department has reviewed the request for "no parking" signs around Joe Hubenak Elementary School. The request was to install "no parking" signs along West Lagano Verde Drive from Via Verdone Drive to Bella Florence Drive. In addition, "no parking" signs along Bella Florence Drive from South Lagano Verde Drive to approximately 125' south of its intersection with Bella Veneza Drive.

The FBCED observed traffic at the requested locations and have prepared a traffic control plan suggesting the installation of "No Parking Anytime" signs at these locations. A copy of the traffic control plan is attached for your review. The public hearing date for acceptance of the plans is being scheduled.

A separate request for the school zone to be extended through the intersection of South Laguna Verde Drive and Mirandola Lane. The flashing school zone sign is located properly according to the recommendation of the traffic impact analysis and the *Texas Manual on Traffic Control Devices (TMUTCD)*. The Engineering Department has determined that the school zone limits are sufficient.

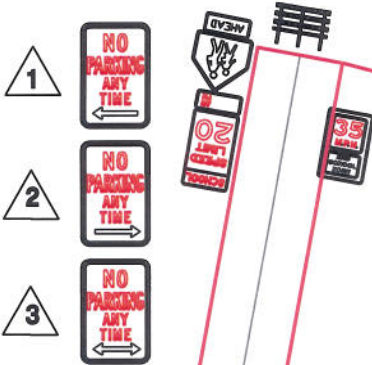

"NO PARKING" SIGN LEGEND

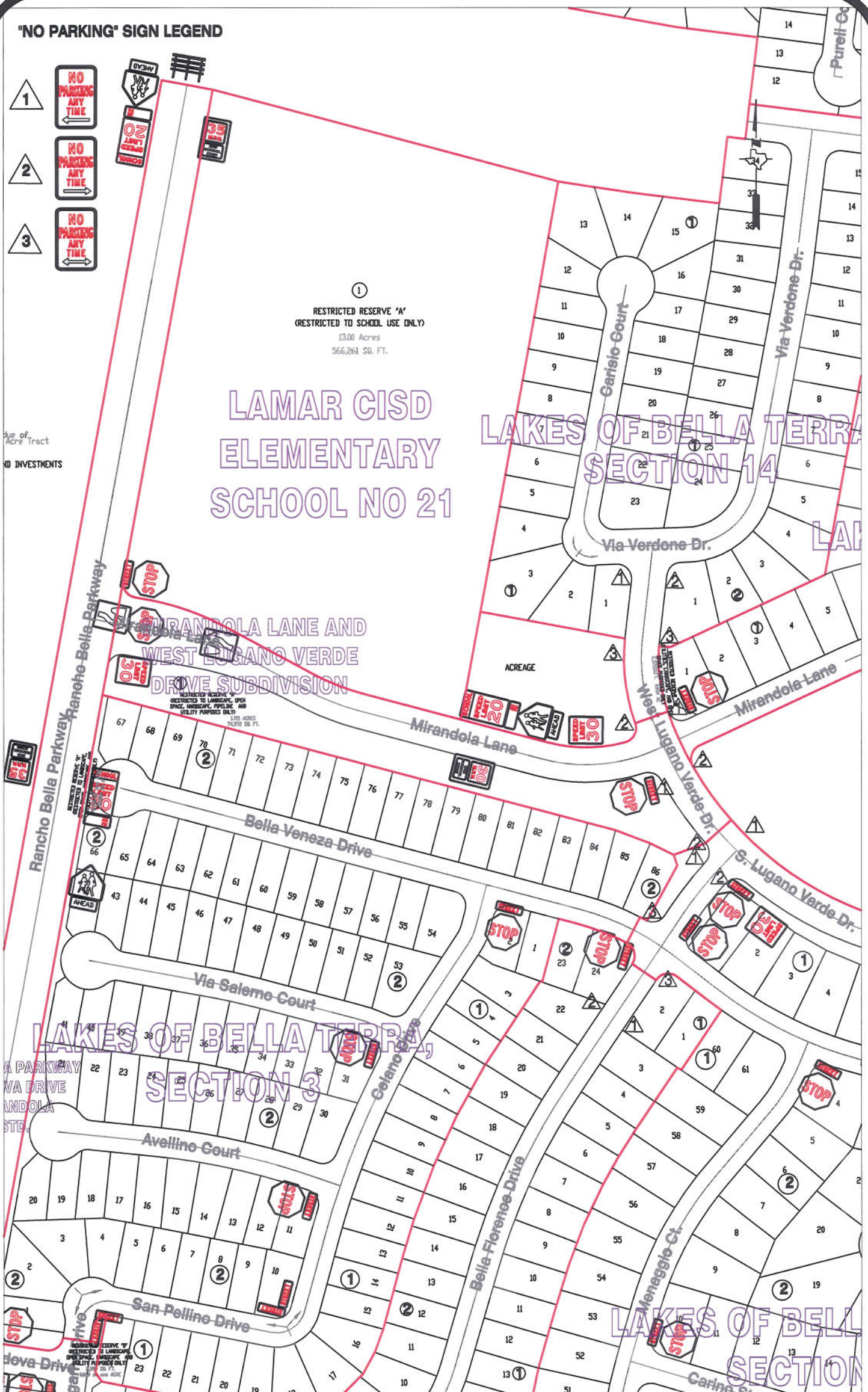
