Out of State Travel Request / Employee Tod Schneider

Environmental Investigator, Tod Schneider investigated an illegal dumping case that involved the same suspect in a North Carolina homicide in which the victim's body was disposed of in Fort Bend County. Investigator Schneider developed evidence which will be submitted in the trial against one of the homicide suspects. Other law enforcement officials from Fort Bend are also involved in this case.

The prosecution is scheduled, by subpoena (attached hereto), for January 27th through February 7th in Raleigh, North Carolina. Investigator Schneider may only be needed an estimated three to four days out of the entire time period. The testimony will take place during regular business hours and will coincide with Investigator Schneider's regular work schedule.

North Carolina District Attorney's office is providing all travel, lodging, meals and ground transportation while in North Carolina.

It is requested that out of state travel be approved for Investigator Schneider to testify at this trial.

Attached is a subpoena for J.T. Schneider that is for a one month period of time (the same time period that members of the sheriffs department are subpoenaed), however I will only be seeking to have Mr. Schneider here for a two day period of time that will be determined after we get the jury seated and get the crime scene before the jury in Raleigh.
