AMENDED AND RESTATED RESOLUTION DESIGNATING THE FORT BEND PARKWAY TOLL ROAD AS A CONTROLLED-ACCESS FACILITY

WHEREAS, the Fort Bend County Toll Road Authority (the "Authority") is a local government corporation created pursuant to the provisions of Subchapter D of the Texas Transportation Corporation Act, Chapter 431, Texas Transportation Code (the "Act"); and

WHEREAS, the Authority is authorized pursuant to Chapter 284 of the Transportation Code to construct and operate a toll road; and

WHEREAS, Transportation Code, Section 284.071 authorizes the Authority to designate a toll road as a controlled-access toll road; and

WHEREAS, on November 20, 2002, the Authority previously adopted a Resolution Designating the Fort Bend Parkway Toll Road as a Controlled-Access Facility (the "Resolution"); and

WHEREAS, the Authority is extending the Fort Bend Parkway Toll Road from State Highway 6 to Sienna Parkway; and

WHEREAS, the Authority desires to amend and restate the Resolution in its entirety as provided herein;

NOW, THEREFORE, BE IT RESOLVED BY THE BOARD OF DIRECTORS OF THE FORT BEND COUNTY TOLL ROAD AUTHORITY THAT:

Section 1. Findings. The Authority hereby makes the following findings:

- a. Fort Bend Parkway Toll Road (the "Parkway") will provide improved access to portions of Fort Bend County and will provide a major travel corridor between Beltway 8 and Sienna Parkway.
- b. The public interest and efficient operation of the Parkway requires that the Authority limit access to the Parkway.

<u>Section 2.</u> <u>Designation of Controlled-Access Facility</u>. The Parkway is a controlled-access toll road. Access to and from the Parkway is limited as follows:

- a. Access to the Parkway is denied for all bicycles and pedestrian traffic.
- b. Access from any real property adjacent to the Parkway is denied, except as may be approved by the Authority in accordance with the Authority's then current Policies and Procedures Relating to Access along the Parkway or as may be retained by the landowner in a deed conveying property to the Authority.

- c. Access from all streets and roads is denied, except from the following: Beltway 8, McHard Road (FM2234), State Highway 6, Lake Olympia Boulevard, Knight Road, Sienna Parkway, and Fondren Road.
- d. Access to or from any ramp is denied, except as may be approved by the Authority in accordance with the Authority's then current Policies and Procedures Relating to Access along the Parkway.

Section 3. This Resolution shall apply to any future extensions of the Parkway.

<u>Section 4</u>. The Authority hereby authorizes the Authority's consultants, including, but not limited to, Brown & Gay Engineers, Inc., Allen Boone Humphries Robinson LLP, WJ Interests, LLC, and Mike Stone Associates, Inc., to take any action necessary to effectuate the purpose of this Resolution.
