Project Status From November 16, 2013 To January 28, 2014:

- A. SES received additional comments on the final completion plan set and the related cost estimate that includes the FBC Brand Lane Road Project and the FBCWCID No. 2 water line improvements. The comments were made by FBC, FBCDD and SPI.
- B. Final plans (signed and sealed originals) have been signed by all parties including FBC and FBCDD.

Planned Activities For Next 30 Days:

- 1. SES will address the additional comments in item A above.
- 2. SES will finalize Project Manual and bidding documents for the project.
- 3. SES will continue to coordinate any outstanding drainage issues with the BAPS facility (Maverick Engineering) as a result of BAP's receiving recent approval from the City of Sugar Land for a new driveway to the BAPS facility from Dulles Avenue. SES will verify if the proposed BAPS drainage as a result of this driveway and future development does not adversely impact the proposed drainage system (System C) on Brand Lane that drains to the existing Avenue E drainage system.

Action Items from SPI/FBC Next 30 Days:

- 4. Finalize right of way acquisitions.
- 5. Establish pre-bid meeting and bid dates.
