Action by the Court is governed by guidelines under Texas Tax Code, Chapter 33, Section 33.011\*, Commissioners Court cannot waive penalty, interest and/or collection fees unless there is evidence of an error by the appraisal district or the County. - Jack Shaw was unable to pay the taxes and therefore, they were paid by Green Tree Servicing LLC on November 11, 2013.

- There is no evidence of an error by the Fort Bend Central Appraisal District or the Fort Bend County Tax Office.
- Stafford MSD, HCC-Stafford and Fort Bend WCID#2 have authorized Fort Bend County
  Tax Office to handle the processing of the waiver of penalty, interest and collection fees
  and allow the Fort Bend County Commissioners Court to make the determination based
  on 33.011 of the State Property Tax Code.


