Summary of organization's purpose including mission statement:

Fort Bend County Social Services (FBCSS) provides short term emergency assistance to the residents of Fort Bend County. Services include: medication assistance, food voucher, utility assistance, rental assistance, and case management services through our Transitional Supportive Housing Program and application benefits assistance. Annually FBCSS also assists children with a pair of new shoes to begin the school year through the Walk With Pride Shoe Program.

Purpose of request:

FBCSS is requesting assistance with its Annual Walk With Pride Shoe Program and providing Unmet Emergency Needs through its comprehensive short term Transitional Supportive Housing Program.

Issue/need to be addressed:

According to a needs assessment (A report on the Demographic Changes and Changing Needs of Fort Bend County, conducted by The George Foundation) in the summer of 2011, respondents identified food and housing as the greatest critical need. Furthermore, participants listed affordable housing, homeless shelters, food assistance and basic needs as not being met by current services in the region. In fiscal year 2013 (October 2012 through September 2013) Fort Bend County Social Services served 163 clients with rent/mortgage assistance, 639 with utility assistance and 325 with food assistance. During, the same fiscal year, 71% reported living at or below 100% of the poverty level (\$23,550.00 annually for a family of 4). The statistics from the needs assessment indicated that from 2000 to 2010, the U.S. Census Bureau reported a 3% increase in the population living below the poverty level. Meal Gap data in 2012 reported that 21% (approximately 55,510) of Fort Bend County's children are food insecure, meaning they do not receive three nutritious meals a day. While the services of the FBCSS are short term we have identified that in assisting individuals and families with more permanent assistance and/or resolving problems, they are less likely to return to the department for assistance. What we have also learned is that in many cases individuals and families lack the financial means to overcome these unmet emergency needs. An example of this service would be a senior citizen whose water was disconnected due to the inability to pay because they live on a fixed income. In the last 6 months our office has identified such cases as water leaks with the inability to pay the plumber to have it fixed, the electricity being disconnected and not having heat during the cold winter days, and other incidents where the elderly go without. While the department has been successful in assisting with these noted incidents and other emergency and transitional needs, there are still many needs which the department is unable to meet.

One need to be addressed through this request is the Walk With Pride Shoe Program held by FBCSS annually. The program assists school age children whose families are at or below 150% of the poverty level. Each year the department receives over 1000 applications from needy families requesting assistance or a new pair of shoes. While assistance for school supplies and uniforms can be obtained through other means, the Walk With Pride Shoe Program is the only program in the county held annually to meet this need.

Anticipated outcomes:

- 100 individuals and families will be immediately impacted by the Unmet Emergency Needs Program. This service will ultimately reduce the number of individuals returning for assistance for the same reason.
- 200 school aged children will be assisted with a new pair of shoes for the start of the school year. Every year the FBCSS attempts to raise \$20,000.00 to assist at least 1000 school aged children with a new pair of shoes.

Total project/program/operating cost: \$20,000.00 Walk With Pride \$10,000.00 Unmet Emergency

Amount requested: \$3,000.00 for Walk With Pride \$7,000.00 Unmet Emergency

Walk With Pride approximately \$1,000.00

Unmet Emergency Needs \$ 0, this is a new service, some funding for this item has been requested through the County's regular budget process. Notification of funding through the county will take place by September 2014.
