The County has received your request to waive penalty, interest, and collection fees on Fort Bend County property taxes. Action by the Court is governed by guidelines under Texas Tax Code, Chapter 33, Section 33.011\*, Commissioners Court cannot waive penalty, interest and/or collection fees unless there is evidence of an error by the appraisal district or the County. Michelle Salinas, is requesting waiver of penalty and interest for 2013 tax year due to Stop Payment on one check and another check being returned as duplicate payment after they became delinquent.

#### Tax Office Records Indicate:

March 27, 1997 -- Original Deed # 9722964 was recorded, with the owner listed as Michelle Salinas. Grantee address was listed as Route 1, Box 1426, Fresno, TX 77545.

October 25, 2013 – 2013 Original Tax Statement was mailed to: Salinas Michelle, 307 Broadmore Dr, Sugar Land, TX 77545-7463. According to Tax Office records this statement was not returned by Post Office.

January 29, 2014 – Taxpayer phoned and asked Tax Clerk if Tax Office has received her check. She was told we had not received it.

February 4, 2014 – Duplicate payment check was returned to taxpayer's aunt.

February 12, 2014 – Payment posted January 30, 2014

February 12, 2014 – 2013 Delinquent Statement is printed for mailing to Carolyn Massey, PO Box 2155, Silsbee, TX 77656-2155.

Fort Bend ISD and Fort Bend Fresh Water Supply District #1 have authorized Fort Bend County Tax Office to handle the processing of the waiver of penalty and interest, and allow the Fort Bend County Commissioners Court to make the determination based on 33.011 of the State Property Tax Code.
