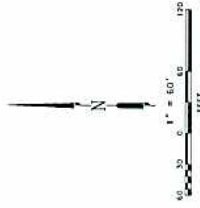
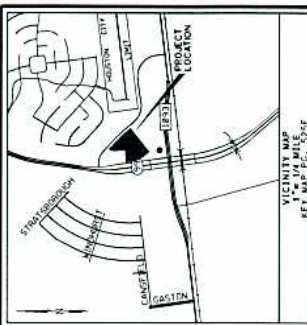

I am requesting a public hearing for said replat which is named **Grand Corner Reserves Partial Replat No 5.**

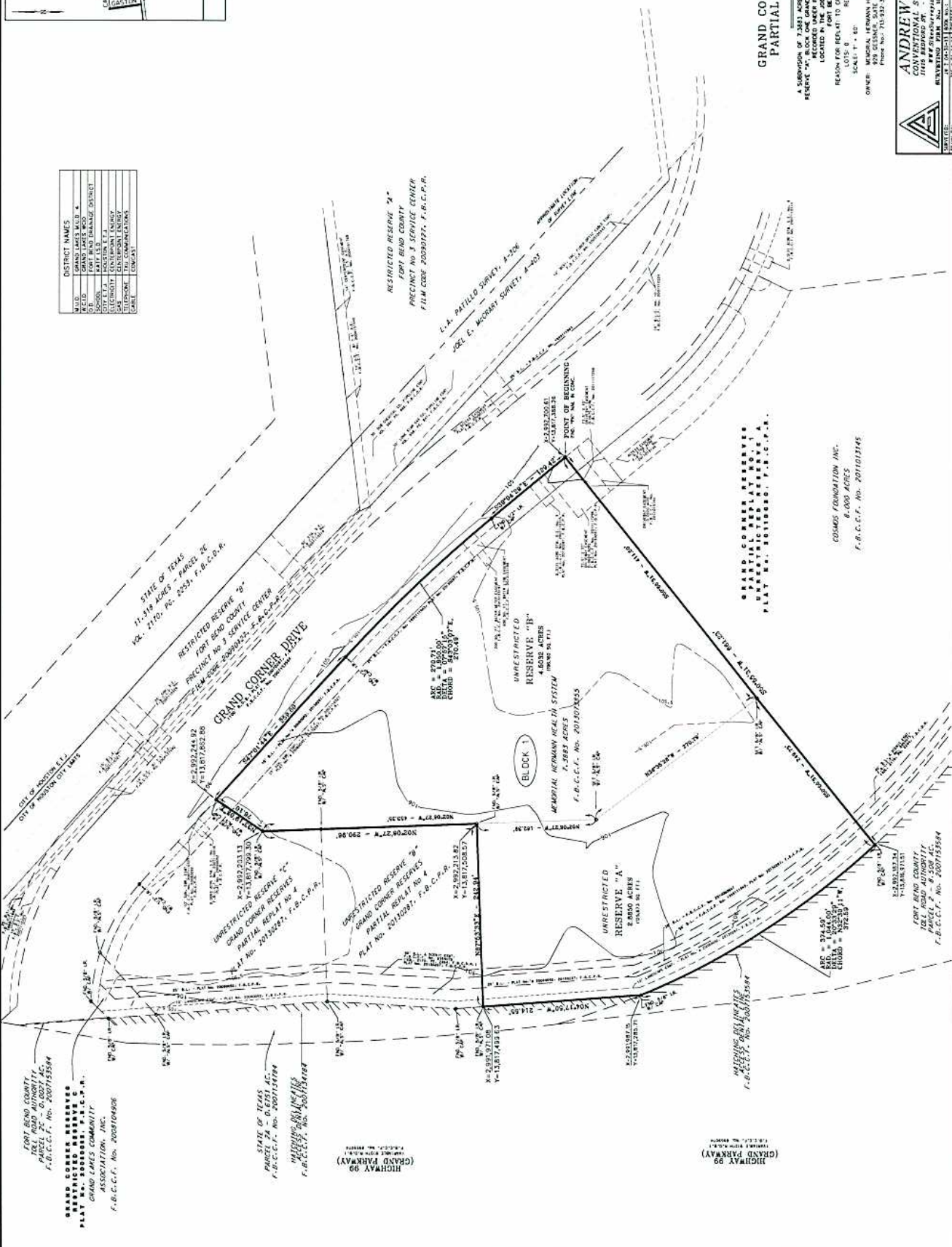
