Action by the Court is governed by guidelines under Texas Tax Code, Chapter 33, Section 33.011*, Commissioners Court cannot waive penalty, interest and/or collection fees unless there is evidence of an error by the appraisal district or the County. Eugene Liu, on behalf of Rose Guajardo, is requesting a waiver of penalty and interest for the 2013 tax year, stating he sent his payment for this property with three other properties prior to the delinquency date but it was not posted with the other payments.

Tax Office Records Indicate:

- June 2, 2010 Deed #2010050183 was recorded with owner Rose Guajardo and mailing address 10718 Highland Woods Drive, Sugar Land, TX 77478.
- The Original 2013 Tax Statement, the Reminder Notice and the 33.07 Notice were all mailed to Rose Guajardo, 10718 Highland Woods Dr, Sugar Land, TX 77498-1741. These statements were not returned by the Post Office.
- Tax Office findings indicate that payments for eight accounts were received in the same envelope from Eugene Liu and Sandy Ho, which was postmarked December 27, 2013.
 This envelope did not include a payment for the above referenced tax account.

- There is no evidence of an error by the Fort Bend Central Appraisal District or the Fort Bend County Tax Office.
- Fort Bend ISD and Fort Bend ESD # 5 have authorized Fort Bend County Tax Office to handle the processing of the waiver of penalty, interest and collection fees and allow the Fort Bend County Commissioners Court to make the determination based on 33.011 of the State Property Tax Code.

I am filing this waiver because I received a delinquent property tax notice last week, from an attorney, stating that we had not paid the 2013's county property taxes for 10718 Highland Woods Drive. As a result, we have to pay over \$500 penalties, interests and attorney fees on \$1300 owed taxes. Once we have received the notice, we paid the owed taxes and penalties immediately in full.

We feel this sever penalty is extremely unfair for the following reasons:

- We have paid the taxes in a check with 3 other properties in Fort Bend County. We don't know why the tax assessor didn't deposit this one but cleared the other 3.
- Why the county assessor didn't inform us in January when the penalties were insignificant? Why we have never received any late payment notices from the tax assessor's office but the first notice from the attorney's office.
- Are they doing a favor to the law firm they have hired to collect taxes?
- We always pay taxes on time. Please check our paying record.

I believe this severe punishment is for the dead-beat home owners; not for owners like us whose only mistake is not reconciling their checking accounts closely enough to find out their check to the county tax office wasn't cleared.

The tax assessor's office bears some faults too including negligence. But why we have to pay the severe total penalty? Please don't let them abuse their

Therefore, I respectfully to request you to waive the penalties and requesting the Tax assessor sending late payment notices to tax payers in January in the future.
