**2014-15 RENEWAL ADDENDUM BETWEEN  
DEER OAKS EAP SERVICES AND FORT BEND COUNTY**

THIS RENEWAL ADDENDUM, is made and entered into by and between Fort Bend County, (hereinafter "County"), a body corporate and politic under the laws of the State of Texas, and Deer Oaks EAP Services (hereinafter "Contractor"), a company authorized to conduct business in the State of Texas.

**WITNESSETH**

WHEREAS, County participates in an Interlocal Agreement with Montgomery County which permits County to contract with Montgomery County vendors under the same terms and conditions as provided to Montgomery County;

WHEREAS, Contractor has been providing Employee Assistance Program/Work-Life Services for County (hereinafter "Services") since December 1, 2012 under the terms and conditions of Montgomery County Project #2006-0133 (attached as Exhibit A to this Addenda);

WHEREAS, the parties wish to continue services beyond December 31, 2014.

NOW, THEREFORE, in consideration of the mutual covenants and conditions set forth below, the parties agree as follows:

- A. Contractor shall provide Services to County under the same terms and conditions as shown in Exhibit A to this Addendum, effective January 1, 2015 through December 31, 2015.
- B. County shall pay contractor \$2.13 per County employee, for a total of 2,375 employees, per month for the contract term.
- C. The Maximum Compensation for the performance of Services is sixty thousand seven hundred five dollars and zero cents (\$60,705.00). In no case shall the amount paid by County under this Agreement exceed the Maximum Compensation without an approved change order.
- D. No additional funding shall be available for services provided under the Agreement without prior written consent of County.
- E. Except as modified herein, the Agreement remains in full force and effect and has not been modified or amended.
- F. If there is a conflict between this Renewal Addendum and the Agreement, the provisions of this Renewal Addendum shall prevail with regard to the conflict.
