The County has received your request to waive penalty, interest, and collection fees on Fort Bend County property taxes. Action by the Court is governed by guidelines under Texas Tax Code, Chapter 33, Section 33.011*, Commissioners Court cannot waive penalty, interest and/or collection fees unless there is evidence of an error by the appraisal district or the County. - October 25, 2013 The Original 2013 Tax Statement was mailed to Stafford Investment LLC, 3311 S Main St, Stafford, TX 77477-5539. This statement was not returned by the Post Office.
- February, 2014 2013 Reminder and 33.07 Notices were sent to Stafford Investment LLc, 3311 S Main St, Stafford, TX 77477-5539. These statements were not returned by the Post Office.

- August 15, 2014 July Name and Address Change added owner: Zoya Enterprises LTD,
 223 Kingfisher Dr., Sugar Land, TX 77478-4712.
- There is evidence of an error by the Fort Bend Central Appraisal District.
- Stafford MSD, Houston Community College- Stafford and Fort Bend WCID #2 have authorized Fort Bend County Tax Office to handle the processing of the waiver of penalty, interest and collection fees and allow the Fort Bend County Commissioners Court to make the determination based on 33.011 of the State Property Tax Code.
