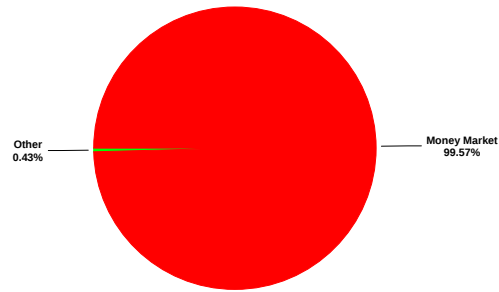

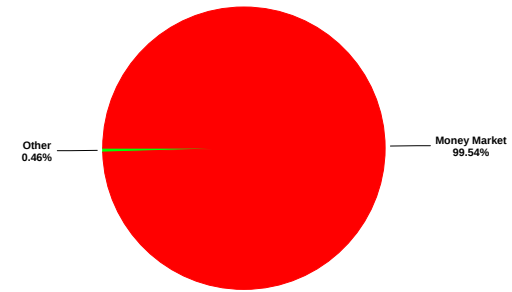

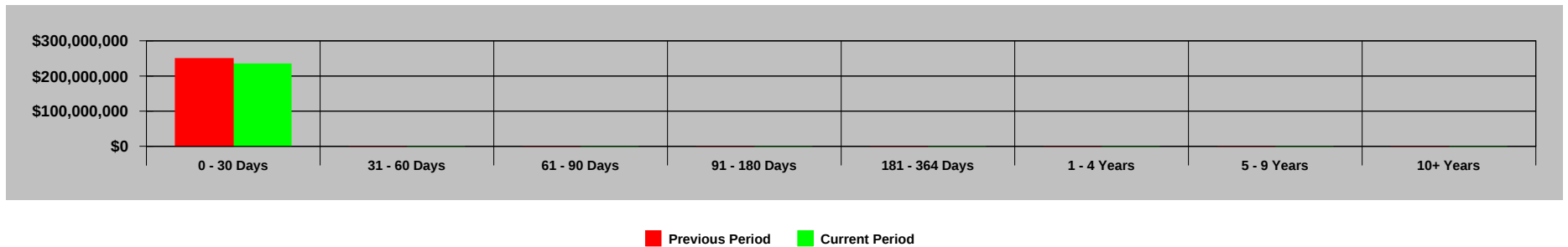
Portfolio Composition - 05/31/14



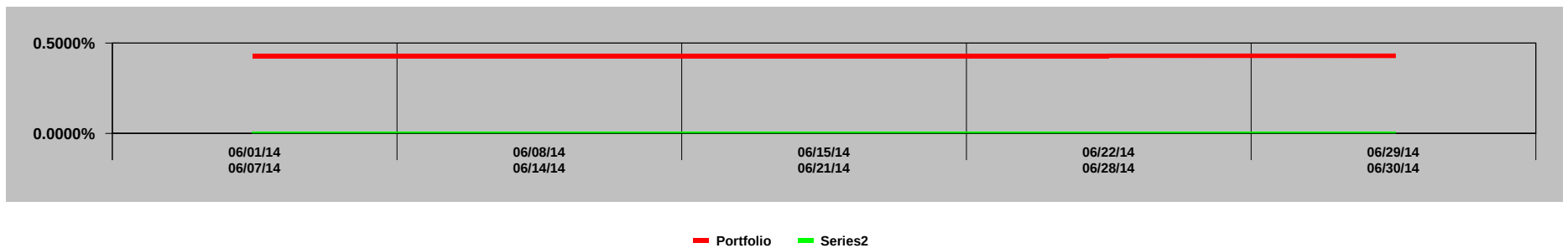
Portfolio Composition - 06/30/14

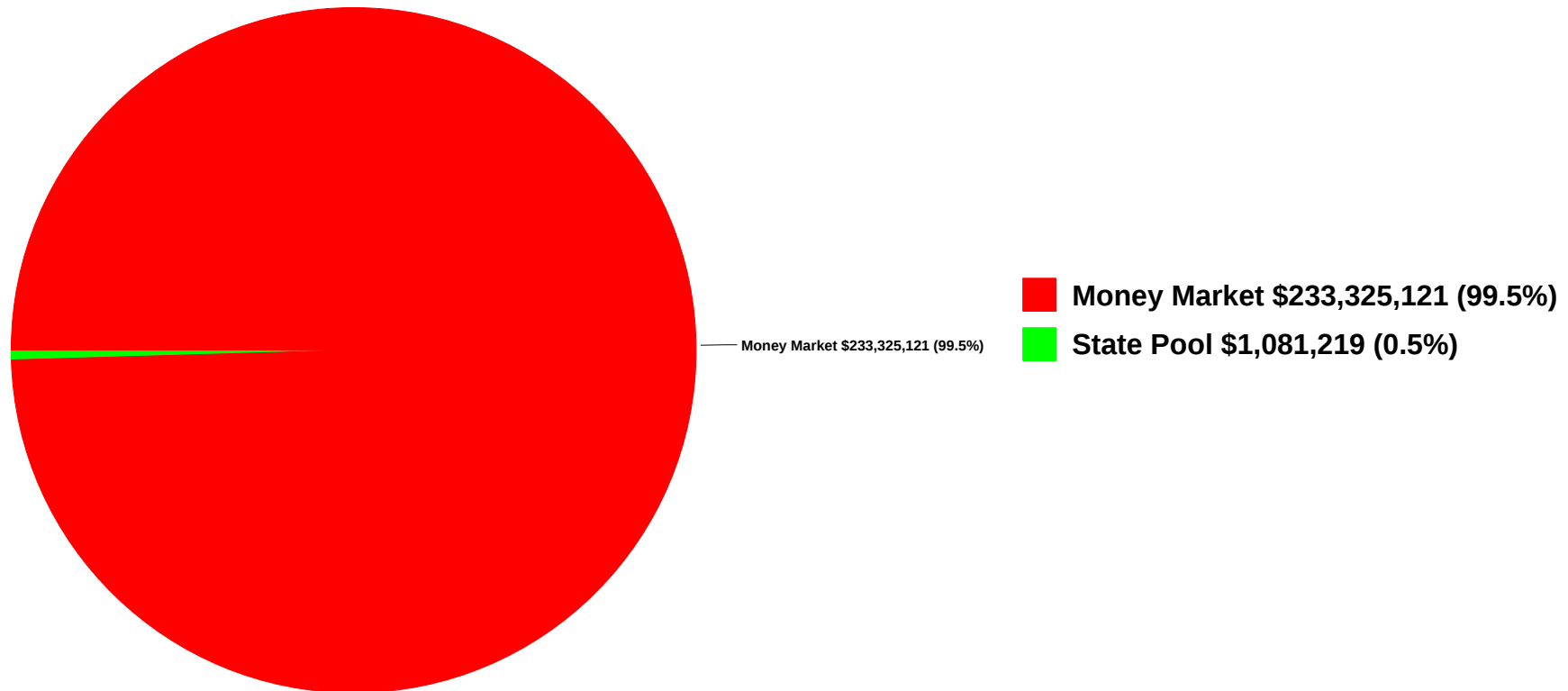

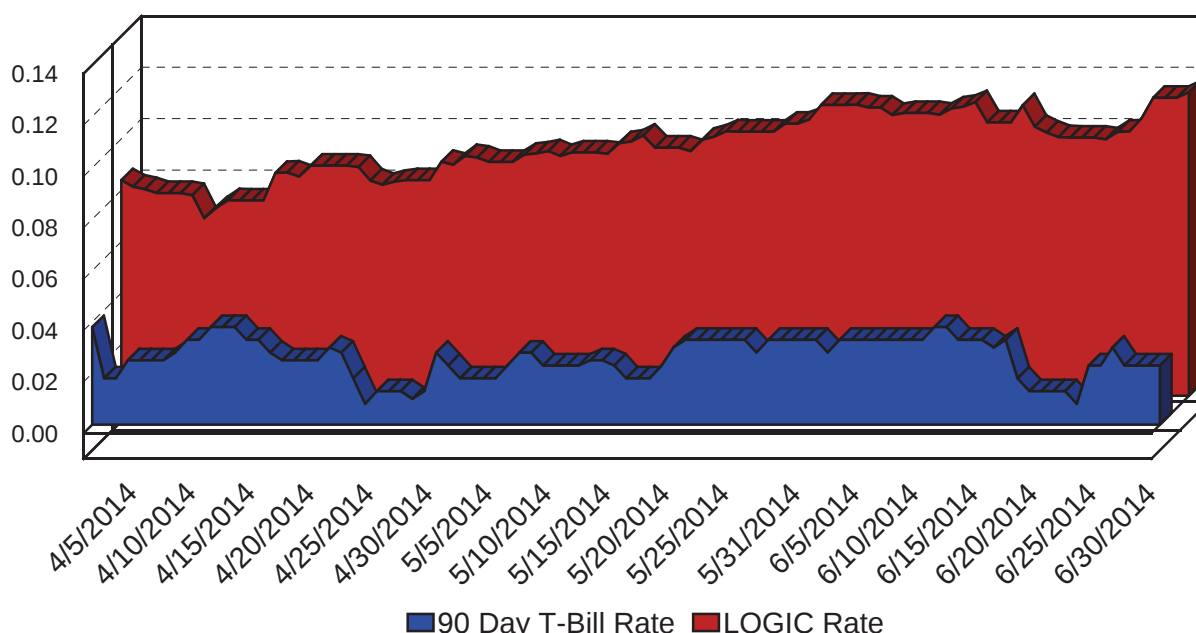
