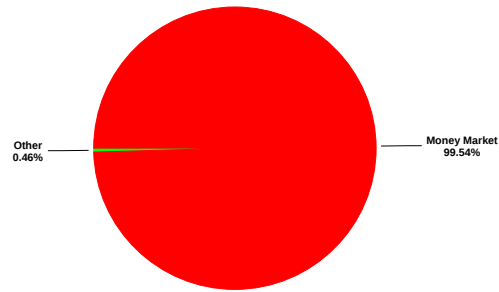

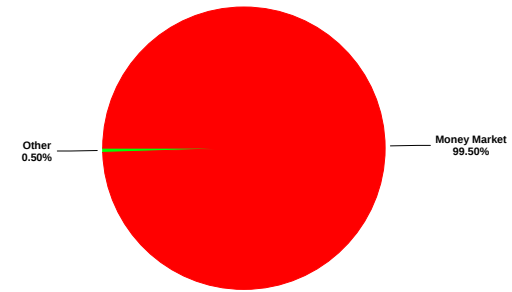

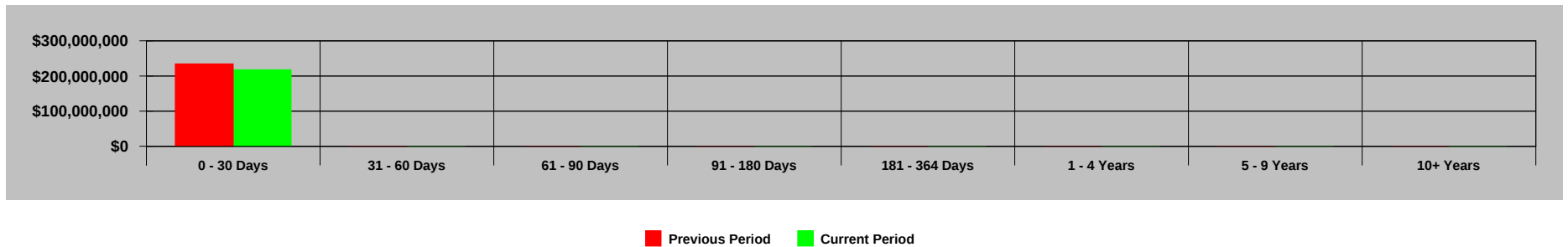
Portfolio Composition - 06/30/14



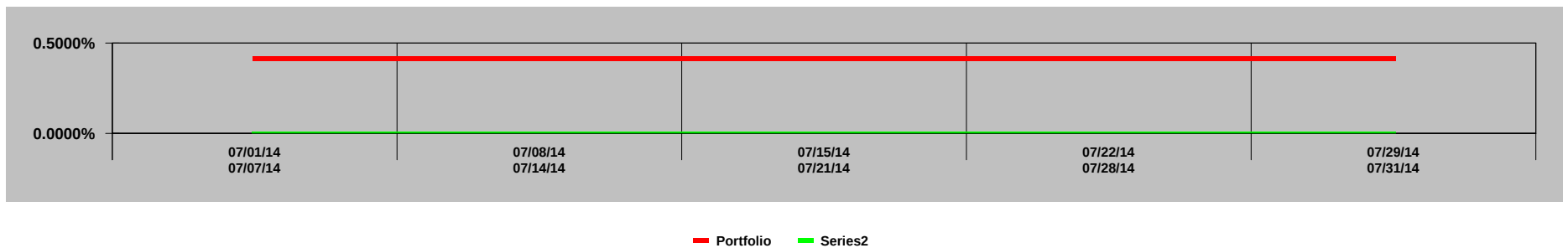
Portfolio Composition - 07/31/14

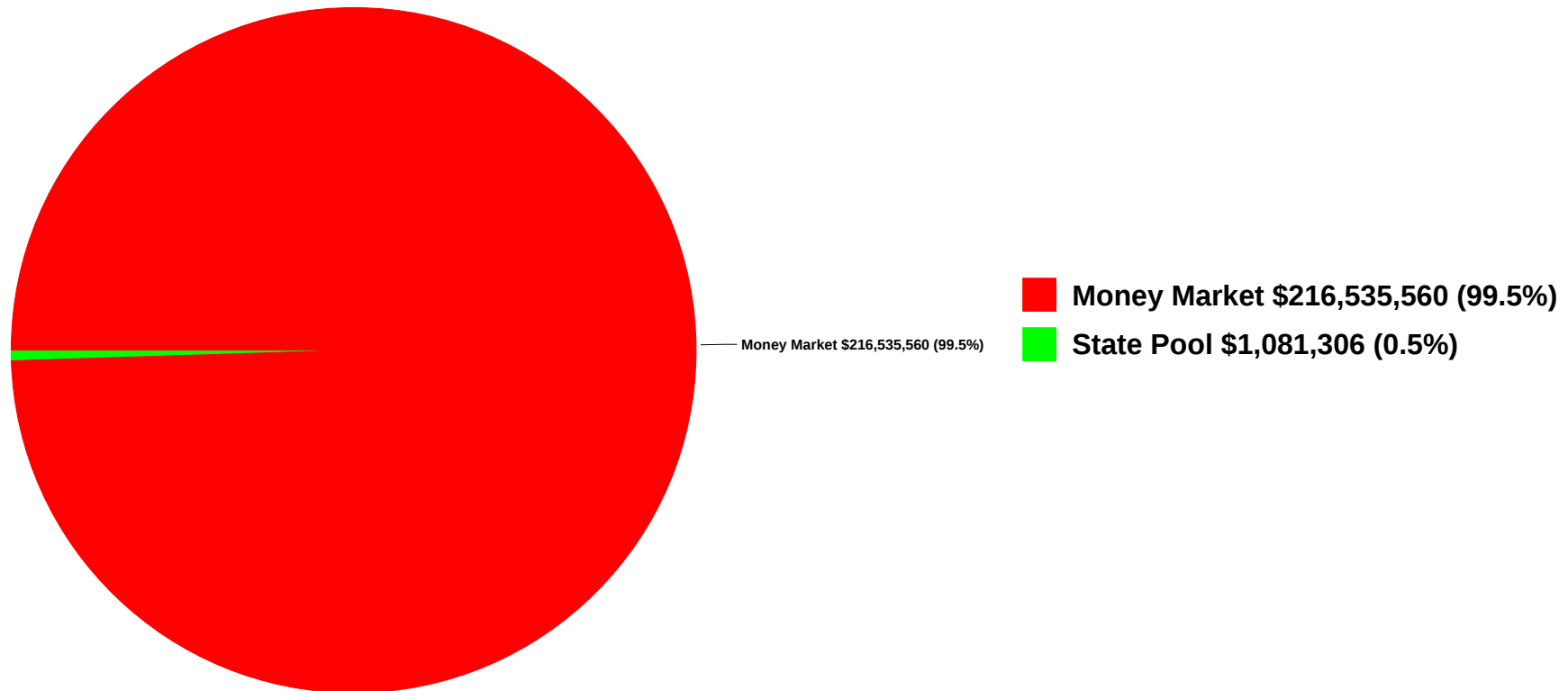

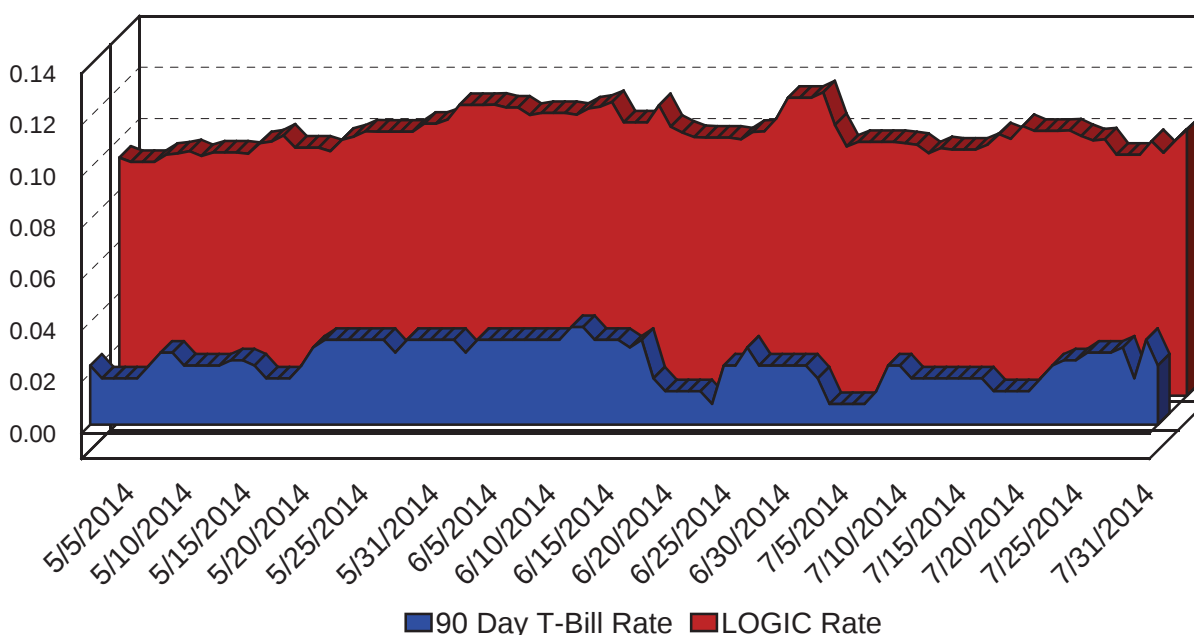
