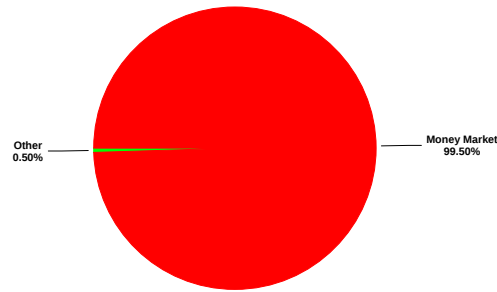

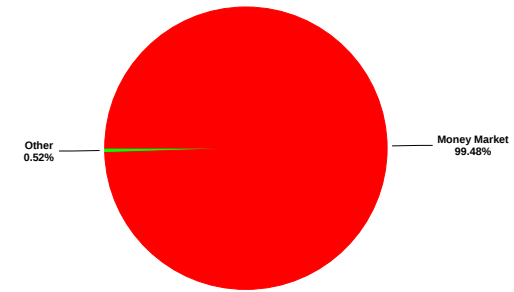

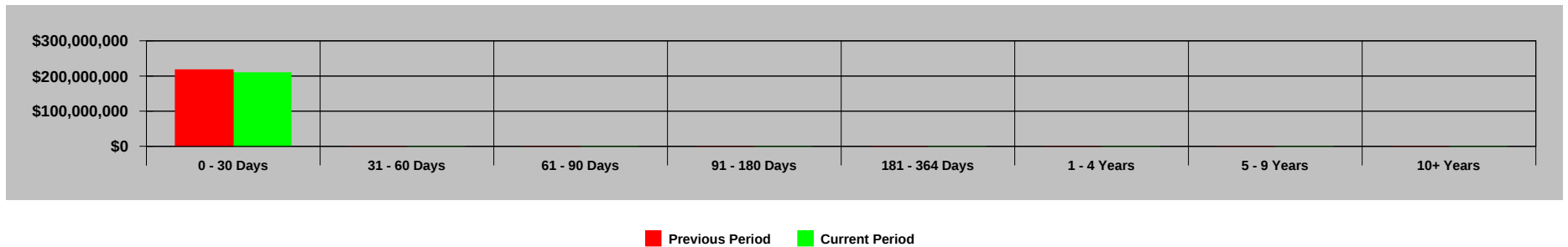
Portfolio Composition - 07/31/14



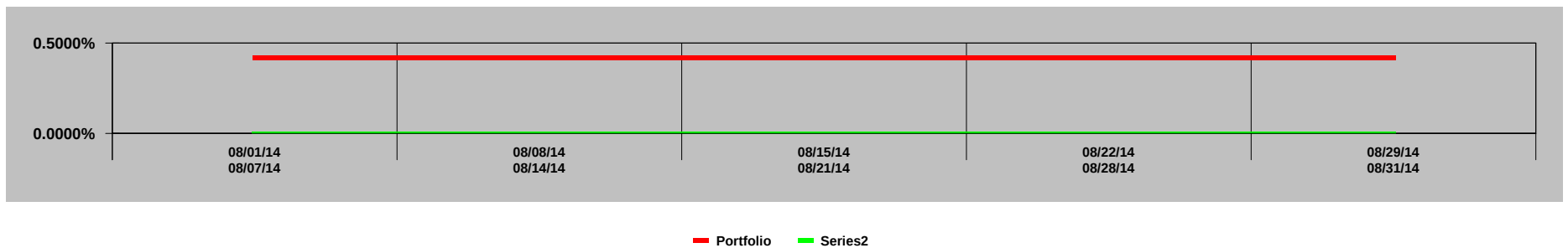
Portfolio Composition - 08/31/14

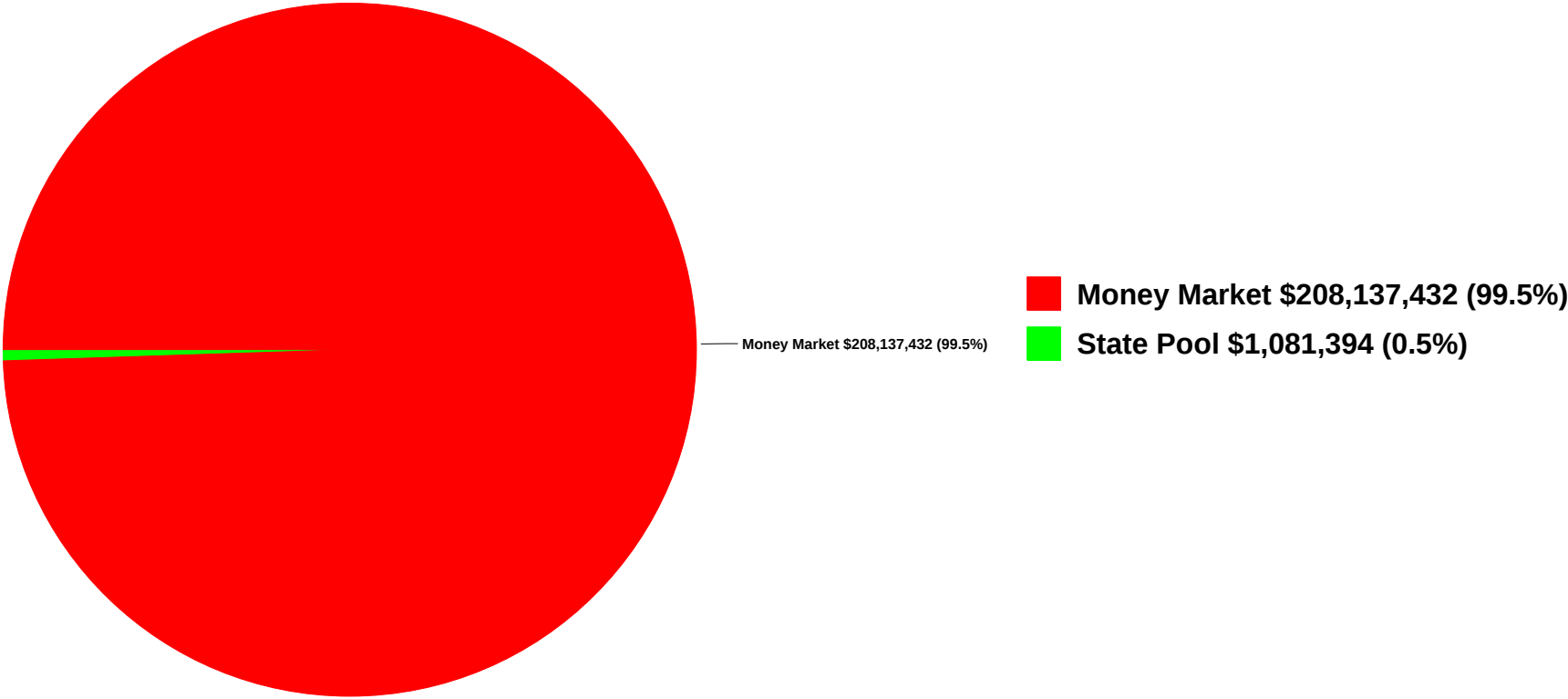

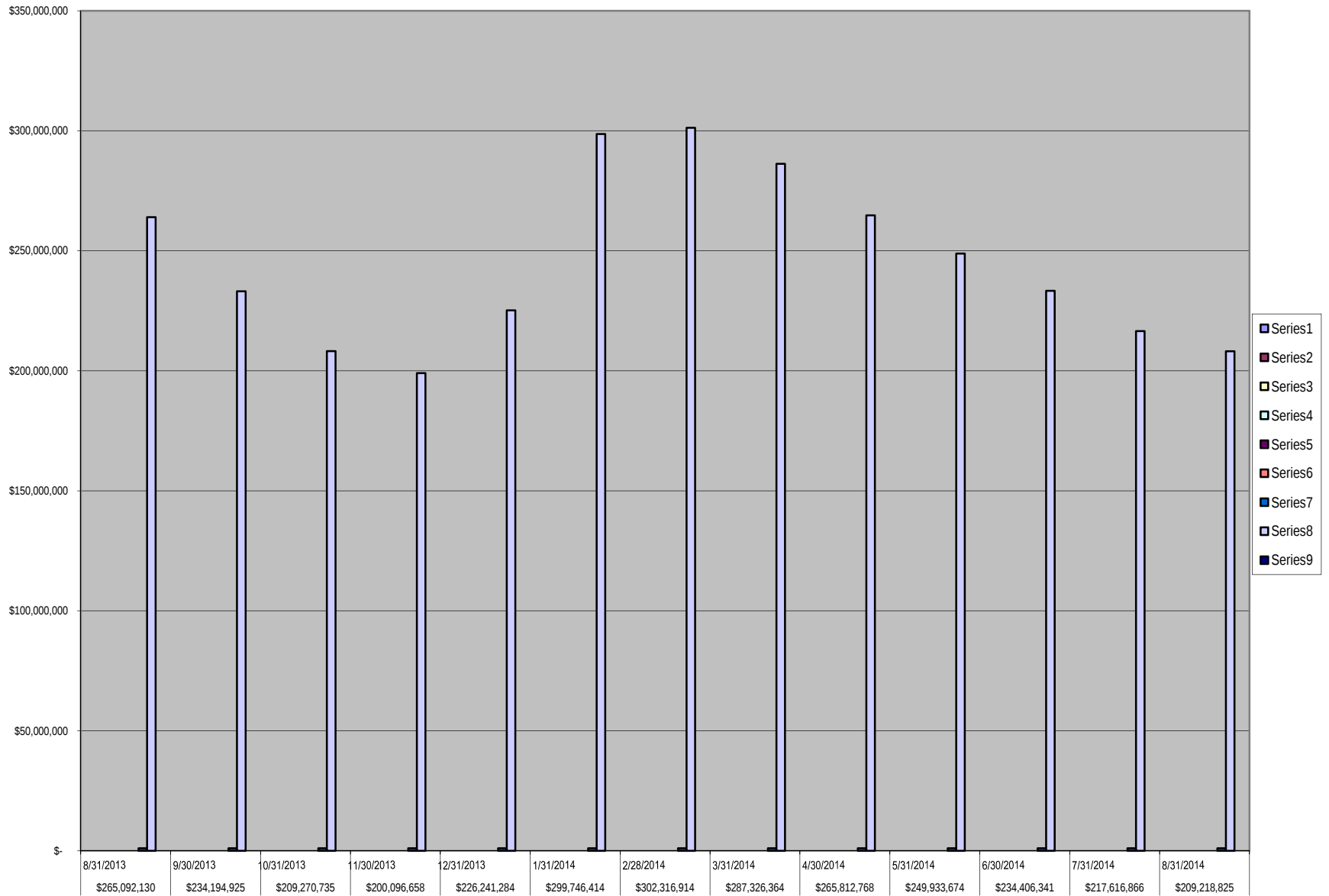

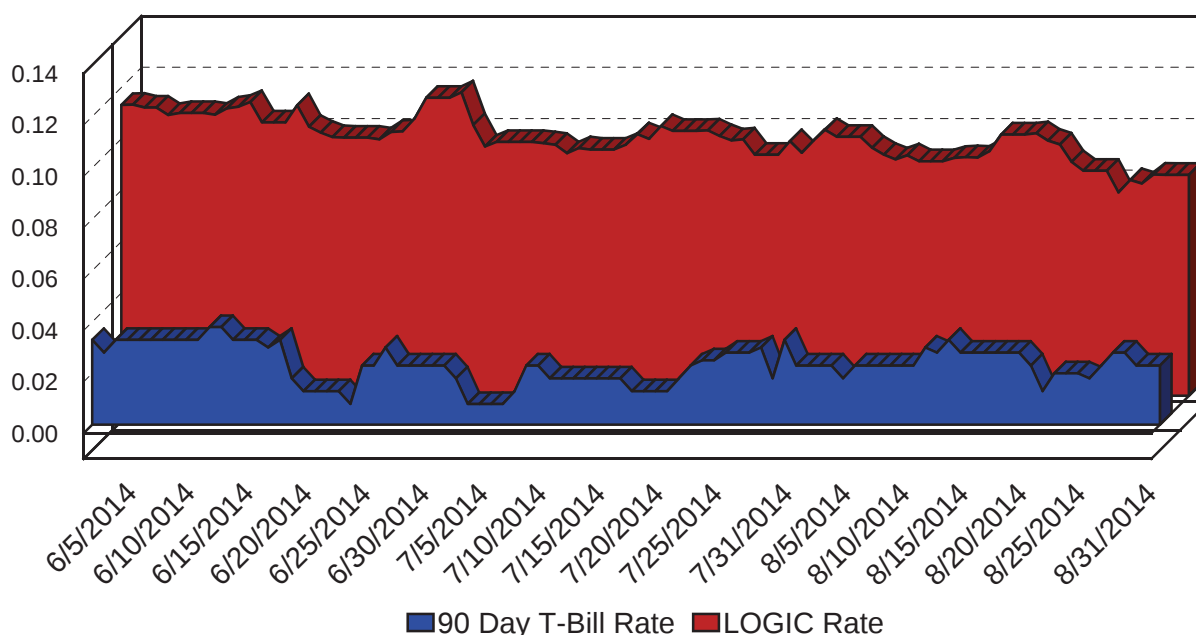
